**ORDER GRANTING PLAN ADMINISTRATOR'S TWENTY-
EIGHTH OMNIBUS OBJECTION TO CLAIMS (STIPULATED CLAIMS)**

Upon the Plan Administrator's Twenty-Eighth Omnibus Objection to Claims (Stipulated Claims) (the "Omnibus Objection")² [Docket No. 3919] of William Kaye as Plan Administrator, seeking entry of an order (the "Order") modifying/disallowing and expunging the Claims listed on Exhibit A hereto; it appearing that the relief requested in the Omnibus Objection is in the best interests of the Reorganized Debtors' estates, their creditors and other parties in interest; the Court having jurisdiction to consider the Omnibus Objection and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334; consideration of the Omnibus Objection and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); venue being proper before the Court pursuant to 28 U.S.C. §§ 1408 and 1409; proper notice of the Omnibus Objection having been provided to all necessary and appropriate parties in accordance with the Order Establishing

Omnibus Objection Procedures and Approving the Form and Manner of Notice of Omnibus Objections [Docket No. 2860] entered by the Court on September 19, 2008, and no further notice being necessary; and after due deliberation and sufficient cause appearing therefore, it is hereby ORDERED, ADJUDGED and DECREED that

1. The Omnibus Objection is granted in its entirety.
2. The shortened notice period is approved.
3. Claim number 2964, filed by Sarah Dickey in an unliquidated amount, is hereby allowed as a general unsecured claim in the amount of \$300,000.00.
4. Claim number 2703, filed by Toni Roseneau in the amount of \$150,000.00, is hereby disallowed and expunged as a general unsecured claim for all purposes.
5. Claim number 6467, filed by Special Data Processing Corporation d/b/a National Publishers Exchange in the amount of \$630,940.00, is hereby allowed as a general unsecured claim in the amount of \$530,940.00.
6. Nothing in the Notice or this Order shall be deemed or construed in any manner to constitute a finding, conclusion or judgment with regard to any administrative expense and/or cure claim amounts asserted against the Reorganized Debtors.
7. This Order is effective without further action of the Reorganized Debtors, the Plan Administrator or the Claimants.
8. The Reorganized Debtors and Plan Administrator are authorized to take all actions necessary to effectuate the relief granted pursuant to this Order in accordance with the Omnibus Objection.

9. The terms and conditions of this Order shall be immediately effective and enforceable upon its entry.

10. The Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Order.
