**PLEASE TAKE NOTICE** that on the date hereof, Simpson Thacher & Bartlett LLP (“*Simpson Thacher*”) filed the *Seventh Interim Fee Application of Simpson Thacher & Bartlett LLP for Compensation for Services and Reimbursement of Expenses as Counsel to the Debtors for the Period from February 1, 2023 Through and Including April 30, 2023* (the “**STB Interim Fee Application**”).

**PLEASE TAKE FURTHER NOTICE** that on the date hereof, LDCM Advogados (“*LDCM*”) filed the *Third Interim Fee Application of LDCM Advogados for Compensation for Services as Special Brazilian Counsel to the Debtors for the Period from February 1, 2023 Through and Including April 30, 2023* (the “**LDCM Interim Fee Application**”).

**PLEASE TAKE FURTHER NOTICE** that due to the COVID-19 pandemic and in accordance with the Court’s General Order M-543, dated March 20, 2020, the hearing will only be conducted via Zoom.<sup>1</sup> Parties should not appear in person and those wishing to participate in the hearing are required to register their appearance by **4:00 p.m. (prevailing Eastern Time) on June 22, 2023** at <https://ecf.nysb.uscourts.gov/cgi-bin/nysbAppearances.pl>.<sup>2</sup>

**PLEASE TAKE FURTHER NOTICE** that any responses or objections to the relief requested in the Interim Fee Applications shall: (a) be in writing; (b) conform to the Federal Rules of Bankruptcy Procedure, the Local Bankruptcy Rules for the Southern District of New York, all General Orders applicable to chapter 11 cases in the United States Bankruptcy Court for the Southern District of New York; (c) be filed electronically with the Court on the docket of *In re MatlinPatterson Global Opportunities Partners II L.P.*, Case 21-11255 (DSJ) by registered users of the Court’s electronic filing system and in accordance with the General Order M-399 (which is available on the Court’s website at <http://www.nysb.uscourts.gov>); and (d) be served so as to be actually received by **June 22, 2023 at 4:00 p.m. (prevailing Eastern Time)** (the “*Objection Deadline*”), by (i) the U.S. Trustee for the Southern District of New York, (ii) (x) with respect to

Objecting parties are required to attend the hearing and failure to appear may result in relief being granted upon default. In the event that no objection to the Interim Fee Applications is timely filed and served, the relief requested in the Interim Fee Applications may be granted without a hearing before the Court.

**PLEASE TAKE FURTHER NOTICE** that in accordance with the *Order Pursuant to Sections 105(a) and 331 of the Bankruptcy Code, Bankruptcy Rule 2016 and Local Rule 2016-1 Establishing Procedures for Monthly Compensation and Reimbursement of Expenses of Professionals* [Docket No. 105] (the “**Interim Compensation Order**”), if any Interim Fee Application is uncontested, the Court, in its discretion, may approve the Interim Fee Application without the need for a hearing. If no responses are timely filed and served, Simpson, Schulte and LDCM may, after the Objection Deadline, submit a proposed order to the Court granting the Interim Fee Applications, which may be entered with no further notice or opportunity to be heard.
