FINAL ORDER (A) AUTHORIZING USE OF CASH COLLATERAL PURSUANT TO SECTION 363(c) OF THE BANKRUPTCY CODE AND GRANTING ADEQUATE PROTECTION, AND (B) AUTHORIZING DEBTOR TO OBTAIN POSTPETITION FINANCING AND <u>GRANTING LIENS AND SUPERPRIORITY CLAIMS</u>

This matter came before the Court pursuant to the *Debtors' (A) Emergency Motion for Interim and Final Orders Authorizing the Use of Cash Collateral, Granting Adequate Protection to Prepetition Secured Parties, and Scheduling a Final Hearing Pursuant to Bankruptcy Rule 4001; and (B) Motion for Final Order Authorizing Secured Post-Petition Financing on a Priming and Super Priority Basis* (the "<u>Motion</u>") filed by the above-captioned debtors² on July 12, 2018, (a) for entry of an interim order (the "<u>Interim Order</u>") and a final order (the "<u>Final</u> <u>Order</u>") (i) authorizing the use of "cash collateral," as defined in Bankruptcy Code Section 363(a) (the "<u>Cash Collateral</u>"), of the Prepetition Agent (as defined below) and the Prepetition Secured Parties (as defined below); (ii) authorizing adequate protection to the Agent and the Prepetition Secured Parties for any aggregate diminution in value of their respective interests in the Cash Collateral and Prepetition Collateral (as defined below); (iii) modifying the automatic

stay imposed by Bankruptcy Code Section 362 to the extent necessary; and (iv) scheduling a hearing to consider the relief requested on a final basis (the "<u>Final Hearing</u>"); and (b) for entry of a final order (i) authorizing the Debtors to obtain secured post-petition financing on a priming and super priority basis (the "<u>DIP Financing</u>").

Upon due, proper, and sufficient notice of the Motion, the interim hearing on the Motion (the "Interim Hearing"), and the final hearing on the Motion (the "Final Hearing") having been given under the circumstances and the opportunity for objection having been provided; and the Interim Hearing having been held on July 13, 2018; and the Court having entered an interim order on July 13, 2018 [Docket No. 39] (the "Interim Order") granting the Debtors the authority to use Cash Collateral (defined below) on an interim basis; and the Court having held the Final Hearing on August 8, 2018; and it appearing that no other or further notice is necessary with respect to the Court's entry of this Order (the "Final Order"); and after considering all the pleadings filed with the Court; and upon the Declaration of Chad J. Shandler in Support of Chapter 11 Petitions and First Day Pleadings (the "First Day Declaration"), the evidence submitted, and the record made at the Interim Hearing and Final Hearing held on the Motion to approve this Final Order; and the Court having found and determined that the relief sought in the Motion is fair and reasonable and in the best interest of the Debtors, their estates and creditors, and is essential for the continued operation of the Debtors' business; all objections, if any, to the entry of this Final Order having been withdrawn, resolved, or overruled by the Court; and after due deliberation and consideration and good and sufficient cause appearing therefor,

THE COURT HEREBY MAKES THE FOLLOWING FINDING OF FACT AND CONCLUSIONS OF LAW:

A. <u>Petition Date</u>. On July 12, 2018 (the "<u>Petition Date</u>"), the Debtors filed voluntary petitions for relief under Chapter 11 of Title 11 of the United States Code (the "<u>Bankruptcy</u>

<u>Code</u>"), thereby commencing these Chapter 11 cases (the "<u>Bankruptcy Cases</u>"). On July 13, 2018, the Court entered an order approving the joint administration of the Bankruptcy Cases. The Debtors are continuing in the management and operation of their businesses and properties as debtors-in-possession pursuant to Section 1107 and 1108 of the Bankruptcy Code. On July 23, 2018 an official committee of unsecured creditors (the "<u>Creditors' Committee</u>" and, together with any other statutory committee, the "<u>Committees</u>" and each, a "<u>Committee</u>") was appointed in the Bankruptcy Cases.

B. <u>Jurisdiction and Venue</u>. This Court has jurisdiction over the Bankruptcy Cases and the Motion pursuant to 28 U.S.C. § 1334. The Motion is a core proceeding as defined in 28 U.S.C. § 157(b)(2). The Court may enter a final order consistent with Article III of the United States Constitution. Venue for the Bankruptcy Cases is proper in this district pursuant to 28 U.S.C. § 1408.

C. <u>Notice</u>. Notice of the Final Hearing and the relief requested in the Motion has been provided by the Debtors in accordance and compliance with Bankruptcy Rules 4001 and 9014, as well as the Bankruptcy Local Rules and the Complex Case Procedures, and is sufficient under the circumstances. Without limiting the foregoing, due notice was afforded, whether by facsimile, electronic mail, overnight courier, or hand delivery, to parties in interest, including: (i) the Office of the U.S. Trustee for the Southern District of Texas (the "<u>US Trustee</u>"); (ii) entities listed as holding the 50 largest unsecured claims against the Debtors (on a consolidated basis); (iii) the Agent (defined below) and its counsel; (iv) the Internal Revenue Service; (v) the Office of the United States Attorney for the Southern District of Texas; (vi) the state attorney general for the state of Texas; and (vii) any party that has requested notice pursuant to Bankruptcy Rule 2002.

D. <u>Pre-Petition Loan Documents</u>. KeyBank National Association, as Administrative Agent (the "<u>Agent</u>") for the parties identified as "Lenders" (collectively, the "<u>Lenders</u>") in the Credit Agreement (defined below), the Lenders, and Neighbors Global Holdings, LLC are parties to that certain Credit Agreement dated as of November 19, 2015, as amended by: (i) that certain Amendment No. 1 to Credit Agreement dated as of July 5, 2016; (ii) that certain Waiver, Consent, and Amendment No. 2 to Credit Agreement dated as of September 9, 2016; and (iii) that certain Waiver, Consent and Amendment No. 3 to Credit Agreement dated as of May 9, 2017 (collectively, the "<u>Credit Agreement</u>"), pursuant to which the Lenders made the following credit facility available to the Debtors (the "<u>Credit Facility</u>"): (i) a revolving credit facility in the original maximum principal amount of \$30,000,000; (ii) a term loan in the maximum principal amount of \$20,000,000.

E. In connection with the Credit Facility, the Debtors delivered to the Agent, among other things: (i) that certain Amended and Restated Pledge and Security Agreement dated as of May 9, 2017, which amended and restated that certain Pledge and Security Agreement dated as of November 19, 2015 (as amended and restated, the "<u>Pledge and Security Agreement</u>"), pursuant to which the Debtors granted the Agent (for the benefit of the Agent, for the benefit of the Secured Creditors (as defined in the Pledge and Security Agreement) a first-priority (subject only to Permitted Liens, as defined in the Credit Agreement) security interest and lien upon substantially all of the tangible and intangible personal property of the Debtors, whether then existing or thereafter from time to time arising or acquired and wherever located (all as more specifically described in the Pledge and Security Agreement and herein collectively called the "Personal Property"); (ii) that certain Assignment of Management Services Agreement dated

November 19, 2015 (the "Assignment Agreement"), pursuant to which Neighbors Health, LLC (f/k/a Neighbors Health Systems, LLC) collaterally assigned to the Agent, for the benefit of the Lenders, all of its rights and remedies with respect to the representations, warranties, covenants and indemnities of certain of the Debtors under the Management Services Agreements (as defined in the Assignment Agreement) and all of its other rights under the Management Services Agreements; (iii) that certain Collateral Assignment of Trademarks dated as of November 19, 2015 (the "2015 Trademark Assignment"), pursuant to which Neighbors Emergency Center, LLC assigned and granted to Agent, for the benefit of the Secured Creditors, a first-priority (subject only to Permitted Liens, as defined in the Credit Agreement) security interest in, a general lien upon and/or right of setoff against its intellectual property rights (as more specifically described in the 2015 Trademark Assignment); (iv) that certain Collateral Assignment of Trademarks dated as of September 16, 2016 (the "2016 Trademark Assignment"), pursuant to which Neighbors Emergency Center, LLC assigned and granted to Agent, for the benefit of the Secured Creditors, a first priority (subject only to Permitted Liens, as defined in the Credit Agreement) security interest in, a general lien upon and/or right of setoff against its intellectual property rights (as more specifically described in the 2016 Trademark Assignment); (v) that certain Deed of Trust, Assignment of Leases and Rents, Security Agreement and UCC Financing Statement for Fixture Filing dated effective as of November 19, 2015, by NEC Baytown Asset Holdings, LLC, as Grantor, to Martha Wach, as Trustee, for the benefit of the Agent, as Beneficiary (the "Baytown Mortgage"), pursuant to which NEC Baytown Asset Holdings, LLC: (a) granted a first-priority (subject only to Permitted Liens, as defined in the Credit Agreement) lien upon certain real property (as more specifically described in the Baytown Mortgage), and improvements constructed thereon and/or fixtures attached thereto, located in

Baytown, Texas (the "Baytown Facility"), (b) granted a first-priority (subject only to Permitted Liens, as defined in the Credit Agreement) security interest in all personal property situated on or attached to the Baytown Facility, and (c) assigned all leases of and/or rent collected on account of any lease of the Baytown Facility; (vi) that certain Deed of Trust, Assignment of Leases and Rents, Security Agreement and UCC Financing Statement for Fixture Filing dated effective as of November 19, 2015, by NEC Beaumont Asset Holdings, LLC, as Grantor, to Martha Wach, as Trustee, for the benefit of the Agent, as Beneficiary (the "Beaumont Mortgage"), pursuant to which NEC Beaumont Asset Holdings, LLC: (a) granted a first-priority (subject only to Permitted Liens, as defined in the Credit Agreement) lien upon certain real property (as more specifically described in the Beaumont Mortgage), and improvements constructed thereon and/or fixtures attached thereto, located in Beaumont, Texas (the "Beaumont Facility"), (b) granted a first-priority (subject only to Permitted Liens, as defined in the Credit Agreement) security interest in all personal property situated on or attached to the Beaumont Facility, and (c) assigned all leases of and/or rent collected on account of any lease of the Beaumont Facility; (vii) that certain Deed of Trust, Assignment of Leases and Rents, Security Agreement and UCC Financing Statement for Fixture Filing dated effective as of November 19, 2015, by NEC Kingwood Asset Holdings, LLC, as Grantor, to Martha Wach, as Trustee, for the benefit of the Agent, as Beneficiary (the "Kingwood Mortgage"), pursuant to which NEC Kingwood Asset Holdings, LLC: (a) granted a first-priority (subject only to Permitted Liens, as defined in the Credit Agreement) lien upon certain real property (as more specifically described in the Kingwood Mortgage), and improvements constructed thereon and/or fixtures attached thereto, located in Kingwood, Texas (the "Kingwood Facility"), (b) granted a first-priority (subject only to Permitted Liens, as defined in the Credit Agreement) security interest in all personal property

situated on or attached to the Kingwood Facility, and (c) assigned all leases of and/or rent collected on account of any lease of the Kingwood Facility; and (viii) that certain Deed of Trust, Assignment of Leases and Rents, Security Agreement and UCC Financing Statement for Fixture Filing dated effective as of November 19, 2015, by NEC Pearland Asset Holdings, LLC, as Grantor, to Martha Wach, as Trustee, for the benefit of the Agent, as Beneficiary (the "<u>Pearland Mortgage</u>," and collectively with the Baytown Mortgage, the Beaumont Mortgage and the Kingwood Mortgage, the "<u>Mortgages</u>"), pursuant to which NEC Pearland Asset Holdings, LLC: (a) granted a first-priority (subject only to Permitted Liens, as defined in the Credit Agreement) lien upon certain real property (as more specifically described in the Pearland Mortgage), and improvements constructed thereon and/or fixtures attached thereto, located in Pearland, Texas (the "<u>Pearland Facility</u>"), (b) granted a first-priority (subject only to Permitted Liens, as defined in the Credit Agreement) security interest in all personal property situated on or attached to the Pearland Facility, and (c) assigned all leases of and/or rent collected on account of any lease of the Pearland Facility.

F. In connection with the Credit Facility, the Agent, among other things, filed the items described on Schedule 1.

and restated, the "<u>Guaranty</u>"), by the Guarantors with the Agent, for the benefit of the Creditors (as defined in the Guaranty), pursuant to which the Guarantors, among other things, guaranteed the prompt payment and performance of all indebtedness and liabilities owing by Neighbors Global Holdings, LLC to the Agent and the Lenders under the Credit Agreement.

H. The prepetition loan documents described in paragraphs D-G hereof, as amended, supplemented, or otherwise modified prior to the Petition Date, together with all collateral and ancillary documents executed in connection therewith are collectively referred to herein as the "<u>Prepetition Loan Documents</u>," and the principal, interest, costs, expenses, fees, and other amounts owing under the Prepetition Loan Documents are collectively referred to herein as the "<u>Prepetition Indebtedness</u>."

I. <u>Debtors' Stipulations</u>. Without prejudice to the rights of the Committee and any other party and subject to the Challenge Period set forth in paragraph 29, the Debtors stipulate that they are liable to the Agent and the Lenders, for the Prepetition Indebtedness (computed as of the Petition Date) in the aggregate amount of at least \$110,195,053.48, broken down as follows:

1. With respect to the Term Loan, the aggregate amount of at least \$91,481,592.47, comprised of: (i) \$90,625,000 of unpaid principal; and (ii) \$856,592.47 of accrued and unpaid interest; plus (iii) certain other recoverable fees (including attorneys' fees) and costs owing under the Term Loan and related Prepetition Loan Documents.

2. With respect to the Delayed Draw Loan, the aggregate amount of at least \$18,713,461.01, comprised of: (i) \$18,500,000 of unpaid principal; and (ii) \$174,863.01 of accrued and unpaid interest; and (iii) \$38,625 in unused line-of-credit fees; plus (iv)

certain other recoverable fees (including attorneys' fees) and costs owing under the Term Loan and related Prepetition Loan Documents.

Additionally, the Agent and the Lenders assert that interest, fees, costs, expenses and attorney's fees continue to accrue on the Pre-Petition Indebtedness (collectively with the Pre-Petition Indebtedness, the "<u>Secured Claim</u>"). The Debtors stipulate that the Secured Claim constitutes an allowable, legal, valid, binding, and enforceable obligation of the Debtors.

J. Without prejudice to the rights of the Committee and any other party and subject to the Challenge Period set forth in paragraph 29, the Debtors further stipulate that, as security for repayment of the Secured Claim, the Agent, for the benefit of the Secured Creditors, holds valid, binding, enforceable, and properly perfected first-priority (subject only to Permitted Liens, as defined in the Credit Agreement) liens and security interests (the "<u>Pre-Petition Liens</u>") in: (i) substantially all of the Debtors' tangible and intangible Personal Property as described in the Prepetition Loan Documents; (ii) the Real Property as described in the Mortgages; and (iii) the Collateral Records, Pledged Equity Interests, and the proceeds therefrom described in the Pledge and Security Agreement, whether now owned or hereinafter acquired or arising, and together with all proceeds and products thereof (collectively, the "<u>Collateral</u>").

K. Without prejudice to the rights of the Committee and any other party and subject to the Challenge Period set forth in paragraph 29, the Debtors further stipulate that: (i) the Secured Claim and any other amounts owing to the Secured Creditors pursuant to the Prepetition Loan Documents are due and owing, are legally binding and enforceable obligations of the Debtors, and are not subject to any offset, defense, claims, counterclaims of any kind; (ii) the Prepetition Loan Documents are valid and enforceable against the Debtors in accordance with their terms, are not subject to any offset, defense, claim, counterclaim of any kind or nature

whatsoever, and are not subject to avoidance pursuant to applicable state or federal laws; (iii) the liens and security interests of the Agent for the benefit of the Secured Creditors in, to, and against all of the Collateral are first-priority (subject only to the Permitted Liens (as defined in the Credit Agreement)) valid, binding, enforceable and properly perfected liens and security interests, and are not subject to avoidance under any state and federal law; and (iv) there are no existing claims or causes of action of the Debtors, breaches of contract or other liabilities, whether liquidated or unliquidated, direct or indirect, and whether arising under state or federal law (including the Bankruptcy Code) against the Agent or the Secured Creditors, arising from the relationships between the Debtors, on one hand, and the Agent and the Secured Creditors, on the other hand.

L. Without prejudice to the rights of the Committee and any other party and subject to the Challenge Period set forth in paragraph 29, the Debtors further stipulate that the Collateral includes cash proceeds and other cash equivalents, and all cash and cash equivalent proceeds of the Prepetition Collateral, constituting cash collateral of the Debtors within the meaning of Section 363(a) of the Bankruptcy Code ("<u>Cash Collateral</u>").

M. <u>Debtors' Need to Use Cash Collateral</u>. The Debtors do not have sufficient available sources of working capital and financing to operate their business without the use of Cash Collateral. The ability of the Debtors to pay employees and otherwise finance their operations is essential for the Debtors to continue operations and to administer and preserve the value of their bankruptcy estates until the closing of the last of one or more sales collectively involving substantially all of the Debtors' assets (the "<u>Closing</u>"). The Debtors' critical need for use of Cash Collateral is immediate. Without the use of Cash Collateral, the continued operation

of the Debtors' business would not be possible, and serious and irreparable harm to the Debtors and their estates would result.

N. <u>Agent's Consent to the Use of Cash Collateral</u>. The Debtors have requested that the Agent consent to the use of Cash Collateral on a final basis. The Debtors undertook arm'slength negotiations with the Agent with respect to the use of Cash Collateral on a final basis, which are memorialized by the terms of this Final Order. The Agent, on behalf of the Secured Creditors, is willing to allow the Debtors to use Cash Collateral on a final basis pursuant to the terms and conditions set forth in this Final Order. The terms and conditions of the proposed use of Cash Collateral pursuant to this Final Order are fair and reasonable, were negotiated by the parties in good faith at arm's length, and the parties otherwise acted in good faith. Neither the Agent nor the Secured Creditors have agreed to any further or other use of Cash Collateral for any other purpose except as set forth in this Final Order.

O. <u>Need for Post-Petition Financing</u>. The Debtors have a fiduciary duty to protect and maximize the value of their estates for the benefit of creditors. To that end, the Debtors have an immediate need to obtain financing in order to continue operations and to administer and preserve the value of their bankruptcy estates until the Closing. The Debtors lack sufficient liquidity to finance their operations, preserve and maintain the value of their assets, and maximize the return for all creditors through the Closing without access to the DIP Proceeds (defined below). As a result, the Debtors, their bankruptcy estates and their creditors would suffer serious and irreparable harm if the Debtors cannot access the DIP Proceeds.

P. <u>The DIP Facility</u>. The terms upon which KeyBank National Association, as postpetition Administrative Agent (in such capacity, the "<u>DIP Agent</u>") for itself and certain parties identified as "Lenders" (collectively, the "<u>DIP Lenders</u>") in the DIP Financing Documents

(defined below), are willing to: (i) provide debtor-in-possession financing to the Debtors; and (ii) advance the DIP Proceeds (defined below) to the Debtors on the terms set forth in the credit agreement attached hereto as Exhibit A (the "DIP Credit Agreement").³ The debtor-inpossession financing transaction described in the DIP Credit Agreement shall hereinafter be referred to as the "DIP Facility." The DIP Facility and the documents and instruments governing the DIP Facility shall hereinafter be referred to as the "DIP Financing Documents." As set forth in more detail in the DIP Financing Documents, the DIP Facility shall be in the form of a postpetition senior secured loan facility with a commitment in an aggregate principal amount of up to \$24,000,000 (the "Commitment"), comprised of: (i) an amount up to \$8,000,000 of new money revolving loan funding (the "DIP Revolving Loan"); and (ii) a roll-up of \$16,000,0000 of the Secured Claim (the "DIP Roll-Up"). The Commitment will be made in two tranches: (i) the DIP Roll-Up; and (ii) the DIP Revolving Loan, subject to the Agent's receipt of a Funding Request (as defined in the DIP Financing Documents). The DIP Facility obligations shall include the following fees: (i) a \$300,000 Commitment Fee; (ii) a \$100,000 Agent Fee; and (iii) an Unused Fee of 1.5% on the DIP Revolving Loan (the "DIP Fees"). The fees described in clauses (i) and (ii) shall be payable upon entry of this Order. The fees described in clause (iii) shall be paid in arrears (on a monthly basis) based upon the average unused portion of the DIP Revolving Loan.

Q. <u>Secured Creditors' Consent to DIP Facility / Priming Liens</u>. The Pre-Petition Lenders holding 100% of the aggregate principal balance of the Secured Claim, and that are entitled to vote under the Prepetition Loan Documents, have expressly consented to the entry of this Final Order, the relief requested herein, the execution of the DIP Financing Documents, and the DIP Liens (defined below), including the priming liens, and DIP Super-Priority Claim

granted to the DIP Agent and the DIP Lenders under the terms of the DIP Financing Documents. Such consent is binding on all of the Secured Creditors. None of the Secured Creditors has filed an objection to the entry of this Final Order or the relief provided herein. Notwithstanding anything to the contrary herein, the Secured Creditors' consent to the DIP Facility and to the priming of the Prepetition Liens, except for the Permitted Liens, by the DIP Liens is expressly limited to the present DIP Facility and the DIP Liens securing same, and shall not be applicable to any other debtor-in-possession credit facility, even if it contains substantially the same economic terms as this DIP Facility.

R. No Credit Available on More Favorable Terms. Given the Debtors' financial condition, financing arrangements, and capital structure, the Debtors do not have sufficient unencumbered cash to fund their businesses through the Closing, and are otherwise unable to obtain adequate unsecured credit allowable under Section 503(b)(1) of the Bankruptcy Code as an administrative expense. Financing on a post-petition basis is not otherwise available without the Debtors' granting, pursuant to Section 364(c)(1) of the Bankruptcy Code, claims having priority over any and all administrative expenses of the kinds specified in Sections 503(b) and 507(b) of the Bankruptcy Code, and securing such indebtedness and obligations with the security interests in and the liens upon the DIP Collateral (defined below) pursuant to Section 364(c)(2), (c)(3) and (d) of the Bankruptcy Code. The Debtors are unable to obtain the necessary postpetition financing that they need on terms more favorable in the aggregate than those provided by the DIP Facility and DIP Financing Documents. The Debtors, with the assistance of their financial and other advisors, after conducting marketing efforts and carefully reviewing the various alternatives, determined that the DIP Facility is the best available option for, among other things, the following reasons: (i) the DIP Facility offered better terms when compared to

the terms of the considered alternatives; (ii) the DIP Facility had the highest certainty of closing given that, among other things, the Debtors are already indebted to the DIP Agent and certain of the DIP Lenders, which incentivized the DIP Agent and the DIP Lenders to provide financing to, among other things, protect their economic interests; and (iii) the DIP Agent and the DIP Lenders have a substantial base of knowledge with respect to the Debtors' business, their capital structure, the Collateral, and DIP Collateral, which knowledge ultimately saved the Debtors' estates diligence-related time and expenses.

S. Need to Grant Superpriority Claims and Priming Liens. The Debtors are unable to obtain adequate unsecured credit financing allowable under Section 503(b)(1) of the Bankruptcy Code and must grant to the DIP Agent and the DIP Lenders a superpriority administrative expense claim pursuant to Section 364(c)(1) of the Bankruptcy Code, and liens as contemplated by Section 364(c)(2), (c)(3) and (d) of the Bankruptcy Code. The DIP Agent and the DIP Lenders have conditioned all loans and advances to be made under the DIP Facility upon the grant to the DIP Agent and the DIP Lenders (subject only to the Carve-Out): (i) a superpriority administrative expense claim pursuant to Section 364(c)(1) of the Bankruptcy Code with priority over any and all expenses of any kind or nature whatsoever specified in Sections 503(b) and 507(b) of the Bankruptcy Code; and (ii) in accordance with Sections 364(c)(2), (c)(3) and (d) of the Bankruptcy Code, liens on and security interests in all of the DIP Collateral (defined below).

T. <u>Business Judgment and Good Faith Pursuant to Section 364(e)</u>. The terms and conditions of the DIP Facility, as set forth in the DIP Financing Documents, and the DIP Fees paid and to be paid thereunder: (i) are fair, reasonable, and the best available under the circumstances; (ii) reflect the Debtors' exercise of prudent business judgment consistent with

their fiduciary duties; and (iii) are supported by reasonably equivalent value and consideration. The DIP Facility was negotiated in good faith and at arm's length between the Debtors and the DIP Agent. The DIP Agent and the DIP Lenders have indicated their willingness to provide financing to the Debtors pursuant to the DIP Financing Documents. The funds to be extended under the DIP Facility will be extended by the DIP Agent and the DIP Lenders in good faith, and for valid business purposes and uses by the Debtors; as a consequence, the DIP Agent and the DIP Lenders are entitled to the protections and benefits afforded by Section 364(e) of the Bankruptcy Code. Accordingly, the DIP Superpriority Claim (defined below), the DIP Liens (defined below), and the other protections granted pursuant to this Final Order, the DIP Financing Documents and the DIP Facility will not be affected by any subsequent reversal, modification, vacatur or amendment of this Final Order, as provided in Section 364(e) of the Bankruptcy Code.

U. <u>Cause Exists to Grant the Motion; Relief Essential; Best Interests.</u> The relief requested in the Motion is necessary, essential, and appropriate to continue operations and to administer and preserve the value of their bankruptcy estates until the Closing. It is in the best interests of the Debtors' bankruptcy estates that the Debtors be allowed to obtain credit pursuant to the DIP Facility and the DIP Financing Documents. Additionally, based on the record before this Court, there is good cause for the Court to authorize the Debtors' use of Cash Collateral, on a final basis, under the terms and conditions stated herein (and not otherwise).

V. <u>Findings of Fact and Conclusions of Law</u>. Each of the foregoing findings by the Court will be deemed a finding of fact if, and to the extent, that it contains factual findings and a conclusion of law if, and to the full extent, that it makes legal conclusions.

Based upon the foregoing findings and conclusions, and good and sufficient cause appearing therefor,

IT IS HEREBY ORDERED as follows:

1. The paragraphs contained in the foregoing findings and conclusions of this Final Order are incorporated herein by reference, and the Debtors, the Agent, the Secured Creditors, the DIP Agent, and the DIP Lenders consent and stipulate to the facts and findings contained in such preamble and to the entry of this Final Order.

<u>Motion Granted</u>. The Motion is **GRANTED** on a final basis as provided in this
 Final Order. All objections to the Motion are hereby overruled.

3. <u>Approval of Entry into the DIP Financing Documents.</u> The Debtors are expressly and immediately authorized, empowered and directed to execute and deliver the DIP Financing Documents to the DIP Agent and the DIP Lenders, and to incur and perform all duties and obligations set forth therein. The Debtors are further expressly and immediately authorized, empowered and directed to execute and deliver all instruments, certificates, agreements and documents which may be required or necessary for the Debtors to comply with the DIP Facility and DIP Financing Documents; as well as to create and perfect the liens and security interests granted pursuant to the DIP Financing Documents as described in and provided for by this Final Order and the DIP Financing Documents. The Debtors are hereby authorized and directed to do and perform all acts, satisfy all obligations, and to pay all principal, interest, fees, including, without limitation, the DIP Fees, expenses and other amounts described in the DIP Financing Documents as such become due (collectively with all other obligations under and as defined in the DIP Financing Documents, the "<u>DIP Obligations</u>"), which amounts shall not otherwise be subject to further approval of this Court. Upon execution and delivery, the DIP Financing

Documents shall represent valid and binding obligations of the Debtors in accordance with their terms enforceable against the Debtors and the bankruptcy estates.

4. <u>Approval of DIP Roll-Up</u>. The DIP Roll-Up is hereby approved, and the Debtors are expressly and immediately authorized, empowered, and directed to the use the DIP Roll-Up to satisfy \$16,000,000 of the Secured Claim. Each DIP Lender's ratable share of the \$16,000,000 DIP Roll-Up shall be entitled to all the priorities, privileges, rights, and other benefits afforded to the other DIP Obligations under this Final Order and the DIP Loan Documents. The DIP Roll-Up will be required to be repaid in cash on the Maturity Date.

5. <u>Maturity</u>. The DIP Facility will mature on the date set forth in the DIP Financing Documents (the "<u>Maturity Date</u>"). All obligations and liabilities of the Debtors and their bankruptcy estates to the DIP Agent and the DIP Lenders that remain outstanding or are in existence on the Maturity Date shall be due and payable on the Maturity Date.

6. <u>Good Faith Under Section 364(e)</u>; No Modification or Stay of this Final Order. The DIP Agent and the DIP Lenders are extending credit pursuant to the DIP Facility, the DIP Financing Documents and this Final Order in "good-faith" within the meaning of Section 364(e) of the Bankruptcy Code, and the credit extended by the DIP Agent and the DIP Lenders pursuant to this Final Order, and in connection with the DIP Facility and the DIP Financing Documents shall be deemed to be extended in good faith within the meaning of Section 364(e) of the Bankruptcy Code and the DIP Agent and the DIP Lenders are entitled to the protections afforded by Section 364(e) of the Bankruptcy Code and no such appeal, modification, amendment or vacation shall affect the validity and enforceability of any advances made hereunder or the liens, rights, claims, or priority authorized or created hereby. Notwithstanding any such potential modification, amendment or vacation, any liens, rights, claims or priorities granted to the DIP

Agent and the DIP Lenders hereunder arising prior to the effective date of such modification, amendment or vacation of any DIP Liens and DIP Superpriority Claims granted to the DIP Agent and DIP Lenders shall be governed in all respects by the provisions of this Final Order, and the DIP Agent and the DIP Lenders shall be entitled to all of the rights, liens, priorities remedies, privileges and benefits, including the DIP Liens and DIP Superpriority Claims granted herein, with respect to any outstanding portion of the DIP Obligations. Since the loans made pursuant to the DIP Facility and the DIP Financing Documents are made in reliance on this Final Order, any unpaid portion of the DIP Obligations prior to the effective date of any stay, modification or vacation of this Final Order shall not, as a result of any subsequent order in any of the Bankruptcy Cases, or in any successor cases, be subordinated, lose its lien priority or superpriority administrative expense claim status, or be deprived of the benefit of the status of the liens and claims granted to the Agent and Secured Creditors under this Final Order and/or the DIP Financing Documents.

7. <u>Authorization to Use Cash Collateral and DIP Proceeds</u>. Pursuant to Sections 363(c), 364(c) and 364(d) of the Bankruptcy Code, the Debtors shall be, and hereby are authorized to use Cash Collateral and all funds advanced by the DIP Agent and the DIP Lenders pursuant to the DIP Revolving Loan (the "<u>DIP Proceeds</u>"), on a final basis, upon (and only upon) the terms and conditions set forth in this Final Order, the Pre-Petition Loan Documents, the DIP Financing Documents, and the Budget (defined below).

8. <u>Budget Compliance</u>. The Debtors' use of Cash Collateral and the DIP Proceeds is limited to the payment of the authorized expenses pursuant to the budget attached hereto as <u>Exhibit</u> "1" (the "<u>Budget</u>"), and for no other purpose without the prior written consent of the Agent and the DIP Agent. The Debtors are hereby authorized to use the Cash Collateral and the

DIP Proceeds to pay only the amounts as set forth in the Budget, subject to the Permitted Disbursement Variance (defined below); provided, however, that in no event will the Debtors prepay any expenses, including (without limitation) vendor expenses, from Cash Collateral or the DIP Proceeds unless the Debtors have given the Agent and the DIP Agent three business days' notice of the Debtors' intent to prepay any expense and the Debtors receive no objection; provided further that the Debtors may prepay any expense that is less than \$50,000. The Debtors' compliance with the Budget will be tested every other week on a cumulative basis (except for clause (iii), as described below). The Debtors must comply with the Budget such that as of the end of every other week (beginning with the week ending July 27, 2018): (i) the aggregate amount of all disbursements (exclusive of debt service, adequate protection, professional fees, U.S. Trustee's fees and capital expenditures) actually paid by the Debtors from the Petition Date through the end of such reporting period is not more than 105% (the "Permitted Disbursement Variance") of the aggregate, cumulative disbursements (exclusive of debt service, adequate protection, professional fees, U.S. Trustee's fees and capital expenditures) set forth in the Budget for such period; (ii) the aggregate amount of all cash receipts received by the Debtors from the Petition Date through the end of such reporting period is not less than 90% (the "Permitted Receipts Variance") of the total cash receipts projected in the Budget for such period; (iii) the actual cash balance (after adding back any debt service, professional fees, adequate protection, U.S. Trustee fees and capital expenditures) on the Friday preceding the delivery of the Budget Variance Report is not more than \$1,100,000 less than the projected cash balance (after adding back any debt service, professional fees, adequate protection, U.S. Trustee fees and capital expenditures) on the Friday preceding the delivery of the Budget Variance Report; and (iv) the aggregate amount of capital expenditures for the two-week reporting period then ended

does not exceed the amount of capital expenditures set forth in the Budget for such period, unless the Debtors have obtained prior written approval from the Agent and the DIP Agent. The Budget may be amended from time to time without further order of this Court upon the prior written agreement of the Debtors, the Agent, and the DIP Agent, in consultation with the Committee, and such amended budget shall become the Budget under this Final Order. Upon the sale of any Debtor's business or principal operations, the Debtors shall, in consultation with the Committee, provide the Agent and the DIP Agent with a revised Budget to be reasonably acceptable to the Agent and the DIP Agent covering the subsequent thirteen-week period.

9. Limitations on the Use of Cash Collateral and the DIP Proceeds. No Cash Collateral or DIP Proceeds may be used by the Debtors to: (i) object to or contest in any manner, or raise any defenses to the validity, perfection, priority or enforceability of the Secured Claim or the DIP Obligations, or the liens in favor of the Agent, DIP Agent, the Secured Creditors, or the DIP Lenders securing the Secured Claim or the DIP Obligations, including, without limitation, the Replacement Liens (defined below) and the DIP Liens (defined below); (ii) object to or contest in any manner, or raise any alleged defenses to the validity, perfection, priority or enforceability of the Secured Claim owing to the Agent and the Secured Creditors, or the liens in favor of the Agent and Secured Creditors securing the Secured Claim; (iii) object to or contest in any manner, or raise any alleged defenses to the validity, perfection, priority or enforceability of the DIP Obligations owing to the DIP Agent and the DIP Lenders, or the liens in favor of the DIP Agent and DIP Lenders securing the DIP Obligations; (iv) assert any claims or causes of action against the Agent, DIP Agent, the Secured Creditors, or the DIP Lenders of any type, including, without limitation, any avoidance actions under Chapter 5 of the Bankruptcy Code, or any claim or cause of action related to the Prepetition Loan Documents, the DIP Financing

Documents, or otherwise; or (v) prepare or prosecute any adversary proceeding in which any of the Agent, the DIP Agent, the Secured Creditors, or the DIP Lenders are named as a defendant.

10. Carve-Out. For purposes of this Final Order, "Carve-Out" means: (i) all unpaid fees required to be paid in these Bankruptcy Cases to the clerk of the Bankruptcy Court and to the office of the U.S. Trustee under 28 U.S.C. § 1930(a)(6) (as determined by final order of the Court or by agreement with the U.S. Trustee); (ii) all reasonable fees and expenses incurred by a trustee appointed under section 701 of the Bankruptcy Code in an amount not to exceed \$25,000; (iii) subject to the terms and conditions of this Final Order, the reasonable unpaid fees, costs, and disbursements of professionals retained by the Debtors in these Bankruptcy Cases (the "Debtors' Professionals") that are: (a) incurred prior to the delivery by the Agent or the DIP Agent of a Carve-Out Trigger Notice (as defined below), (b) provided for in the Budget, (c) allowed by the Court under Sections 327, 328, 330, or 1103 of the Bankruptcy Code, and (d) that remain unpaid after application of any retainers being held by such professionals; (iv) subject to the terms and conditions of this Final Order, the reasonable unpaid fees, costs, and disbursements of professionals retained by the Committees in these Bankruptcy Cases (collectively, the "Committees' Professionals") and all reasonable unpaid out-of-pocket expenses of the members of any Committee ("Committee Members"), in each case that are: (a) incurred prior to the delivery by the Agent and/or the DIP Agent of a Carve-Out Trigger Notice, (b) provided for in the Budget, and (c) allowed by the Court under Sections 327, 328, 330, or 1103 of the Bankruptcy Code; (v) the reasonable unpaid fees, costs, and disbursements of the Debtors' Professionals that are: (a) incurred after the delivery of a Carve-Out Trigger Notice by the Agent or the DIP Agent (by way of clarification, fees incurred by the Debtors' Professionals but not invoiced and/or paid by the Debtors prior to the delivery of a Carve-Out Trigger Notice are not

subject to the Post-Default Carve-Out Cap defined below, but instead, are subject to the Carve-Out provisions set forth in Section (iii) above), and (b) allowed by the Court under Sections 327, 328, 330 or 363 of the Bankruptcy Code after application of any retainers being held by such professionals, in an aggregate amount not to exceed \$275,000 (the "Debtors' Professionals Carve-Out Cap"), which includes \$15,000 for any Patient Care Ombudsman appointed, and as that term is defined, under 11 U.S.C. § 333); and (vi) the reasonable unpaid fees, costs, and disbursements of the Committees' Professionals and the reasonable unpaid expenses of Committee Members that are: (a) incurred after the delivery of a Carve-Out Trigger Notice by the Agent or DIP Agent (by way of clarification, fees of the Committees' Professionals and reasonable unpaid expenses of Committee Members that are incurred but not invoiced and/or paid by the Debtors prior to the delivery of a Carve-Out Trigger Notice are not subject to the Post-Default Carve-Out Cap defined below, but instead, are subject to the Carve-Out provisions set forth in Section (iv) above), and (b) allowed by this Court under sections 327, 328, 330 or 1103 of the Bankruptcy Code, in an aggregate amount (for both Committee Members and the Committees' Professionals) not to exceed \$75,000 (the "Committee Carve-Out Cap" and, together with the Debtors' Professionals Carve-Out Cap, the "Post-Default Carve-Out Cap"). The term "Carve-Out Trigger Notice" shall mean a written notice delivered by the Agent or the DIP Agent to Debtors' counsel, the U.S. Trustee, and counsel for the Committees appointed in these Bankruptcy Cases, which notice may be delivered at any time following the occurrence and during the continuation of any Termination Date (as defined below), and expressly stating that the Post-Default Carve-Out Cap is triggered. The DIP Agent shall be entitled to establish and maintain reserves against borrowing availability under the DIP Revolving Loan on account of the Carve-Out (including, for avoidance of doubt, the DIP Agent's estimate of future fees and

expenses of the Debtors' Professionals, the Committees' Professionals and the Committee Members that may be incurred before or after the delivery of Carve-Out Trigger Notice) in accordance with the terms of the DIP Financing Documents. No amounts set forth in this subparagraph 10(i) with respect to the Post-Default Carve-Out Cap may be modified without the prior written consent of the Agent and the DIP Agent.

11. No Direct Obligation to Pay Professional Fees; No Waiver of Right to Object to Fees. Regardless of any reserve established by the DIP Agent, neither the Agent, the DIP Agent, the Secured Creditors, nor the DIP Lenders shall be responsible for the direct payment or reimbursement of any fees or disbursements of any of the Debtors' Professionals, Committees' Professionals or Committee Members incurred in connection with the Bankruptcy Cases. Nothing in this Final Order, or otherwise, shall be construed: (i) to obligate the Agent, the DIP Agent, the Secured Creditors, or the DIP Lenders to pay compensation to, or to reimburse expenses of, any of the Debtors' Professionals, the Committees' Professionals or Committee Members, or to guarantee that the Debtors or their estates have sufficient funds to pay such compensation or reimbursement; or (ii) to increase the Carve-Out if actual allowed fees and expenses of any of the Debtors' Professionals, Committees' Professionals or Committee Members are higher in fact than the amounts in the Budget or the Carve-Out Cap. Notwithstanding the forgoing, no portion of the Carve-Out, Cash Collateral, Prepetition First Lien Collateral, Prepetition Second Lien Collateral, DIP Collateral or proceeds of the DIP Facility shall be utilized for the payment of professional fees and disbursements to the extent restricted under Paragraphs 8 and 9 hereof. Nothing herein shall be construed as consent to the allowance of any professional fees or expenses of any of the Debtors, any Committee, any other official or unofficial committee in these Bankruptcy Cases, or of any other person or entity, or

shall affect the right of the Agent, the DIP Agent, the Secured Creditors, or the DIP Lenders to object to the allowance and payment of any such fees and expenses.

12. <u>Payment of Allowed Professional Fees and Expenses Prior to the Termination</u> <u>Date</u>. Prior to the occurrence of the Termination Date (as defined below), the Debtors shall be permitted to pay allowed fees and expenses of the Debtors' Professionals, the Committees' Professionals and the Committee Members (to the extent the fees and expenses of the Debtors' Professionals, the Committees' Professionals and the Committee Members were incurred in accordance with the Budget), subject to the provisions of this Final Order, the Bankruptcy Code, the Bankruptcy Rules, the Local Rules, and any interim compensation procedures order entered by the Court. The amounts paid prior to the Carve-Out Trigger Notice shall not reduce the Post-Default Carve-Out Cap.

13. <u>Submission of Invoices</u>. At the end of each calendar month, the Debtors' Professionals, Committees' Professionals and the Committee Members (or counsel for the Creditors' Committee on behalf of the Committee Members) shall submit to the Agent and the DIP Agent invoices for professional services rendered in the immediately preceding month (or in the case of Committee Members, their respective expenses), which invoices may be redacted to exclude privileged information.

14. <u>Use of Non-Cash Collateral</u>. Notwithstanding any other provision in this Final Order, in the event the Debtors possesses any cash or cash equivalents during the pendency of the Bankruptcy Cases that are not subject to the Agent's, DIP Agent's, Secured Creditors', or DIP Lenders' liens or security interests, including, without limitation, the Replacement Liens and/or the DIP Liens, such cash or cash equivalents shall be used (or deemed to have been used) by the Debtors prior to the use of any Cash Collateral or DIP Proceeds.

15. Termination Date. Unless extended with the written consent of the Agent and the DIP Agent (confirmed by the entry of a further order of this Court), or further order of this Court, the authorization granted to the Debtors to use Cash Collateral and the DIP Proceeds under this Final Order shall terminate immediately upon the *earliest* to occur of the following (the date of such termination being the "Termination Date"), unless waived by Agent: (i) the occurrence of the Maturity Date or the Closing; provided that upon the Closing, the Debtors shall be permitted to retain a portion of the sale proceeds sufficient to satisfy all costs and expenses set forth in a revised Budget to be reasonably acceptable to the DIP Agent covering the time period from the Closing until the effective date of any plan confirmed by the Court; (ii) the entry of an order dismissing any of the Bankruptcy Cases; (iii) the entry of an order converting any of the Bankruptcy Cases to Chapter 7; (iv) the entry of an order appointing a trustee or an examiner with expanded powers for any of the Debtors' estates or with respect to any of the Debtors' property; (v) entry of an order reversing, vacating, or otherwise amending, supplementing, or modifying this Final Order; (vi) entry of an order granting relief from the automatic stay to any creditor with a claim larger than \$100,000 (other than the Agent or the Secured Creditors) holding or asserting a lien in the Collateral or the DIP Collateral (defined below); (vii) entry of an order for relief under Section 506(c) of the Bankruptcy Code with respect to the Collateral or the DIP Collateral; (viii) the filing by the Debtors of any motion in any of the Bankruptcy Cases, without the DIP Agent's and the DIP Lenders prior written consent, to (a) obtain financing under Section 364 of the Bankruptcy Code from any person or entity other than the DIP Agent or the DIP Lenders, or (b) grant any lien or offering any collateral to any person or entity other than the DIP Agent or the DIP Lenders; (ix) the Debtors breach or fail to comply with any term or provision of this Final Order; or (x) the Debtors' failure to timely and strictly comply with any of

the obligations and deadlines set forth in Schedule 2 attached hereto (the "<u>Sale/Chapter 11</u> <u>Milestones</u>"). Notwithstanding any such termination, the rights and obligations of the Debtors and the rights, claims, liens, priorities, and other benefits and protections afforded to the Agent, on behalf of the Secured Creditors, and the DIP Agent, on behalf of the DIP Lenders, under this Final Order shall remain unimpaired and unaffected by any such termination, and shall survive any such termination.

16. <u>Termination of Automatic Stay Upon Occurrence of the Termination Date</u>. Following the Termination Date, and upon three (3) business day's written notice (which may be delivered by electronic mail) to the Debtors, their counsel, the U.S. Trustee, and counsel for any appointed Committee, and the Agent and the DIP Agent shall be entitled to file an emergency motion seeking to exercise all rights and remedies provided in this Final Order, the Pre-Petition Loan Documents, the DIP Financing Document and applicable law, including, but not limited to, the Agent's and DIP Agent's rights to apply any proceeds of Collateral and the DIP Collateral to the Secured Claim and the DIP Obligations in accordance with the terms of the Pre-Petition Loan Documents, the DIP Financing Documents, and applicable law.

17. <u>Adequate Protection for the Use of Cash Collateral – Replacement Liens</u>. Notwithstanding anything in Section 552 of the Bankruptcy Code to the contrary, the Agent, on behalf of itself and the Secured Creditors, shall have, and is hereby granted, replacement liens and security interests in and on all property of the Debtors and their bankruptcy estates, including property acquired by the Debtors and their bankruptcy estates after the Petition Date, except for Chapter 5 causes of action and the proceeds thereof (the "<u>Replacement Liens</u>") to the extent necessary to adequately protect the Agent and the Secured Creditors from any diminution in the value of their interests in the Collateral as a result of the entry of this Final Order, the use of

Cash Collateral authorized hereby, and the imposition of the automatic stay in the Bankruptcy Cases.

18. <u>Adequate Protection for the Use of Cash Collateral – the Roll-Up</u>. The DIP Liens (defined below) granted to secure the DIP Roll-Up shall constitute adequate protection granted to the Agent and the Secured Creditors for the use of their Cash Collateral.

19. DIP Liens. In order to secure the DIP Obligations, the Agent and Secured Creditors are granted, subject only to the Permitted Liens (as defined in the Prepetition Loan Documents): (i) priming first-priority security interests and liens against all pre-petition and postpetition assets of the Debtors and their bankruptcy estates, except for Chapter 5 causes of action and proceeds thereof, which shall immediately be valid, binding, permanent, continuing, enforceable and non-avoidable pursuant to Section 364(d)(1) of the Bankruptcy Code: (ii) firstpriority security liens and interest in all unencumbered pre-petition and post-petition assets of the Debtors and their bankruptcy estates, except for Chapter 5 causes of action and proceeds thereof, which shall immediately be valid, binding, permanent, continuing, enforceable and nonavoidable pursuant to Section 364(c)(2) of the Bankruptcy Code; and (iii) second priority security interests and liens, pursuant to Section 364(c)(3) of the Bankruptcy Code, on all property of Debtors and their bankruptcy estates, except for Chapter 5 causes of action and proceeds thereof, that is subject to valid and unavoidable liens that were in existence as of the Petition Date or that are perfected subsequent to the Petition Date as permitted by Sections 546(b) and/or 552(b) of the Bankruptcy Code, if any, other than liens in favor of the Agent and the Secured Creditors (collectively, the "DIP Liens"). For the avoidance of any doubt, the DIP Liens granted to the DIP Agent and the DIP Lenders under the terms of this Final Order shall, subject only to the Permitted Liens, prime and have priority over the Pre-Petition Liens and the

Replacement Liens. The foregoing property described in sub-paragraphs (i), (ii), and (iii) above shall hereinafter be referred to as the "<u>DIP Collateral</u>."

20. Replacement Lien and DIP Lien Perfection. This Final Order shall be sufficient and conclusive evidence of the validity, perfection, and priority of the Replacements Liens and the DIP Liens without the necessity of filing or recording any financing statement, deed of trust, mortgage, or other instrument or document that may otherwise be required under the law of any jurisdiction, or the taking of any other action to validate or perfect the Replacement Liens or the DIP Liens in order to entitle the Replacement Liens and the DIP Lien to the priorities granted under this Final Order; provided, however, that the portion of the DIP Liens attributable to the DIP Roll-Up shall remain subject to the Challenge Period set forth in paragraph 29, but solely in the event that all or substantially all of the Prepetition Liens are avoided or subordinated. Notwithstanding the foregoing, the Agent, the DIP Agent, the Secured Creditors and the DIP Lenders may, in their sole and absolute discretion, file such financing statements, mortgages, security agreements, notices of liens and other similar documents, and are hereby granted relief from the automatic stay imposed by Section 362 of the Bankruptcy Code for the limited purpose of making such filings. All financing statements, mortgages, security agreements, notices and other agreements or documents filed in accordance with this provision shall be deemed to have been filed or recorded at the time and on the date of this Final Order. The Debtors shall execute and deliver to the Agent, the DIP Agent, the Secured Creditors, and the DIP Lenders all such financing statements, mortgages, security agreements, notices and other documents as the Agent, the DIP Agent, the Secured Creditors, and the DIP Lenders may reasonably request to evidence, confirm, validate or perfect, or to insure the contemplated priority of the Replacement Liens and/or the DIP Liens. The Agent, the DIP Agent, the Secured Creditors, and the DIP Lenders, in

their sole discretion, may file a photocopy of this Final Order as a financing statement with any recording officer designated to file financing statements or with any registry or recorder of deeds or similar office in any jurisdiction in which the Debtors have real or personal property, and in such event, the subject filing or recording officer shall be authorized to file or record such copy of this Final Order.

21. <u>Modification of the Automatic Stay</u>. The automatic stay imposed under Section 362(a) of the Bankruptcy Code is hereby modified as necessary to: (i) permit the Debtors to grant the Replacement Liens and the DIP Liens, and to incur all liabilities and obligations to the Agent, DIP Agent, the Secured Creditors, and DIP Lenders under and in connection with the DIP Financing Documents, the DIP Facility and this Final Order; and (ii) authorize the Agent, the DIP Agent, the Secured Creditors, and DIP Lenders to retain and apply payments made to them pursuant to the terms of this Final Order, the Pre-Petition Loan Documents, or the DIP Financing Documents.

22. <u>No Impairment of Priority of the Replacement Liens and DIP Liens</u>. Subject to the Carve-Out, the Replacement Liens and DIP Liens shall not be made subject to or *pari passu* with any lien or security interest by any other order entered by the Court in any of the Bankruptcy Cases. Furthermore, unless and until the Secured Claim and the DIP Obligations have been indefeasibly satisfied and/or paid in full, the Replacement Liens and DIP Liens shall remain enforceable and maintain their priority as provided by this Final Order in any successor Chapter 7 case(s) or subsequent / successor cases filed under any Chapter of the Bankruptcy Code regardless of whether such subsequent / successor cases are filed in this Court or any other bankruptcy court of competent jurisdiction.

23. <u>Additional Liens May Not be Granted</u>. From and after entry of this Final Order, unless the Agent and/or DIP Agent has provided its prior written consent or amounts owing on the Secured Claim and DIP Obligations have been indefeasibly paid in full and in cash, there shall not be entered in these Bankruptcy Cases, or in any successor case, any order which authorizes the obtaining of credit or the incurring of indebtedness that is secured by a security, mortgage, or collateral interest or other lien on all or any portion of the Collateral or the DIP Collateral. Additionally, no administrative claim allowed in these Bankruptcy Cases, or any successor case, shall be entitled to priority administrative status which is superior to or *pari passu* with the Cash Collateral Superpriority Claim (defined below) or DIP Superpriority Claim (defined below).

24. Adequate Protection for the Use of Cash Collateral – Superpriority Claim. Subject to the Carve-Out, to the extent the Replacement Liens granted to the Agent, on behalf of itself and the Secured Creditors, in this Final Order do not provide the Agent and the Secured Creditors with adequate protection of their interests in the Cash Collateral, the Agent shall have, for the benefit of itself and the Secured Creditors, a super-priority administrative expense claim under Section 507(b) of the Bankruptcy Code as necessary to fully compensate the Agent and the Secured Creditors for any diminution in the value of its Collateral occurring as a result of the Debtors' use of Cash Collateral during the Bankruptcy Cases (the "<u>Cash Collateral Superpriority</u> <u>Claim</u>"). Subject to the Carve-Out, the Cash Collateral Superpriority Claim shall have priority over all administrative expenses of any kind incurred in any of the Bankruptcy Cases, any successor Chapter 7 cases, or any subsequently filed bankruptcy case under any Chapter of the Bankruptcy Code in any court of competent jurisdiction, including such administrative expenses of the kinds specified in, or allowable under, Sections 105, 326, 330, 331, 503(b), 506(c), 507(a),

507(b) or 726 of the Bankruptcy Code; *provided*, *however*, that the Cash Collateral Superpriority Claim shall be *pari passu* with the DIP Superpriority Claim (defined below). Additionally, no: (i) costs or expenses of administration which have been or may be incurred (a) in the Bankruptcy Cases; (b) after the conversion of any of the Bankruptcy Cases to cases proceeding under Chapter 7 of the Bankruptcy Code, or (c) in any other proceeding related hereto; and/or (ii) priority claims as defined in Section 507(a) of the Bankruptcy Code are, or will be, prior to or *pari passu* with the Cash Collateral Superpriority Claims or the DIP Superpriority Claim.

25. <u>DIP Superpriority Claim.</u> Subject to the Carve-Out, and effective immediately upon the entry of this Final Order, and subject to the terms of the DIP Financing Documents, the Agent and the Secured Creditors, as adequate protection and security for the DIP Obligations, are hereby granted a superpriority administrative expense claim pursuant to Section 364(c)(1) of the Bankruptcy Code superior to any and all administrative expenses in any of the Bankruptcy Cases, any successor Chapter 7 cases, or any subsequently filed bankruptcy case under any Chapter of the Bankruptcy Code in any court of competent jurisdiction, including without limitation, any and all administrative expenses of the kind specified or ordered pursuant to any provision of the Bankruptcy Code, including, but not limited to, Sections 105, 326, 328, 330, 331, 503(b) 506(c), 507(a), 507(b) and 726 of the Bankruptcy Code (the "<u>DIP Superpriority Claim</u>"). Notwithstanding the foregoing, the DIP Superpriority Claim shall be *pari passu* with the Cash Collateral Superpriority Claim shall be *pari passu* with the Cash Collateral Superpriority Claim.

26. <u>Adequate Protection for the Use of Cash Collateral – Payment of Agent's</u> <u>Attorney's Fees</u>. As additional adequate protection, the Debtors are authorized and directed to pay all reasonable and documented fees (provided, however, that such documentation may be

abridged for attorney-client privilege and related issues), costs, and expenses for the professionals of the Agent incurred in connection with the Bankruptcy Cases (whether incurred before or after the Petition Date). The use of Cash Collateral to make such adequate protection payments for the fees, costs, and expenses of the Agent shall not constitute a diminution in the value of the Agent's and Secured Creditors' interests in property of the Debtors' estates giving rise to any additional adequate protection obligation.

27. Expenses of the Agent Related to the DIP Facility. As provided in the DIP Financing Documents, the Debtors shall pay all reasonable and documented, post-petition, out-of-pocket expenses incurred by the DIP Agent in the course of these Bankruptcy Cases (including, without limitation, the reasonable and documented fees and disbursements of counsel for the DIP Agent, any other local or foreign counsel that the DIP Agent shall retain, and any internal or third-party appraisers, consultants and auditors advising the DIP Agent), including in connection with the preparation, execution, delivery and administration of the DIP Financing Documents. To the extent provided to the Debtors, copies of all such documented expenses of the DIP Agent shall be provided to the Committee. Payment of such fees shall not be subject to allowance by the Bankruptcy Court, and shall not be required to comply with the U.S. Trustee fee guidelines.

28. <u>Release of Claims</u>. Without prejudice to the rights of any other party and subject to the Challenge Period set forth in paragraph 29, the Debtors and their estates shall be deemed to have forever waived, discharged, and released each of the Agent, the DIP Agent, the Secured Creditors, the DIP Lenders, and their respective affiliates, assigns or successors and the respective members, managers, equity holders, agents, attorneys, financial advisors, consultants, officers, directors, employees and other representatives of the foregoing (all of the foregoing,

collectively, the "Released Parties") from any and all "claims" (as defined in the Bankruptcy Code), counterclaims, causes of action (including causes of action in the nature of "lender liability"), defenses, setoff, recoupment, other offset rights and other rights of disgorgement or recovery against any and all of the Released Parties, whether arising at law or in equity, relating to and/or otherwise in connection with the Secured Claim, the DIP Obligations, the Prepetition Loan Documents, the DIP Financing Documents, the Collateral, the DIP Collateral, or the debtor-creditor relationship between any of the Agent, the DIP Agent, the Secured Creditors, and the DIP Lenders, on the one hand, and any of the Debtors, on the other hand, including (i) any recharacterization, subordination, avoidance, disallowance or other claim arising under or pursuant to Section 105 or Chapter 5 of the Bankruptcy Code, or under any other similar provisions of applicable state law, federal law, or municipal law, and (ii) any right or basis to challenge or object to the amount, validity, or enforceability of the Secured Claim or the DIP Obligations or any payments or other transfers made on account of the Secured Claim or the DIP Obligations, or the validity, enforceability, priority, or non-avoidability of the Prepetition Liens or the DIP Liens securing the Secured Claim and the DIP Obligations, including any right or basis to seek any disgorgement or recovery of payments of cash or any other distributions or transfers previously received by any of the Released Parties.

29. <u>Challenge Period</u>. With regard to all other: (i) creditors, including, but not limited to, any Committees appointed or formed in these Bankruptcy Cases; (ii) parties-in-interest; or (iii) other non-Debtor parties (collectively, the "<u>Investigating Parties</u>") who wish to object to, challenge, or seek to avoid or subordinate the amount, validity, enforceability, perfection, extent or priority of the Secured Claim, the DIP Obligations, the Prepetition Liens or the DIP Liens, such Investigating Parties must, by way of adversary proceeding, commence such objection /

challenge, or action to avoid or subordinate the Secured Claim, the DIP Obligations, the Agent's / Secured Creditors' liens in the Collateral, or the DIP Agent's / DIP Lender's liens in the DIP Collateral on or before September 14, 2018 (the "Investigation Period"). The Debtors, the Agent and the Lenders consent to an expedited hearing on any motion by a Committee to obtain standing (a "Standing Motion") on not less than seven (7) days' notice. For the avoidance of doubt, the filing by a Committee of a Standing Motion for authority and/or standing to commence a challenge proceeding shall toll and automatically extend the Investigation Period for the Committee until the date that is five (5) business days after the Court issues a ruling on the Standing Motion. The Investigation Period also may be extended: (i) by this Court for cause if a motion to extend the Investigation Period is filed on or before September 7, 2018; or (ii) if the Agent and/or DIP Agent, and an Investigating Party file a stipulation with the Court on or before the end of the Investigation Period. If an adversary proceeding is not commenced on or before the expiration of the Investigation Period: (i) the Investigating Parties will be deemed to have agreed and acknowledged that the Secured Claim, DIP Obligations, the Agent's / Secured Creditors' liens in the Collateral, and the DIP Agent's / DIP Lenders' liens in the DIP Collateral are legal, valid, binding, perfected, and otherwise unavoidable in an amount no less than the aggregate amount of the Secured Claim and the Commitment; (ii) have the priority afforded to the Secured Claim and the DIP Obligations as set forth in this Final Order; and (iii) the amount, validity, perfection, priority, or extent of the Secured Claim, the DIP Obligations, or the Agent's / Secured Creditors' liens in the Collateral and DIP Collateral shall not be subject to any other or further challenge by any of the Investigating Parties.

30. <u>Deposit Accounts</u>. The Debtors shall promptly, and shall continue to, segregate, remit, and deposit all Cash Collateral and DIP Proceeds currently in their possession, custody, or

control, or which the Debtors may receive in the future, into the deposit accounts identified by the applicable cash management orders entered by this Court in these Bankruptcy Cases. The bank accounts of the Debtors (the "<u>Accounts</u>") shall be in the name of the Debtors, but the Debtors shall be prohibited from withdrawing funds from the Accounts except in strict compliance with the terms of this Final Order, the DIP Financing Documents, and the Budget.

31. <u>Access to the Collateral and the DIP Collateral</u>. The Debtors shall, upon **three (3) business days'** notice to Debtor and Debtors' counsel by e-mail, at reasonable times and during normal business hours: (i) make available to the Agent and/or the DIP Agent, its representatives, agents, employees, counsel and consultants, the Debtors' books and records and other financial information requested by the Agent or the DIP Agent; and (ii) permit the Agent and/or the DIP Agent, its representatives, agents, employees, counsel and consultants, to visit, inspect, and/or have reasonable access to the Collateral and/or the DIP Collateral at the location where the Collateral and DIP Collateral is located.

32. <u>Reporting Obligations</u>. The Debtors shall provide the following to the Agent and the DIP Agent:

- Beginning on the Petition Date, and continuing every day thereafter, a Daily
 Cash/Liquidity Report setting forth cash on hand on an aggregate basis.
- (ii) Beginning on July 20, 2018, and continuing on every first business day of every week thereafter, a Volume Report setting forth the amount of patients, in the aggregate and broken down by facility, treated by the Debtors in the immediately preceding week.
- (iii) Beginning on July 20, 2018, and continuing on every other Wednesday thereafter(by Noon ET), a Budget Variance Report comparing (a) actual cash receipts and

cash disbursements (excluding debt service, professional fees, adequate protection, U.S. Trustee fees and capital expenditures) for the time period commencing on the Petition Date and ending on the Friday preceding the delivery of the Budget Variance Report to projected cash receipts and cash disbursements for the same period contained in the Budget; (b) the actual cash balance (after adding back any debt service, professional fees, adequate protection, U.S. Trustee fees and capital expenditures) on the Friday preceding the delivery of the Budget Variance Report to the projected cash balance (after adding back any debt service, professional fees, adequate protection, U.S. Trustee fees and capital expenditures) on the Friday preceding the delivery of the Budget Variance Report; (c) actual debt service, professional fees, adequate protection, and U.S. Trustee fees (on an individual basis) for the time period commencing on the Petition Date and ending on the Friday preceding the delivery of the Budget Variance Report to projected debt service, professional fees, adequate protection and U.S. Trustee fees (on an individual basis) for the same period contained in the Budget; and (d) actual capital expenditures for the two week time period ending on the Friday preceding the delivery of the Budget Variance Report to projected capital expenditures for the same time period contained in the Budget. To the extent that: (x) the actual cash disbursements (excluding debt service, professional fees, adequate protection, U.S. Trustee fees and capital expenditures) exceed the projected cash disbursements in the Budget by more than the Permitted Disbursements Variance or (y) the actual cash receipts are less than the projected cash receipts by more than the Permitted Receipts Variance, the Budget Variance Report shall also

include a detailed explanation regarding the reason that the Debtors failed to comply with the terms of the Budget. To the extent not described in this Order, the Budget Variance Reports shall also include the reporting provided by the Debtors to the Pre-Petition Agent as part of its weekly pre-petition "flash reporting";

- (iv) Within 5 business days before the end of every month, an updated Budget reasonably acceptable to the Agent and the DIP Agent extending the existing Budget so that it covers the upcoming thirteen-week period (along with continuing to show/compare budget and actual performance for all prior weeks covered by the Budget); and
- (v) Beginning on July 21, 2018, and continuing on the 21st calendar day of each month thereafter, an end-of-month report as of the end of the immediately preceding month that details: (i) accounts receivable balances; (ii) the aging of accounts receivable; (iii) a listing of all deposits and prepaid items requested or posted; (iv) accrued liabilities as of the preceding month, setting forth (without limitation) accounts payable detail and all other material unpaid post-bankruptcy liabilities (excluding professional fees) and (v) such other financial information as reasonably requested by the Agent and/or the DIP Agent.

33. <u>Disposition of the Collateral and/or the DIP Collateral.</u> The Debtors shall not sell, transfer, lease, encumber or otherwise dispose of any portion of the Collateral or DIP Collateral (or enter into any binding agreement to do so) without the prior written consent of the Agent, the DIP Agent, the Secured Creditors, and the DIP Lenders (and no such consent shall be implied from any other action, inaction, or acquiescence by the Agent, the DIP Agent, the Secured

Creditors, or the DIP Lenders, or any order of this Court), except: (i) for sales of inventory in the ordinary course of business; (ii) as otherwise provided for in the Pre-Petition Loan Documents and/or the DIP Financing Documents, and approved by the Bankruptcy Court to the extent required under applicable bankruptcy law; (iii) if allowed by subsequent Bankruptcy Court order; or (iv) for sales in the aggregate amount of less than \$50,000.

34. Right to Credit Bid. In the event of the sale of any of the Collateral and/or DIP Collateral pursuant to Section 363 of the Bankruptcy Code or under a plan of reorganization, the Agent, on behalf of the Secured Creditors, and the DIP Agent, on behalf of the DIP Lenders, shall have the right (at an auction or otherwise) to credit bid in an amount equal to the amount of the aggregate amount of the Secured Claim and the outstanding DIP Obligations; provided, however, that such credit bid will be: (i) first from the application of the outstanding DIP Obligations, including the funds necessary to pay the Bid Protections (as defined in the Order (A) Authorizing and Scheduling an Auction for the Sale of Debtors' Assets and (B) Approving Auction and Bid Procedures, Including Payment of Bid Protections [Docket No.]), if any, based upon successful credit bid; and, (ii) second from the application of any obligations secured by the Secured Claim to the extent that such credit bid is allocated to assets secured by prepetition liens. Notwithstanding the foregoing, nothing herein is a waiver of or release of any interested parties' right to challenge, or seek to avoid or subordinate the amount, validity, enforceability, extent or priority of the Secured Claim or the Prepetition Liens as set forth in Paragraph 29 herein.

35. <u>Sales Proceeds</u>. Subject to Paragraph 15 hereof, upon the closing of any sale of any of the Collateral and/or the DIP Collateral pursuant to Section 363 of the Bankruptcy Code or under a plan of reorganization, the proceeds of such sale shall be paid to the either/both Agent,

for immediate application to the outstanding Secured Claim, and/or the DIP Agent, for immediate application to the DIP Obligations and, thereafter, the Pre-Petition Indebtedness, without the need to obtain any further approval from the Court. For the avoidance of doubt, estate proceeds used to satisfy the Debtors' obligations to the Lenders shall be applied first to the DIP Obligations until satisfied in full (inclusive of any loan proceeds advanced to allow the Debtors to pay any break-up fee(s) and/or expense reimbursement to an unsuccessful bidder(s) at an auction), and then to the Pre-Petition Indebtedness.

36. <u>Section 506(c) Waiver</u>. The Debtors, on behalf of themselves and their bankruptcy estates, waive any and all claims, rights, and powers to surcharge the Agent, the DIP Agent, the Secured Creditors, the DIP Lenders, the Collateral, the DIP Collateral and any other property or assets of the Debtors subject in any manner whatsoever to the liens and security interests of the Agent, the DIP agent, the Secured Creditors, and the DIP Lenders (including the Replacement Liens and the DIP Liens) pursuant to Section 506(c) or Section 105(a) of the Bankruptcy Code. The foregoing waiver shall be binding upon any trustee or examiner with expanded powers appointed for any of the Debtors' estates, or with respect to any of the Debtors' property.

37. <u>Payment of Compensation</u>. Nothing herein shall: (i) be construed as consent to the allowance of any Professional Fees or expenses of any of the Debtors' Professionals or the Committees' Professionals; or (ii) affect the right of the Agent, the DIP Agent, the Secured Lenders, and/or the DIP Lenders to object to the allowance and payment of such fees and expenses.

38. <u>No Marshaling Required</u>. The Agent and the Secured Creditors shall not be subject to the equitable doctrine of "marshaling" or any other similar doctrine with respect to the Collateral and/or the DIP Collateral.

39. <u>Section 552(b)</u>. The Agent, the DIP Agent, the Secured Creditors, and the DIP Lenders shall be entitled to all of the rights and benefits of Section 552(b) of the Bankruptcy Code and the "equities of the case" exception under Section 552(b) of the Bankruptcy Code shall not apply to the Replacement Liens, the Secured Claim, the DIP Liens, the DIP Obligations, or any proceeds, products, offspring or profits of any of the foregoing.

40. <u>Continued Effectiveness of the Pre-Petition Loan Documents and DIP Financing</u> <u>Documents</u>. Except as otherwise provided herein, the terms and conditions of the Loan Documents and the DIP Financing Documents shall not be impaired by this Final Order, and the Agent, the DIP Agent, the Secured Creditors, and the DIP Lenders shall have all of their rights and remedies thereunder, subject to the provisions of the Bankruptcy Code, applicable state law and the authority of this Court. Additionally, unless specifically provided for in this Final Order, the Debtors are required to perform all of their obligations under the Pre-Petition Loan Documents and the DIP Financing Documents, including, without limitation, complying with the covenants set forth in the Pre-Petition Loan Documents and the DIP Financing Documents.

41. <u>Binding Effect of Final Order</u>. The provisions of this Final Order shall be binding upon and inure to the benefit of all parties in interest in the Bankruptcy Case, including the Agent, the DIP Agent, the Secured Creditors, the DIP Lenders, the Debtors and their bankruptcy estates, and their respective successors and assigns, including any trustee or examiner with expanded powers appointed for the Debtors' estate or with respect to the Debtors' property.

42. Survival of the Replacement Liens, DIP Liens, and Superpriority Claims. Additionally, unless and until the Secured Claim and the DIP Obligations have been indefeasibly satisfied and/or paid in full, the protections afforded to the Agent, the DIP Agent, the Secured Creditors, and the DIP Lenders under this Final Order, including any adequate protection granted hereunder, and any actions taken pursuant thereto, shall survive the entry of an order dismissing any of the Bankruptcy Cases, or converting any of the Bankruptcy Cases to cases proceeding under Chapter 7 of the Bankruptcy Code. Additionally, unless and until the Secured Claim and the DIP Obligations have been indefeasibly satisfied and/or paid in full, the Replacement Liens, DIP Liens, and the Superpriority Claims granted under this Final Order shall continue in the Bankruptcy Cases, in any successor Chapter 7 case(s), and any subsequent / successor cases filed under any Chapter of the Bankruptcy Code regardless of whether such subsequent / successor cases are filed in this Court or any other bankruptcy court of competent jurisdiction. Furthermore, unless and until the Secured Claim and the DIP Obligations have been indefeasibly satisfied and/or paid in full, the Replacement Liens, DIP Liens, and Superpriority Priority Claims shall maintain their priority as provided by this Final Order in any successor Chapter 7 case(s) or subsequent / successor cases filed under any Chapter of the Bankruptcy Code regardless of whether such subsequent / successor cases are filed in this Court or any other bankruptcy court of competent jurisdiction.

43. <u>No Admissions / Waiver by Agent</u>. Nothing in this Final Order will be deemed or construed as an admission or waiver by the Agent, the DIP Agent, any Secured Creditor, or any DIP Lender as to adequate protection, or any other issue in the Bankruptcy Cases. Nothing in this Final Order shall prejudice the Agent's, the DIP Agent's, the Secured Creditors', and the DIP Lenders' right to seek an order of this Court prohibiting Debtors' use of Cash Collateral

and/or the DIP Proceeds, or seek any other or supplemental relief that the Agent, the DIP Agents, the Secured Creditors, or the DIP Lenders may deem necessary and appropriate under the circumstances; and nothing in this Final Order prejudices the Debtors' or any other party in interest's right to oppose such relief requested by the Agent, the DIP Agent, the Secured Creditors, or the DIP Lenders.

44. <u>No Third-Party Liability</u>. The Agent, the DIP Agent, the Secured Creditors, and the DIP Lenders shall have no liability to any third party nor shall any of them be deemed to be in control of the Debtors or their operations or acting as a "controlling person," "responsible person," "managing agent," or "owner or operator" with respect to the operation or management of the Debtors (as such terms are defined in the Internal Revenue Code, the United States Comprehensive Environmental Response, Compensation and Liability Act, or any similar state or federal statute) or owe any fiduciary duty to the Debtors, their bankruptcy estates, or their creditors. The Agent's, the DIP Agent's, the Secured Creditors', or the DIP Lenders' relationship with the Debtors shall not constitute or be deemed to constitute a joint venture or partnership with the Debtors.

45. <u>Supplemental Unsecured Creditor Carve Out</u>. The Agent, the DIP Agent, the Secured Creditors and the DIP Lenders agree that, absent the commencement of any challenge under Paragraph 29 of this Order, they will consent to: (a) allocation of \$275,000 of the proceeds from the sale of the Collateral and/or DIP Collateral exclusively for the initial funding of a liquidating trust for the benefit of unsecured creditors, as part of a Bankruptcy Court approved plan of reorganization or liquidation; and (b) not sharing, on account of their deficiency claims, in the first \$1,000,000 of net distributions from any such liquidating trust to general unsecured

creditors provided that the next \$125,000 of such distributions are paid solely to them (with any subsequent distributions distributed on a pro-rata basis among all general unsecured creditors).

46. Taxing Authorities. Notwithstanding any provision of the Motion or any final orders pertaining to post-petition financing, use of cash collateral, or the sale of the Debtors' assets, or any agreements validated by any such orders, the liens, if any, currently held by Angelina County, Cameron County, Cypress-Fairbanks ISD, City of El Paso, Ector CAD, Galveston County, Gregg County, City of Harlingen, Harlingen CISD, Harris County, Hidalgo County, Jefferson County, City of McAllen, Montgomery County, Orange County, Smith County, Texas City ISD, Tom Green CAD, Brazos County, Pine Tree Independent School District, Williamson County, Midland Central Appraisal District, and Bowie Central Appraisal District (collectively, the "Taxing Authorities") shall neither be primed by nor subordinated to any liens granted thereby. Further, from the proceeds of the sale of any of the Debtors' assets located in the state of Texas that secure the claims filed by the Taxing Authorities, unless modified as set forth below, the amount of \$506,771.60 shall be set aside by the Debtors in a segregated account (the "Taxing Authority Segregated Account") as adequate protection for the secured claims of the Taxing Authorities prior to the distribution of any proceeds to any other creditor. Between the date of this Final Order and the closing of the sales of the Debtors' assets, the Taxing Authorities and the Debtors shall cooperate to verify and confirm the amount to be included in the Taxing Authority Segregated Account. If the Taxing Authorities and the Debtors cannot agree on the amount to be included in the Taxing Authority Segregated Account, the Court shall resolve the dispute after notice and a hearing. The liens, if any, of the Taxing Authorities shall attach to the Debtors' sale proceeds to the same extent and with the same priority as the liens they now hold against the property of the Debtors. The Lenders and DIP

Lenders' liens and security interests shall attach to the funds in the Taxing Authority Segregated Account, subject to any valid and enforceable Taxing Authorities' liens. These funds shall be on the order of adequate protection and shall constitute neither the allowance of the claims of the Taxing Authorities, nor a cap on the amounts they may be entitled to receive. The claims and liens of the Taxing Authorities shall remain subject to any and all objections any party would otherwise be entitled to raise as to the priority, validity or extent of such liens. These funds may be distributed only in payment of the claims and liens of the Taxing Authorities and the Debtors, or by subsequent order of the Court, duly noticed to the Taxing Authorities.

47. <u>Agent Proof of Claim</u>. Neither the Agent nor the Secured Creditors shall be required to file a proof of claim in these Bankruptcy Cases for their claims to be allowed, and the Debtors' stipulations in Paragraphs I - L of this Final Order shall be deemed to constitute a timely filed proof of claim. Any order entered by this Court in relation to the establishment of a bar date for any claim (including, without limitation, administrative claims) in the Bankruptcy Cases, or any successor case shall not apply to the Agent or the Secured Creditors.

48. <u>No Waivers or Modification of this Final Order.</u> The Debtor irrevocably waives any right to seek any modification or extension of this Final Order without the prior written consent of the Agent, the DIP Agent, the Secured Creditors, and the DIP Lenders and no such consent shall be implied by any other action, inaction or acquiescence of the Agent, the DIP Agent, the Secured Creditors, or the DIP Lenders.

49. <u>Inconsistency.</u> In the event of any inconsistency between the terms and conditions of the Pre-Petition Loan Documents and/or the DIP Financing Documents, and of this Final Order, the provisions of this Final Order shall govern and control.

50. <u>Retention of Jurisdiction</u>. The Bankruptcy Court has and will retain exclusive jurisdiction to enforce this Final Order according to its terms.

51. <u>Waiver of Rule 4001(a)(3) Stay</u>. In the event that the fourteen-day stay provided by Bankruptcy Rule 4001(a)(3) is applicable to any relief granted in this Final Order, such stay is hereby waived.

- 1) On the Petition Date, the Debtors shall file and properly serve a motion, in form and substance satisfactory to the Agent, the DIP Agent, the Secured Creditors, and the DIP Lenders (the "<u>Sale/Bidding Procedures Motion</u>"), seeking the Court's approval of: (i) the sale of all or substantially all of the Debtors' assets relating to the Debtors' Freestanding Emergency Room business through one or more transactions; and (ii) bidding procedures acceptable to the Agent, the DIP Agent, the Secured Creditors, and the DIP Lenders in their sole discretion for the sale of all or substantially all of the Debtors' assets relating to the Debtors' Freestanding Emergency Room business, pursuant to Section 363 and Section 365 of the Bankruptcy Code. The terms of each such sale transaction shall be acceptable to the DIP Agent and the Prepetition First Lien Agent in their sole discretion.
- 2) Within 21 days after the Petition Date, unless the Agent, Required Lenders (as defined in the Credit Agreement), the DIP Agent and the Required DIP Lenders (which shall mean the "Required Lenders", as defined in the DIP Financing Documents) agree otherwise, the Court shall have entered a sales procedures order (the "<u>Bidding Procedures Order</u>") approving the bidding procedures contained in the Sale/Bidding Procedures Motion, which Bidding Procedures Order (including the bidding procedures approved therein) shall be acceptable to the Agent, Required Lenders, DIP Agent and Required DIP Lenders in their sole discretion. The Bidding Procedures Order shall not be amended, modified, supplemented or waived by the Debtors without the written consent of the Agent, Required Lenders, DIP Agent and Required DIP Lenders.
- 3) Within 45 days after the Petition Date, unless the Agent, Required Lenders, DIP Agent and Required DIP Lenders agree otherwise, all qualified bids (which bids, among other things, shall not contain any financing or diligence conditions) shall be due.
- 4) Within 60 days after the Petition Date, unless the Agent, Required Lenders, DIP Agent and Required DIP Lenders agree otherwise, the Debtors shall have held and completed an auction in accordance with the provisions of the Bidding Procedures Order, and shall have selected for approval by the Court, at a sale hearing to be held in accordance with the Bidding Procedures Order, the highest and otherwise best bid(s) for the applicable assets made by any bidder(s) at the auction, (each such highest and otherwise best bid, a "<u>Winning Bid</u>"). No bid that fails to provide for irrevocable payment in full in cash of all of the DIP Obligations and the Secured Claim at closing shall constitute, or be eligible to constitute, a Winning Bid unless such bid is acceptable to the Agent, Required Lenders, DIP Agent and Required DIP Lenders in their respective sole discretion.
- 5) Within 70 days after the Petition Date, unless the Agent, Required Lenders, DIP Agent and Required DIP Lenders agree otherwise, the Court shall have entered one or more orders (the "<u>Sale Approval Order</u>") approving the Winning Bid(s), the transaction or transactions contemplated by the Winning Bid(s) (each, an "<u>Approved Transaction</u>," and the terms and

conditions of the Approved Transaction and the documents evidencing or otherwise relating to each Approved Transaction, the "<u>Approved Transaction Documents</u>"), which Sale Approval Order and Approved Transaction(s) shall be in form and substance acceptable to the Agent, Required Lenders, DIP Agent and Required DIP Lenders in their sole discretion.

- 6) On or before the date that is sixty (60) days after the entry of the Sale Approval Order, unless the Agent, Required Lenders, DIP Agent and Required DIP Lenders agree otherwise, Debtors shall have executed all Approved Transaction Documents and the Approved Transaction(s) shall have been consummated. The Approved Transaction Documents shall be in form and substance acceptable to the Agent, Required Lenders, DIP Agent and Required DIP Lenders in their sole discretion.
- 7) On or before the date that is 120 days after the Petition Date, Debtors shall file an Acceptable Bankruptcy Plan and Disclosure Statement, within the meaning of Section 1125 of the Bankruptcy Code, each in form and substance acceptable to the Lenders.
- 8) With respect to any assets relating to the Debtors' Freestanding Emergency Room business that are not sold pursuant to any Approved Transaction, unless the Agent, Required Lenders, DIP Agent and Required DIP Lenders agree otherwise, the Debtors shall use commercially reasonable efforts to sell, liquidate or otherwise dispose of such assets on terms and conditions and pursuant to a timeline to be agreed upon by the Debtors, the Agent, Required Lenders, DIP Agent and Required DIP Lenders.
- 9) At the request of the Agent or the DIP Agent on a twice weekly basis (or more frequently as reasonably requested by the Agent or DIP Agent) from and after the date hereof, management of the Debtors and the Investment Bankers (as defined below) shall conduct a telephonic meeting to be attended by the respective management representatives of the Debtors, the Agent, the DIP Agent, and their respective representatives. At such telephonic meeting, the Debtors and the Investment Bankers shall present an update on the sale process (including an assessment of any proposed sale transaction or any indication of interest or other offer from any prospective purchaser).
- 10) Until such time as the DIP Obligations and the Prepetition First Lien Obligations are Paid in Full, the Debtors shall continue to retain one or more investment bankers reasonably acceptable to the Agent, Required Lenders, DIP Agent and Required DIP Lenders (collectively, the "Investment Bankers") on terms and conditions acceptable to the Agent, Required Lenders, DIP Agent and Required DIP Lenders in their sole discretion, to assist the Debtors to sell their respective assets and businesses, and no proceeds of the Collateral, the DIP Collateral, or the DIP Proceeds may be used to pay, and the Carve-Out shall not include, any fees and expenses of any investment banker or other financial advisor retained by any Debtor unless the Agent, Required Lenders, DIP Agent and Required DIP Lenders have consented in writing to the terms and conditions of such retention. Additionally, the Debtors shall authorize and direct the Investment Bankers, upon the request of the Agent and the DIP Agent: (i) to fully and promptly disclose to the Agent or DIP Agent, and their respective advisors, all material documents, information and developments in connection with the efforts of the Debtors and/or the Investment Bankers to market and sell the Collateral and/or DIP Collateral; and (ii) to regularly consult with, and promptly respond to the inquiries of,

the Agent and DIP Agent, and their respective advisors, in connection with any sale transaction, the marketing and sale process relating thereto, and any and all other matters relating to the affairs, finances and business of the Debtors, the assets and capital stock of the Debtors, and the Investment Bankers' activities related to any and all of the foregoing.

This DEBTOR-IN-POSSESSION CREDIT AGREEMENT is entered into as of ______, 2018 among the following: (i) Neighbors Global Holdings, LLC, a Delaware limited liability company, as the borrower (the "<u>Borrower</u>"); (ii) the lenders from time to time party hereto (each a "<u>Lender</u>" and collectively, the "<u>Lenders</u>"); and (iii) KeyBank National Association, as the administrative agent (the "<u>Administrative Agent</u>").

PRELIMINARY STATEMENTS:

(1) On July 12, 2018 (the "<u>Petition Date</u>"), the Borrower commenced Chapter 11 Case No. (the "<u>Borrower Chapter 11 Case</u>") and its Subsidiaries set forth on <u>Schedule 1.01</u> (together with the Borrower and any other Person later joined therewith, the "<u>Debtors</u>") commenced case Nos. (together with the Borrower Chapter 11 Case, the "<u>Chapter 11 Cases</u>") by filing voluntary petitions for reorganization under Chapter 11 of the Bankruptcy Code with the Bankruptcy Court.

(2) Prior to the Petition Date, the Pre-Petition Lenders provided financing to the Borrower pursuant to that certain Credit Agreement dated as of November 19, 2015 (as amended or otherwise modified through the Petition Date, the "<u>Pre-Petition Credit Agreement</u>"), among the Borrower, the lenders party thereto (collectively, the "<u>Pre-Petition Administrative Agent</u>"), as the Swing Line Lender (as defined in the Pre-Petition Credit Agreement) and as LC Issuer (as defined in the Pre-Petition Credit Agreement), KeyBanc Capital Markets Inc., as a joint lead arranger and a joint bookrunner, Compass Bank, as a joint lead arranger, a joint bookrunner and the sole syndication agent, and LegacyTexas Bank, as the documentation agent.

(3) The Pre-Petition First Lien Obligations are secured by a security interest in substantially all of the existing and after acquired assets of the Borrower and its Subsidiaries and by a lien on certain of the real property of certain of its Subsidiaries, as more fully set forth in the Security Agreement and the Mortgages (as such terms are defined in the Pre-Petition Credit Agreement) and such security interest and lien are perfected and, with certain exceptions as described in the Security Agreement and the Mortgages (as such terms are defined in the Pre-Petition Credit Agreement), have priority over other security interests.

AGREEMENT:

ARTICLE I

DEFINITIONS AND TERMS

"<u>Acceptable Bankruptcy Plan</u>" means a plan of reorganization or liquidation for each of the Chapter 11 Cases that (a) provides for the termination of the unused Revolving Commitments and the payment in full in cash and full discharge of the Obligations at emergence, (b) contains releases and other exculpatory provisions for the Administrative Agent and the Lenders in form and substance reasonably satisfactory to the Administrative Agent and the Required Lenders and (c) is otherwise in form and substance satisfactory to the Administrative Agent and the Required Lenders.

"<u>Acquisition</u>" means any transaction or series of related transactions for the purpose of or resulting, directly or indirectly, in (i) the acquisition of all or substantially all of the assets of any Person, or any business or division of any Person, (ii) the acquisition or ownership of in excess of 50% of the Equity Interests of any Person, or (iii) the acquisition of another Person by a merger, consolidation, amalgamation or any other combination with such Person.

"Adjusted Eurodollar Rate" means with respect to each Interest Period for a Eurodollar Loan, the greater of (A) (i) the rate per annum equal to the offered rate appearing on Reuters Screen LIBOR01 Page (or on the appropriate page of any successor to or substitute for such service, or, if such rate is not available, on the appropriate page of any generally recognized financial information service, as selected by the Administrative Agent from time to time) that displays an average ICE Benchmark Administration (or any successor thereto) Interest Settlement Rate at approximately 11:00 A.M. Notwithstanding the foregoing, neither the Administrative Agent nor any Lender shall in any event be considered an Affiliate of the Borrower or any of its Subsidiaries.

"Agent Advances" has the meaning provided in Section 9.13.

"<u>Aggregate Credit Facility Exposure</u>" means, at any time, the sum of (i) the Aggregate Revolving Facility Exposure at such time, and (ii) the aggregate principal amount of the Term Loans outstanding at such time.

"<u>Unused Revolving Commitment</u>" means, for any Lender at any time, the excess of (i) such Lender's Revolving Commitment at such time over (ii) such Lender's Revolving Facility Exposure at such time.

"<u>Unused Total Revolving Commitment</u>" means, at any time, the excess of (i) the Total Revolving Commitment at such time over (ii) the Aggregate Revolving Facility Exposure at such time.

"<u>U.S. Person</u>" means any Person that is a "United States Person" as defined in Section 7701(a)(30) of the Code.

"U.S. Tax Compliance Certificate" has the meaning assigned to such term in Section 3.03(g)(ii)(B)(3).

"<u>U.S. Trustee</u>" means the Office of the United States Trustee for the Southern District of Texas

"<u>USA Patriot Act</u>" means the Uniting and Strengthening America by Providing Appropriate Tools Required to Intercept and Obstruct Terrorism (USA PATRIOT Act) Act of 2001.

"<u>Voting Power</u>" means, with respect to any Person, the exclusive ability to control, through the ownership of shares of capital stock, partnership interests, membership interests or otherwise, the election of members of the board of directors or other similar governing body of such Person, and the holding of a designated percentage of Voting Power of a Person means the ownership of shares of capital stock, partnership interests or other interests of such Person sufficient to control exclusively the election of that percentage of the members of the board of directors or other similar governing body of such Person.

"Withholding Agent" means any Credit Party and the Administrative Agent.

Section 1.02 <u>Computation of Time Periods</u>. In this Agreement in the computation of periods of time from a specified date to a later specified date, the word "from" means "from and including," the words "to" and "until" each means "to but excluding" and the word "through" means "through and including."

Section 1.03 Accounting Terms. Except as otherwise specifically provided herein, all terms of an accounting or financial nature shall be construed in accordance with GAAP, as in effect from time to time, provided that (i) if the Borrower notifies the Administrative Agent and the Lenders that the Borrower wishes to amend any financial ratio or requirement to eliminate the effect of any change in GAAP that occurs after the Closing Date on the operation of such financial ratio or requirement, or (ii) if the Administrative Agent notifies the Borrower that the Required Lenders wish to amend any financial ratio or requirement for such purpose), the Borrower, the Administrative Agent and the Lenders shall enter into negotiations to amend any such financial ratio or requirement immediately upon receipt from any party entitled to send such notice and the Borrower's compliance with such financial ratio or requirement shall be determined on the basis of GAAP in effect immediately before the relevant change in GAAP became effective, until either such notice is withdrawn or such financial ratio or requirement is amended in a manner satisfactory to the Borrower, the Administrative Agent and the Required Lenders. Notwithstanding the foregoing, (A) all financial statements delivered hereunder shall be prepared, and all financial covenants contained herein shall be calculated, without giving effect to any election under Statement of Financial Accounting Standards 159 (or any similar accounting principle) permitting a Person to value its financial liabilities at the fair value thereof and (B) all leases of the Borrower and its Subsidiaries that were treated as operating leases in accordance with GAAP on the Closing Date shall continue to be treated as operating leases for purposes of the financial definitions contained herein, regardless of any change in GAAP after the Closing Date that would otherwise require such operating leases to be treated as Capital Leases; provided that, the Borrower shall provide to the Administrative Agent financial statements and other documents required under this Agreement which include a reconciliation showing such treatment before and after giving effect to such change in GAAP.

Terms Generally. The definitions of terms herein shall apply equally to the Section 1.04 singular and plural forms of the terms defined. Whenever the context may require, any pronoun shall include the corresponding masculine, feminine and neuter forms. The words "include," -includes" and including" shall be deemed to be followed by the phrase "without limitation." The word "will" shall be construed to have the same meaning and effect as the word "shall." Unless the context requires otherwise, (a) any definition of or reference to any agreement, instrument or other document herein shall be construed as referring to such agreement, instrument or other document as from time to time amended, restated, supplemented or otherwise modified (subject to any restrictions on such amendments, supplements or modifications set forth herein or in any other Loan Document), (b) any reference herein to any Person shall be construed to include such Person's successors and assigns, (c) the words "herein," "hereof' and "hereunder," and words of similar import, shall be construed to refer to this Agreement in its entirety and not to any particular provision hereof, (d) all references herein to Sections, Schedules and Exhibits shall be construed to refer to Sections of, and Schedules and Exhibits to, this Agreement, (e) the words "asset" and "property" shall be construed to have the same meaning and effect and to refer to any and all Real Property, tangible and intangible assets and properties, including cash, securities, accounts and contract rights, and interests in any of the foregoing, and (f) any reference to a statute, rule or regulation is to that statute, rule or regulation as now enacted or as the same may from time to time be amended, re-enacted or expressly replaced.

ARTICLE II

THE TERMS OF THE CREDIT FACILITY

Section 2.01 <u>Establishment of the Credit Facility</u>. On the Closing Date, and subject to and upon the terms and conditions set forth in this Agreement and the other Loan Documents, the Administrative Agent and the Lenders agree to establish the Credit Facility for the benefit of the Borrower; provided that at no time will (i) the Aggregate Credit Facility Exposure exceed the Total Credit

Facility Amount, or (ii) the Credit Facility Exposure of any Lender exceed the aggregate amount of such Lender's Commitment.

Section 2.02 Revolving Facility. During the Revolving Facility Availability Period, each Lender severally, and not jointly, agrees, on the terms and conditions set forth in this Agreement, to make a Revolving Loan or Revolving Loans to the Borrower from time to time pursuant to such Lender's Revolving Commitment, which Revolving Loans: (i) may, except as set forth herein, at the option of the Borrower, be incurred and maintained as, or Converted into, Revolving Loans that are Base Rate Loans or Eurodollar Loans, in each case denominated in Dollars, provided that all Revolving Loans made as part of the same Revolving Borrowing shall consist of Revolving Loans of the same Type; (ii) may be repaid or prepaid and reborrowed in accordance with the provisions hereof; and (iii) shall not be made if, after giving effect to any such Revolving Loan, (A) the Revolving Facility Exposure of any Lender would exceed such Lender's Revolving Commitment, (B) the Aggregate Revolving Facility Exposure would exceed the lesser of (x) the Total Revolving Commitment and (y) the Revolving Availability or (C) the Borrower would be required to prepay Loans pursuant to Section 2.11(b)(ii) or (iii). The Revolving Loans to be made by each Lender will be made by such Lender on a pro rata basis based upon such Lender's Revolving Facility Percentage of each Revolving Borrowing, in each case in accordance with Section 2.05 hereof.

Section 2.03 <u>Term Loan</u>. On the Closing Date, each Lender that has a Term Commitment severally, and not jointly, agrees, on the terms and conditions set forth in this Agreement, to make a Term Loan to the Borrower pursuant to such Lender's Term Commitment, which Term Loans: (i) can only be incurred on the Closing Date in the entire amount of each Lender's Term Commitment; (ii) once prepaid or repaid, may not be reborrowed; (iii) may, except as set forth herein, at the option of the Borrower, be incurred and maintained as, or Converted into, Term Loans that are Base Rate Loans or Eurodollar Loans, in each case denominated in Dollars, provided that all Term Loans made as part of the same Term Borrowing shall consist of Term Loans of the same Type; (iv) shall be repaid in accordance with <u>Section 2.11</u>; and (v) shall not exceed (A) for any Lender at the time of incurrence thereof the aggregate principal amount of such Lender's Term Commitment, if any, and (B) for all the Lenders at the time of incurrence thereof the Total Term Loan Commitment. The Term Loans to be made by each Lender will be made by such Lender in the aggregate amount of its Term Commitment in accordance with <u>Section 2.05</u> hereof.

Section 2.04 <u>Notice of Borrowing</u>.

(a) <u>Time of Notice</u>. Each Borrowing of a Loan (other than a Continuation or Conversion) shall be made upon notice in the form provided for below which shall be provided by the Borrower to the Administrative Agent at its Notice Office (with a copy to Sally C. Barton, 127 Public Square, Cleveland, OH 44114) not later than (i) in the case of each Borrowing of a Eurodollar Loan, 11:00 A.M. (local time at its Notice Office) at least three Business Days' prior to the date of such Borrowing and (ii) in the case of each Borrowing of a Base Rate Loan, prior to 11:00 A.M. (local time at its Notice Office) on the proposed date of such Borrowing.

(b) <u>Notice of Borrowing</u>. Each request for a Borrowing (other than a Continuation or Conversion) shall be made by an Authorized Officer of the Borrower by delivering written notice of such request substantially in the form of <u>Exhibit B-1</u> hereto (each such notice, a "<u>Notice of Borrowing</u>") or by telephone (to be confirmed immediately in writing by delivery by an Authorized Officer of the Borrower of a Notice of Borrowing), and in any event each such request shall be irrevocable, shall be made no more often than as set forth in clause (d) below and shall specify (i) the aggregate principal amount of the Loans to be made pursuant to such Borrowing, (ii) the date of the Borrowing (which shall be a Business Day), (iii) the Type of Loans such Borrowing will consist of, and (iv) if applicable, the initial Interest Period. Without in any way limiting the obligation of the Borrower to confirm in writing

any telephonic notice permitted to be given hereunder, the Administrative Agent may act prior to receipt of written confirmation without liability upon the basis of such telephonic notice believed by the Administrative Agent in good faith to be from an Authorized Officer of the Borrower entitled to give telephonic notices under this Agreement on behalf of the Borrower. In each such case, the Administrative Agent's record of the terms of such telephonic notice shall be conclusive absent manifest error.

(c) <u>Minimum Borrowing Amount</u>. The aggregate principal amount of each Borrowing by the Borrower shall not be less than the Minimum Borrowing Amount.

(d) <u>Maximum Borrowings</u>. No more than one Borrowing may be incurred by the Borrower in any two (2) week period, and such Borrowings must be consistent with the Budget. At no time shall there be more than five (5) Borrowings of Eurodollar Loans outstanding hereunder.

Section 2.05 Funding Obligations; Disbursement of Funds.

(a) <u>Several Nature of Funding Obligations</u>. The Commitments of each Lender hereunder and the obligation of each Lender to make Loans are several and not joint obligations. No Lender shall be responsible for any default by any other Lender in its obligation to make Loans or fund any participation hereunder and each Lender shall be obligated to make the Loans provided to be made by it and fund its participations required to be funded by it hereunder, regardless of the failure of any other Lender to fulfill any of its Commitments hereunder. Nothing herein and no subsequent termination of the Commitments pursuant to <u>Section 2.10</u> shall be deemed to relieve any Lender from its obligation to fulfill its commitments hereunder and in existence from time to time or to prejudice any rights that the Borrower may have against any Lender as a result of any default by such Lender hereunder.

(b) <u>Borrowings Pro Rata</u>. All Loans hereunder shall be made as follows: (i) all Revolving Loans made shall be made on a pro rata basis based upon each Lender's Revolving Facility Percentage of the amount of such Revolving Borrowing in effect on the date the applicable Revolving Borrowing is to be made; and (ii) all Term Loans shall be made by the Lenders having Term Commitments pro rata on the basis of their respective Term Commitments.

(c) <u>Notice to Lenders</u>. The Administrative Agent shall promptly give each Lender, as applicable, written notice (or telephonic notice promptly confirmed in writing) of each proposed Borrowing, or Conversion or Continuation thereof, and of such Lender's proportionate share thereof or participation therein and of the other matters covered by the Notice of Borrowing, Notice of Continuation or Conversion, as the case may be, relating thereto.

(d) <u>Funding of Loans</u>. No later than 2:00 P.M. (local time at the Payment Office) on the date specified in each Notice of Borrowing, each Lender will make available its amount, if any, of each Borrowing requested to be made on such date to the Administrative Agent at the Payment Office in Dollars and in immediately available funds and the Administrative Agent promptly will make available to the Borrower by [wiring to _____] (or such other account as the Borrower shall specify) the aggregate of the amounts so made available in the type of funds received.

(e) <u>Advance Funding</u>. Unless the Administrative Agent shall have been notified by any Lender prior to the date of Borrowing that such Lender does not intend to make available to the Administrative Agent its portion of the Borrowing or Borrowings to be made on such date, the Administrative Agent may assume that such Lender has made such amount available to the Administrative Agent on such date of Borrowing, and the Administrative Agent, in reliance upon such assumption, may (in its sole discretion and without any obligation to do so) make available to the Borrower a corresponding amount. If such corresponding amount is not in fact made available to the

Administrative Agent by such Lender and the Administrative Agent has made the same available to the Borrower, the Administrative Agent shall be entitled to recover such corresponding amount from such Lender. If such Lender does not pay such corresponding amount forthwith upon the Administrative Agent's demand therefor, the Administrative Agent shall promptly notify the Borrower, and the Borrower shall immediately pay such corresponding amount to the Administrative Agent. The Administrative Agent shall also be entitled to recover from such Lender or the Borrower, as the case may be, interest on such corresponding amount in respect of each day from the date such corresponding amount was made available by the Administrative Agent at a rate per annum equal to (i) if paid by such Lender, the overnight Federal Funds Effective Rate or (ii) if paid by the Borrower, the then applicable rate of interest, calculated in accordance with Section 2.07, for the respective Loans (but without any requirement to pay any amounts in respect thereof pursuant to Section 3.02).

Section 2.06 Evidence of Obligations.

(a) <u>Loan Accounts of Lenders</u>. Each Lender shall maintain in accordance with its usual practice an account or accounts evidencing the Obligations of the Borrower to such Lender resulting from each Loan made by such Lender, including the amounts of principal and interest payable and paid to such Lender from time to time hereunder.

(b) Loan Accounts of Administrative Agent; Lender Register. The Administrative Agent shall maintain accounts in which it shall record: (i) the amount of each Loan and Borrowing made hereunder, the Type thereof, the currency in which such Loan is denominated, the Interest Period and applicable interest rate; (ii) the amount of any principal due and payable or to become due and payable from the Borrower to each Lender hereunder; (iii) the amount of any sum received by the Administrative Agent hereunder for the account of the Lenders and each Lender's share thereof; and (iv) the other details relating to the Loans and other Obligations. In addition, the Administrative Agent shall maintain a register (the "Lender Register") on or in which it will record the names and addresses of the Lenders, and the Commitments from time to time of each of the Lenders. The Administrative Agent will make the Lender Register available to any Lender or the Borrower upon its request.

(c) <u>Effect of Loan Accounts, etc.</u> The entries made in the accounts maintained pursuant to <u>Section 2.07(b)</u> shall be prima facie evidence of the existence and amounts of the Obligations recorded therein; provided that, the failure of the Administrative Agent to maintain such accounts or any error (other than manifest error) therein shall not in any manner affect the obligation of any Credit Party to repay or prepay the Loans or the other Obligations in accordance with the terms of this Agreement.

(d) <u>Notes</u>. Upon request of any Lender, the Borrower will execute and deliver to such Lender (i) a Revolving Facility Note with blanks appropriately completed in conformity herewith to evidence the Borrower's obligation to pay the principal of, and interest on, the Revolving Loans made to it by such Lender and (ii) a Term Note with blanks appropriately completed in conformity herewith to evidence its obligation to pay the principal of, and interest on, the Term Loan made to it by such Lender; provided that, the decision of any Lender to not request a Note shall in no way detract from the Borrower's obligation to repay the Loans and other amounts owing by the Borrower to such Lender.

Section 2.07 Interest; Default Rate.

(a) <u>Interest on Revolving Loans</u>. The outstanding principal amount of each Revolving Loan made by each Lender shall bear interest at a fluctuating rate per annum that shall at all times be equal to (i) during such periods as such Revolving Loan is a Base Rate Loan, the Base Rate plus the Applicable Revolving Loan Margin and (ii) during such periods as such Revolving Loan is a

Eurodollar Loan, the relevant Adjusted Eurodollar Rate for such Eurodollar Loan for the applicable Interest Period plus the Applicable Revolving Loan Margin.

(b) <u>Interest on Term Loans</u>. The outstanding principal amount of each Term Loan made by each Lender shall bear interest at a fluctuating rate per annum that shall at all times be equal to (i) during such periods as such Term Loan is a Base Rate Loan, the Base Rate plus the Applicable Term Loan Margin, and (ii) during such periods as such Term Loan is a Eurodollar Loan, the relevant Adjusted Eurodollar Rate for such Eurodollar Loan for the applicable Interest Period plus the Applicable Term Loan Margin.

(c) <u>Default Interest</u>. Notwithstanding the above provisions, if (x) any Event of Default other than a Specified Event of Default has occurred and is continuing, then upon written notice by the Administrative Agent (which notice the Administrative Agent may give in its discretion and shall give at the direction of the Required Lenders) and (y) a Specified Event of Default has occurred and is continuing, then automatically the principal amount of all Loans outstanding and, to the extent permitted by applicable law, all overdue interest in respect of each Loan and all fees or other amounts owed hereunder, shall thereafter bear interest (including post-petition interest in any proceeding under the Bankruptcy Code or other applicable bankruptcy laws) payable on demand, at a rate per annum equal to the Default Rate. In addition, if any amount (other than amounts as to which the foregoing sentence is applicable) payable by the Borrower under the Loan Documents is not paid when due, upon written notice by the Administrative Agent (which notice the Administrative Agent may give in its discretion and shall give at the direction of the Required Lenders), such amount shall bear interest, payable on demand, at a rate per annum equal to the Default Rate.

(d) <u>Accrual and Payment of Interest</u>. Interest shall accrue from and including the date of any Borrowing to but excluding the date of any prepayment or repayment thereof and shall be payable by the Borrower: (i) in respect of each Base Rate Loan, quarterly in arrears on the last Business Day of each March, June, September and December: (ii) in respect of each Eurodollar Loan, on the last day of each Interest Period applicable thereto; and (iii) in respect of all Loans, other than Revolving Loans accruing interest at a Base Rate, on any repayment, prepayment or Conversion (on the amount repaid, prepaid or Converted), at maturity (whether by acceleration or otherwise), and, after such maturity, on demand.

(e) <u>Computations of Interest</u>. All computation of interest hereunder shall be made on the actual number of days elapsed over a year of 360 days, except that interest computed by reference to the Base Rate shall be computed on the basis of a year of 365 days (or 366 days in a leap year).

(f) <u>Information as to Interest Rates</u>. The Administrative Agent, upon determining the interest rate for any Borrowing, shall promptly notify the Borrower and the Lenders thereof. Any such determination by the Administrative Agent shall be conclusive and binding absent manifest error.

Section 2.08 <u>Conversion and Continuation of Loans</u>.

(a) <u>Conversion and Continuation of Revolving Loans</u>. The Borrower shall have the right, subject to the terms and conditions of this Agreement, to (i) Convert all or a portion of the outstanding principal amount of Loans of one Type made to it into a Borrowing or Borrowings of another Type of Loans that can be made to it pursuant to this Agreement and (ii) Continue a Borrowing of Eurodollar Loans at the end of the applicable Interest Period as a new Borrowing of Eurodollar Loans with a new Interest Period; provided that, any Conversion of Eurodollar Loans into Base Rate Loans shall be made on, and only on, the last day of an Interest Period for such Eurodollar Loans.

(b) Notice of Continuation and Conversion. Each Continuation or Conversion of a Loan shall be made upon notice in the form provided for below provided by the Borrower to the Administrative Agent at its Notice Office (with a copy to Sally C. Barton, 127 Public Square, Cleveland, OH 44114) not later than (i) in the case of each Continuation of or Conversion into a Eurodollar Loan, prior to 11:00 A.M. (local time at its Notice Office) at least three Business Days' prior to the date of such Continuation or Conversion, and (ii) in the case of each Conversion to a Base Rate Loan, prior to 11:00 A.M. (local time at its Notice Office) on the proposed date of such Conversion. Each such request shall be made by an Authorized Officer of the Borrower delivering written notice of such request substantially in the form of Exhibit B-2 hereto (each such notice, a "Notice of Continuation or Conversion") or by telephone (to be confirmed immediately in writing by delivery by an Authorized Officer of the Borrower of a Notice of Continuation or Conversion), and in any event each such request shall be irrevocable and shall specify (A) the Borrowings to be Continued or Converted, (B) the date of the Continuation or Conversion (which shall be a Business Day), and (C) the Interest Period or, in the case of a Continuation, the new Interest Period. Without in any way limiting the obligation of the Borrower to confirm in writing any telephonic notice permitted to be given hereunder, the Administrative Agent may act prior to receipt of written confirmation without liability upon the basis of such telephonic notice believed by the Administrative Agent in good faith to be from an Authorized Officer of the Borrower entitled to give telephonic notices under this Agreement on behalf of the Borrower. In each such case, the Administrative Agent's record of the terms of such telephonic notice shall be conclusive absent manifest error.

Section 2.09 Fees.

(a) <u>Unused Fees</u>. The Borrower agrees to pay to the Administrative Agent, for the ratable benefit of each Lender based upon each such Lender's Revolving Facility Percentage, as consideration for the Revolving Commitments of the Lenders, unused fees (the "<u>Unused Fees</u>") for the period from the Closing Date to, but not including, the Termination Date, computed for each day at a rate per annum equal to (A) 1.50% times (B) the Total Revolving Commitment in effect on such day minus the Total Revolving Facility Usage as of such day. Accrued Unused Fees shall be due and payable in arrears on the first Business Day after the last Business Day of each March, June, September and December and on the Termination Date, commencing on the first Business Day of the first full calendar quarter after the Closing Date. For the avoidance of doubt, for purposes of computing Unused Fees, a Revolving Commitment of a Lender shall be deemed to be used to the extent of the outstanding Revolving Loans of such Lender.

(b) <u>Commitment Fee</u>. The Borrower agrees to pay to the Administrative Agent, a commitment fee (the "<u>Commitment Fee</u>") in the amount of \$300,000, payable on the Closing Date. The first \$60,000 of the Commitment Fee shall be payable to the Administrative Agent as an arranger fee. The remaining Commitment Fee shall be for the ratable benefit of each Lender pro rata on the basis of their respective Revolving Commitments,

(c) <u>Administrative Agent Fees</u>. The Borrower shall pay to the Administrative Agent, on the Closing Date, for its own account, an agent's fee of \$100,000.

(d) <u>Computations and Determination of Fees</u>. All computations of Unused Fees and other Fees hereunder shall be made on the actual number of days elapsed over a year of 360 days.

Section 2.10 <u>Termination and Reduction of Revolving Commitments</u>.

(a) <u>Mandatory Termination of Revolving Commitments</u>. All of the Revolving Commitments shall terminate on the Termination Date.

(b) <u>Voluntary Termination of the Total Revolving Commitment</u>. Upon at least three Business Days' prior irrevocable written notice (or telephonic notice confirmed in writing) to the Administrative Agent at its Notice Office, with a copy to Sally C. Barton, 127 Public Square, Cleveland, OH 44114 (which notice the Administrative Agent shall promptly transmit to each of the Lenders), the Borrower shall have the right to terminate in whole the Total Revolving Commitment, provided that all outstanding Revolving Loans are contemporaneously prepaid in accordance with <u>Section 2.11</u>.

(c) <u>Partial Reduction of Total Revolving Commitment</u>. Upon at least three Business Days' prior irrevocable written notice (or telephonic notice confirmed in writing) to the Administrative Agent at its Notice Office, with a copy to Sally C. Barton, 127 Public Square, Cleveland, OH 44114 (which notice the Administrative Agent shall promptly transmit to each of the Lenders), the Borrower shall have the right to partially and permanently reduce the Unused Total Revolving Commitment; provided that, (i) any such reduction shall apply to proportionately (based on each Lender's Revolving Facility Percentage) and permanently reduce the Revolving Commitment of each Lender and (ii) no such reduction shall be permitted if the Borrower would be required to make a mandatory prepayment of Loans pursuant to <u>Section 2.11(b)(ii)</u> or (iii), and any partial reduction shall be in the amount of at least \$1,000,000 (or, if greater, in integral multiples of \$500,000).

Section 2.11 Voluntary, Scheduled and Mandatory Prepayments of Loans.

(a) <u>Voluntary Prepayments</u>. The Borrower shall have the right to prepay any of the Loans owing by it, in whole or in part, without premium or penalty, except as specified in subparts (c) and (d) below, from time to time. The Borrower shall give the Administrative Agent at the Notice Office written or telephonic notice (in the case of telephonic notice, promptly confirmed in writing if so requested by the Administrative Agent) of its intent to prepay the Loans, the amount of such prepayment and (in the case of Eurodollar Loans) the specific Borrowing(s) pursuant to which the prepayment is to be made, which notice shall be received by the Administrative Agent by (y) 11:00 A.M. (local time at the Notice Office) three (3) Business Days prior to the date of such prepayment, in the case of any prepayment of Eurodollar Loans, or (z) 11:00 A.M. (local time at the Notice Office) one Business Day prior to the date of such prepayment, in the case of any prepayment of Base Rate Loans, and which notice shall promptly be transmitted by the Administrative Agent to each of the affected Lenders, provided that:

(i) each partial prepayment shall be in an aggregate principal amount of at least (A) in the case of any prepayment of a Eurodollar Loan, \$500,000 (or, if less, the full amount of such Borrowing), or an integral multiple of \$100,000 and (B) in the case of any prepayment of a Base Rate Loan, \$100,000 (or, if less, the full amount of such Borrowing), or an integral multiple of \$50,000;

(ii) no partial prepayment of any Loans made pursuant to a Borrowing shall reduce the aggregate principal amount of such Loans outstanding pursuant to such Borrowing to an amount less than the Minimum Borrowing Amount applicable thereto; and

(iii) in the case of any voluntary prepayment of Term Loans, such prepayment shall be applied in the manner directed by the Borrower.

(b) <u>Mandatory Payments</u>. The Loans shall be subject to mandatory repayment or prepayment (in the case of any partial prepayment conforming to the requirements as to the amounts of partial prepayments set forth in <u>Section 2.11(a)</u> above) in accordance with the following provisions:

(i) <u>Revolving Facility Termination Date</u>. The entire principal amount of all outstanding Revolving Loans shall be repaid in full on the Termination Date.

(ii) Loans Exceed the Commitments. If on any date (after giving effect to any other payments on such date) (A) the Aggregate Credit Facility Exposure exceeds the Total Credit Facility Amount, (B) the Revolving Facility Exposure of any Lender exceeds such Lender's Revolving Commitment or (C) the Aggregate Revolving Facility Exposure exceeds the Total Revolving Commitment, then, in the case of each of the foregoing, the Borrower shall, on such day, prepay on such date the principal amount of Loans in an aggregate amount at least equal to such excess.

(iii) <u>Term Loan Maturity Date</u>. The entire principal amount of all outstanding Term Loans shall be repaid in full on the Termination Date.

(iv) <u>Proceeds of Asset Sales</u>. Subject to the terms of the Orders, in the event of any Asset Sale with respect to any asset of any of the Credit Parties, to the extent not directly paid to the Administrative Agent, promptly (and in any event not later than the next Business Day following the receipt of the Net Cash Proceeds of such Asset Sale), an amount equal to 100% of the Net Cash Proceeds from such Asset Sale shall be applied as a mandatory prepayment of the Loans in accordance with <u>Section 2.11(c)</u> below.

(v) <u>Certain Proceeds of an Event of Loss</u>. Subject to the terms of the Orders, if any Event of Loss with respect to any property of any of the Credit Parties occurs, promptly (and in any event not later than the third Business Day following the date of receipt of the Net Cash Proceeds of such Event of Loss) an amount equal to 100% of the Net Cash Proceeds from such Event of Loss shall be applied as a mandatory prepayment of the Loans in accordance with <u>Section 2.11(c)</u> below.

(c) <u>Applications of Certain Prepayment Proceeds</u>. Each prepayment required to be made pursuant to <u>Section 2.11(b)(iv)</u> or (v) above shall be applied as a mandatory prepayment of principal of first, the outstanding Term Loans, and second, after no Term Loans are outstanding, the outstanding Revolving Loans (but without any corresponding reduction in Revolving Commitments).

(d) <u>Particular Loans to be Prepaid</u>. With respect to each repayment or prepayment of Loans made or required by this Section, the Borrower shall designate the Types of Loans that are to be repaid or prepaid and the specific Borrowing(s) pursuant to which such repayment or prepayment is to be made; provided that, (i) the Borrower shall first so designate all Loans that are Base Rate Loans and Eurodollar Loans with Interest Periods ending on the date of repayment or prepayment prior to designating any other Eurodollar Loans for repayment or prepayment, and (ii) if the outstanding principal amount of Eurodollar Loans made pursuant to a Borrowing is reduced below the applicable Minimum Borrowing Amount as a result of any such repayment or prepayment, then all the Loans outstanding pursuant to such Borrowing shall, in the case of Eurodollar Loans, be Converted into Base Rate Loans. In the absence of a designation by the Borrower as described in the preceding sentence, the Administrative Agent shall, subject to the above, make such designation in its sole discretion with a view, but no obligation, to minimize breakage costs owing under <u>Article III</u>.

(e) <u>Breakage and Other Compensation</u>. Any prepayment made pursuant to this <u>Section 2.11</u> shall be accompanied by any amounts payable in respect thereof under <u>ARTICLE III</u> hereof.

Section 2.12 <u>Method and Place of Payment</u>.

(a) <u>Generally</u>. All payments made by the Borrower hereunder under any Note or any other Loan Document shall be made without setoff, counterclaim or other defense.

(b) <u>Application of Payments</u>. Except as specifically set forth elsewhere in this Agreement and subject to <u>Section 8.03</u>, (i) all payments and prepayments of Revolving Loans shall be applied by the Administrative Agent on a pro rata basis based upon each Lender's Revolving Facility Percentage of the amount of such prepayment and (ii) all payments and prepayments of Term Loans shall be applied by the Administrative Agent to reduce the principal amount of the Term Loans made by each Lender with a Term Commitment, pro rata on the basis of their respective Term Commitments.

(c) <u>Payment of Obligations</u>. Except as specifically set forth elsewhere in this Agreement, all payments under this Agreement with respect to any of the Obligations shall be made to the Administrative Agent on the date when due and shall be made at the Payment Office in immediately available funds and, except as set forth in the next sentence, shall be made in Dollars.

(d) <u>Timing of Payments</u>. Any payments under this Agreement that are made later than 11:00 A.M. (local time at the Payment Office) shall be deemed to have been made on the next succeeding Business Day. Whenever any payment to be made hereunder shall be stated to be due on a day that is not a Business Day, the due date thereof shall be extended to the next succeeding Business Day and, with respect to payments of principal, interest shall be payable during such extension at the applicable rate in effect immediately prior to such extension.

(e) <u>Distribution to Lenders</u>. Upon the Administrative Agent's receipt of payments hereunder, the Administrative Agent shall immediately distribute to each Lender its ratable share, if any, of the amount of principal, interest, and Fees received by it for the account of such Lender. Payments received by the Administrative Agent in Dollars shall be delivered to the Lenders in Dollars in immediately available funds; provided that, if at any time insufficient funds are received by and available to the Administrative Agent to pay fully all amounts of principal, interest and Fees then due hereunder then, except as specifically set forth elsewhere in this Agreement and subject to <u>Section 8.03</u>, such funds shall be applied, first, towards payment of interest and Fees then due hereunder, ratably among the parties entitled thereto in accordance with the amounts of interest and Fees then due to such parties, and second, towards payment of principal then due hereunder, ratably among the parties entitled thereto in accordance with the amounts of interest.

Section 2.13 <u>Defaulting Lenders</u>.

(a) <u>Defaulting Lender Adjustments</u>. Notwithstanding anything to the contrary contained in this Agreement, if any Lender becomes a Defaulting Lender, then, until such time as such Lender is no longer a Defaulting Lender, to the extent permitted by applicable law:

(i) <u>Waivers and Amendments</u>. Such Defaulting Lender's right to approve or disapprove any amendment, waiver or consent with respect to this Agreement shall be restricted as set forth in the definition of Required Lenders.

(ii) <u>Defaulting Lender Waterfall</u>. Any payment of principal, interest, fees or other amounts received by the Administrative Agent for the account of such Defaulting Lender (whether voluntary or mandatory, at maturity, pursuant to <u>Article VIII</u> or otherwise) or received by the Administrative Agent from a Defaulting Lender pursuant to <u>Section 11.03</u> shall be applied at such time or times as may be determined by the Administrative Agent as follows: first, to the payment of any amounts owing by such Defaulting Lender to the Administrative Agent hereunder; second, as the Borrower may request (so long as no Default or Event of Default exists), to the funding of any Loan in respect of which such Defaulting Lender has failed to fund its portion thereof as required by this Agreement, as determined by the Administrative Agent; third, if so determined by the Administrative Agent and the Borrower, to be held in a deposit account and released pro rata in order to satisfy such Defaulting Lender's potential future funding obligations with respect to Loans under this Agreement; fourth, to the payment of any amounts owing to the Lenders as a result of any judgment of a court of competent jurisdiction obtained by any Lender against such Defaulting Lender as a result of such Defaulting Lender's breach of its obligations under this Agreement; fifth, so long as no Default or Event of Default exists, to the payment of any amounts owing to the Borrower as a result of any judgment of a court of competent jurisdiction obtained by the Borrower against such Defaulting Lender as a result of such Defaulting Lender's breach of its obligations under this Agreement; and sixth, to such Defaulting Lender or as otherwise directed by a court of competent jurisdiction; provided that if such Loans were made at a time when the conditions set forth in Section 4.02 were satisfied or waived, such payment shall be applied solely to pay the Loans of all Non-Defaulting Lenders on a pro rata basis prior to being applied to the payment of any Loans of such Defaulting Lender until such time as all Loans are held by the Lenders pro rata in accordance with the Commitments under the applicable Credit Facilities. Any payments, prepayments or other amounts paid or payable to a Defaulting Lender that are applied (or held) to pay amounts owed by a Defaulting Lender shall be deemed paid to and redirected by such Defaulting Lender, and each Lender irrevocably consents hereto.

(iii) <u>Certain Fees</u>. No Defaulting Lender shall be entitled to receive any Unused Fee for any period during which that Lender is a Defaulting Lender (and the Borrower shall not be required to pay any such fee that otherwise would have been required to have been paid to that Defaulting Lender).

(b) <u>Defaulting Lender Cure</u>. If the Borrower and the Administrative Agent agree in writing that a Lender is no longer a Defaulting Lender, the Administrative Agent will so notify the parties hereto, whereupon as of the effective date specified in such notice and subject to any conditions set forth therein, that Lender will, to the extent applicable, purchase at par that portion of outstanding Loans of the other Lenders or take such other actions as the Administrative Agent may determine to be necessary to cause the Loans to be held pro rata by the Lenders in accordance with the Commitments under the applicable Credit Facility, whereupon such Lender will cease to be a Defaulting Lender; provided that no adjustments will be made retroactively with respect to fees accrued or payments made by or on behalf of the Borrower while that Lender was a Defaulting Lender; and provided, further, that except to the extent otherwise expressly agreed by the affected parties, no change hereunder from Defaulting Lender to Lender will constitute a waiver or release of any claim of any party hereunder arising from that Lender's having been a Defaulting Lender.

Section 2.14 [Reserved].

Section 2.15 Status of Obligations; Perfection and Priority of Security Interests.

(a) <u>Superpriority Claims</u>. The Obligations are, subject to the Carve-Out and the Orders, pursuant to Section 364(c)(1) of the Bankruptcy Code, entitled (without the need to file a proof of claim) to a joint and several superpriority claim against the Debtors, with priority over any and all other obligations, liabilities, and indebtedness against the Debtors, now existing or hereafter arising, of any kind whatsoever, including any and all administrative expenses or other claims of the kind specified in or arising under Sections 105, 326, 328, 330, 331, 503(b), 506(c) (following entry of the Final Order), 507, 546(c), 552(b), 726, 1113, or 1114 of the Bankruptcy Code, whether or not such expenses or claims may become secured by a judgment lien or other non-consensual lien, levy, or attachment, whether now in existence or hereafter incurred by the Debtors, and shall at all times be senior to the rights of the Debtors, each Debtor's estate and any successor trustee, estate representative, or any creditor, in any of the Chapter 11 Cases or any subsequent cases or proceedings under the Bankruptcy Code (the "Lender Superpriority

<u>Claim</u>"), and the Lender Superpriority Claim shall have recourse to and be payable from all prepetition and postpetition assets of the Debtors, including, but not limited to, the Collateral; Lender Superpriority Claim in respect of the Revolving Commitments shall be senior and have priority to Lender Superpriority Claims in respect of the Term Loans.

(b) <u>Lien on Unencumbered Assets</u>. The Obligations are, subject to the Carve-Out and the Orders, pursuant to Section 364(c)(2) of the Bankruptcy Code, secured by a perfected first priority lien on all Collateral that is not subject to valid, perfected, and non-avoidable liens as of the Petition Date and such liens are perfected without the necessity of the execution or filing of mortgages, security agreements, pledge agreements, financing statements, or other agreements.

(c) Junior Lien on Certain Encumbered Assets. The Obligations are, subject to the Carve-Out and the Orders, pursuant to Section 364(c)(3) of the Bankruptcy Code, secured by a perfected lien on all Collateral (other than Collateral described in <u>Section 2.15(b)</u> or <u>Section 2.15(d)</u>, as to which the liens in favor of the Administrative Agent are as described in such Sections) that is subject to valid and non-avoidable liens as of the Petition Date that were permitted pursuant to the terms of the Prepetition Credit Agreement or (with respect to statutory liens) applicable laws and which were senior to the liens under the Prepetition Credit Agreement and which were either perfected as of the Petition Date or subsequently perfected pursuant to Section 546(b) of the Bankruptcy Code, which liens are junior to such valid, perfected, and non-avoidable liens and are perfected without the necessity of the execution or filing of mortgages, security agreements, pledge agreements, financing agreements, or other agreements.

(d) <u>Priming Lien on Certain Encumbered Assets</u>. The Obligations are, subject to the Carve-Out and the Orders, pursuant to Section 364(d)(1) of the Bankruptcy Code, secured by a perfected first priority, senior priming lien on all the Collateral on which (i) liens were granted as security for the obligations under or in connection with the Prepetition Credit Agreement, or (ii) liens were granted as of the Petition Date that were not permitted pursuant to the terms of the Prepetition Credit Agreement or (with respect to statutory liens) applicable law, all of which existing liens, rights, and interests (the "<u>Primed Liens</u>") shall be primed by and made subject and subordinate to the perfected first priority senior lien to be granted to the Administrative Agent for its and the Lenders' benefit (the "<u>Priming Lien</u>"), which Priming Lien also primes any liens granted after the Petition Date to provide adequate protection in respect of any of the Primed Liens, and such liens are perfected without necessity of the execution or filing of mortgages, security agreements, pledge agreements, financing statements, or other agreements. For the avoidance of doubt, notwithstanding <u>Section 2.15(c)</u>, the Priming Lien primes and is senior to the Primed Liens.

(e) The priorities set forth above are subject, in each case, only to the Carve-Out. All of the liens and security interests described in <u>Section 2.15</u> shall be effective and perfected as of the date that the Bankruptcy Court enters the Final Order, without the necessity of the execution of mortgages, security agreements, pledge agreements, financing statements, or other agreements or documents. The Debtors shall execute and deliver to the Administrative Agent (for recordation or filing, as appropriate) such mortgages and pledges (and other security instruments), and be authorized pursuant to the Orders to file such financing statements and other instruments and documents, as shall be advisable (as reasonably determined by Administrative Agent) to evidence and secure the Obligations. The cost of such recordation and filing shall be set forth in the Budget.

ARTICLE III

INCREASED COSTS, ILLEGALITY AND TAXES

Section 3.01 Increased Costs, Illegality, etc.

(a) In the event that (y) in the case of clause (i) below, the Administrative Agent or (z) in the case of clauses (ii) and (iii) below, any Lender or other Recipient, shall have determined on a reasonable basis (which determination shall, absent manifest error, be final and conclusive and binding upon all parties hereto):

(i) on any date for determining the interest rate applicable to any Eurodollar Loan for any Interest Period that, by reason of any changes arising after the Closing Date, adequate and fair means do not exist for ascertaining the applicable interest rate on the basis provided for in this Agreement for such Eurodollar Loan; or

(ii) at any time, that such Lender or other Recipient shall incur increased costs or reductions in the amounts received or receivable by it hereunder in an amount that such Lender or other Recipient deems material with respect to any Eurodollar Loans (other than any increased cost or reduction in the amount received or receivable resulting from the imposition of or a change in the rate of any Connection Income Taxes) because of (x) any Change in Law since the Closing Date (including, but not limited to, a change in requirements for any reserve, special deposit, liquidity or similar requirements (including any compulsory loan requirement, insurance charge or other assessment) against assets of, deposits with or for the account of, or credit extended by, any Lender or other Recipient, but, in all events, excluding reserves already includable in the interest rate applicable to such Eurodollar Loan pursuant to this Agreement) or (y) other circumstances adversely affecting the London interbank market or the position of such Lender or other Recipient in any such market; or

(iii) at any time, that the making or continuance of any Eurodollar Loan has become unlawful by compliance by such Lender in good faith with any Change in Law since the Closing Date, or would conflict with any thereof not having the force of law but with which such Lender customarily complies, or has become impracticable as a result of a contingency occurring after the Closing Date that materially adversely affects the London interbank market;

then, and in each such event, such Lender or other Recipient (or the Administrative Agent in the case of clause (i) above) shall (1) on or promptly following such date or time and (2) within 10 Business Days of the date on which such event no longer exists give notice (by telephone confirmed in writing) to the Borrower and to the Administrative Agent of such determination (which notice the Administrative Agent shall promptly transmit to each of the other Lenders or other Recipients). Thereafter (x) in the case of clause (i) above, the affected Type of Eurodollar Loans shall no longer be available until such time as the Administrative Agent notifies the Borrower and the Lenders or other Recipients that the circumstances giving rise to such notice by the Administrative Agent no longer exist, and any Notice of Borrowing or Notice of Continuation or Conversion given by the Borrower with respect to such Type of Eurodollar Loans that have not yet been incurred, Converted or Continued shall be deemed rescinded by the Borrower or, in the case of a Notice of Borrowing, shall, at the option of the Borrower, be deemed converted into a Notice of Borrowing for Base Rate Loans to be made on the date of Borrowing contained in such Notice of Borrowing, (y) in the case of clause (ii) above, the Borrower shall pay to such Lender or other Recipient, upon written demand therefor, such additional amounts (in the form of an increased rate of, or a different method of calculating, interest or otherwise as such Lender or other Recipient shall determine) as shall be required to compensate such Lender or other Recipient for such increased costs or reductions in amounts receivable hereunder (a written notice as to the additional amounts owed to such Lender or other Recipient, showing the basis for the calculation thereof, which basis must be reasonable, submitted to the Borrower by such Lender or other Recipient shall, absent manifest error, be final and conclusive and binding upon all parties hereto) and (z) in the case of clause (iii) above, the Borrower shall take one of the actions specified in Section 3.01(b) as promptly as possible and, in any event, within the time period required by law.

(b) At any time that any Eurodollar Loan is affected by the circumstances described in <u>Section 3.01(a)(ii)</u> or (iii), the Borrower may (and in the case of a Eurodollar Loan affected pursuant to <u>Section 3.01(a)(iii)</u> the Borrower shall) either (i) if the affected Eurodollar Loan is then being made pursuant to a Borrowing, by giving the Administrative Agent telephonic notice (confirmed promptly in writing) thereof on the same date that the Borrower was notified by a Lender or other Recipient pursuant to <u>Section 3.01(a)(ii)</u> or (iii), cancel said Borrowing, or, in the case of any Borrowing, convert the related Notice of Borrowing into one requesting a Borrowing of Base Rate Loans or require the affected Lender or other Recipient to make its requested Loan as a Base Rate Loan, or (ii) if the affected Eurodollar Loan is then outstanding, upon at least one Business Days' notice to the Administrative Agent, require the affected Lender or other Recipient to Convert each such Eurodollar Loan into a Base Rate Loan; provided that, if more than one Lender or other Recipient is affected at any time, then all affected Lenders or other Recipients must be treated the same pursuant to this <u>Section 3.01(b)</u>.

If any Lender shall have determined that after the Closing Date, any Change in (c) Law regarding capital adequacy by any Governmental Authority, central bank or comparable agency charged by law with the interpretation or administration thereof, or compliance by such Lender or its parent corporation with any request or directive regarding capital adequacy (whether or not having the force of law) of any such authority, central bank, or comparable agency, in each case made subsequent to the Closing Date, has or would have the effect of reducing by an amount reasonably deemed by such Lender to be material to the rate of return on such Lender's or its parent corporation's capital or assets as a consequence of such Lender's commitments or obligations hereunder to a level below that which such Lender or its parent corporation could have achieved but for such adoption, effectiveness, change or compliance (taking into consideration such Lender's or its parent corporation's policies with respect to capital adequacy), then from time to time, within 15 days after demand by such Lender (with a copy to the Administrative Agent), the Borrower shall pay to such Lender such additional amount or amounts as will compensate such Lender or its parent corporation for such reduction. Each Lender, upon determining in good faith that any additional amounts will be payable pursuant to this Section 3.01(c), will give prompt written notice thereof to the Borrower, which notice shall set forth, in reasonable detail, the basis of the calculation of such additional amounts, which basis must be reasonable, although the failure to give any such notice shall not release or diminish any of the Borrower's obligations to pay additional amounts pursuant to this Section 3.01(c) upon the subsequent receipt of such notice.

(d) Notwithstanding anything in this Agreement to the contrary, (i) no Lender shall be entitled to compensation or payment or reimbursement of other amounts under <u>Section 3.01</u> or <u>Section 3.04</u> for any amounts incurred or accruing more than 90 days prior to the giving of notice to the Borrower of additional costs or other amounts of the nature described in such Sections, and (ii) no Lender shall demand compensation for any reduction referred to in <u>Section 3.01(c)</u> or payment or reimbursement of other amounts under <u>Section 3.04</u> if it shall not at the time be the general policy or practice of such Lender to demand such compensation, payment or reimbursement in similar circumstances under comparable provisions of other credit agreements.

Section 3.02 Breakage Compensation. The Borrower shall compensate each Lender, upon its written request (which request shall set forth the detailed basis for requesting and the method of calculating such compensation), for all reasonable losses, costs, expenses and liabilities (including, without limitation, any loss, cost, expense or liability incurred by reason of the liquidation or reemployment of deposits or other funds required by such Lender to fund its Eurodollar Loans) which such Lender may sustain in connection with any of the following: (i) if for any reason (other than a default by such Lender or the Administrative Agent) a Borrowing of Eurodollar Loans does not occur on a date specified therefor in a Notice of Borrowing or a Notice of Continuation or Conversion (whether or not withdrawn by the Borrower or deemed withdrawn pursuant to <u>Section 3.01(a)</u>); (ii) if any repayment, prepayment, Conversion or Continuation of any Eurodollar Loan occurs on a date that is not the last day

of an Interest Period applicable thereto; (iii) if any prepayment of any of its Eurodollar Loans is not made on any date specified in a notice of prepayment given by the Borrower; (iv) as a result of an assignment by a Lender of any Eurodollar Loan other than on the last day of the Interest Period applicable thereto pursuant to a request by the Borrower pursuant to <u>Section 3.04(b)</u>; or (v) as a consequence of (y) any other default by the Borrower to repay or prepay any Eurodollar Loans when required by the terms of this Agreement or (z) an election made pursuant to <u>Section 3.04(b)</u>. The written request of any Lender setting forth any amount or amounts that such Lender is entitled to receive pursuant to this Section shall be delivered to the Borrower and shall be conclusive absent manifest error. The Borrower shall pay such Lender the amount shown as due on any such request within 10 days after receipt thereof.

Section 3.03 <u>Net Payments</u>.

(a) <u>Defined Terms</u>. For purposes of this <u>Section 3.03</u>, the term "applicable law" includes FATCA.

(b) Payments Free of Taxes. Any and all payments by or on account of any obligation of any Credit Party under any Loan Document shall be made without deduction or withholding for any Taxes, except as required by applicable law. If any applicable law (as determined in the good faith discretion of an applicable Withholding Agent) requires the deduction or withholding of any Tax from any such payment by a Withholding Agent, then the applicable Withholding Agent shall be entitled to make such deduction or withholding and shall timely pay the full amount deducted or withheld to the relevant Governmental Authority in accordance with applicable law and, if such Tax is an Indemnified Tax, then the sum payable by the applicable Credit Party shall be increased as necessary so that after such deduction or withholding has been made (including such deductions and withholdings applicable to additional sums payable under this Section) the applicable Recipient receives an amount equal to the sum it would have received had no such deduction or withholding been made.

(c) <u>Payment of Other Taxes by the Borrower</u>. The Credit Parties shall timely pay to the relevant Governmental Authority in accordance with applicable law, or at the option of the Administrative Agent timely reimburse it for the payment of, any Other Taxes.

(d) <u>Indemnification by the Borrower</u>. The Credit Parties shall jointly and severally indemnify each Recipient, within 10 days after demand therefor, for the full amount of any Indemnified Taxes (including Indemnified Taxes imposed or asserted on or attributable to amounts payable under this Section) payable or paid by such Recipient or required to be withheld or deducted from a payment to such Recipient and any reasonable expenses arising therefrom or with respect thereto, whether or not such Indemnified Taxes were correctly or legally imposed or asserted by the relevant Governmental Authority. A certificate as to the amount of such payment or liability delivered to the Borrower by a Lender (with a copy to the Administrative Agent), or by the Administrative Agent on its own behalf or on behalf of a Lender, shall be conclusive absent manifest error.

(e) Indemnification by the Lenders. Each Lender shall severally indemnify the Administrative Agent, within 10 days after demand therefor, for (i) any Indemnified Taxes attributable to such Lender (but only to the extent that any Credit Party has not already indemnified the Administrative Agent for such Indemnified Taxes and without limiting the obligation of the Credit Parties to do so), (ii) any Taxes attributable to such Lender's failure to comply with the provisions of Section 11.06(b) relating to the maintenance of a Participant Register and (iii) any Excluded Taxes attributable to such Lender, in each case, that are payable or paid by the Administrative Agent in connection with any Loan Document, and any reasonable expenses arising therefrom or with respect thereto, whether or not such Taxes were correctly or legally imposed or asserted by the relevant Governmental Authority. A certificate as to the amount of such payment or liability delivered to any Lender by the Administrative Agent shall

be conclusive absent manifest error. Each Lender hereby authorizes the Administrative Agent to set off and apply any and all amounts at any time owing to such Lender under any Loan Document or otherwise payable by the Administrative Agent to the Lender from any other source against any amount due to the Administrative Agent under this paragraph (e).

(f) <u>Evidence of Payments</u>. As soon as practicable after any payment of Taxes by any Credit Party to a Governmental Authority pursuant to this <u>Section 3.03</u>, such Credit Party shall deliver to the Administrative Agent the original or a certified copy of a receipt issued by such Governmental Authority evidencing such payment, a copy of the return reporting such payment or other evidence of such payment reasonably satisfactory to the Administrative Agent.

(g) <u>Status of Lenders</u>.

(i) Any Lender that is entitled to an exemption from or reduction of withholding Tax with respect to payments made under any Loan Document shall deliver to the Borrower and the Administrative Agent, at the time or times reasonably requested by the Borrower or the Administrative Agent, such properly completed and executed documentation reasonably requested by the Borrower or the Administrative Agent as will permit such payments to be made without withholding or at a reduced rate of withholding. In addition, any Lender, if reasonably requested by the Borrower or the Administrative Agent, shall deliver such other documentation prescribed by applicable law or reasonably requested by the Borrower or the Administrative Agent as will enable the Borrower or the Administrative Agent to determine whether or not such Lender is subject to backup withholding or information reporting requirements. Notwithstanding anything to the contrary in the preceding two sentences, the completion, execution and submission of such documentation (other than such documentation set forth in Section 3.03(g)(ii)(A), (ii)(B) and (ii)(D) below) shall not be required if in the Lender's reasonable judgment such completion, execution or submission would subject such Lender to any material unreimbursed cost or expense or would materially prejudice the legal or commercial position of such Lender.

(ii) Without limiting the generality of the foregoing, in the event that the Borrower is a U.S. Borrower,

(A) any Lender that is a U.S. Person shall deliver to the Borrower and the Administrative Agent on or prior to the date on which such Lender becomes a Lender under this Agreement (and from time to time thereafter upon the reasonable request of the Borrower or the Administrative Agent), executed originals of IRS Form W-9 (or successor form) certifying that such Lender is exempt from U.S. federal backup withholding Tax;

(B) any Foreign Lender shall, to the extent it is legally entitled to do so, deliver to the Borrower and the Administrative Agent (in such number of copies as shall be requested by the recipient) on or prior to the date on which such Foreign Lender becomes a Lender under this Agreement (and from time to time thereafter upon the reasonable request of the Borrower or the Administrative Agent), whichever of the following is applicable:

(1) in the case of a Foreign Lender claiming the benefits of an income tax treaty to which the United States is a party (x) with respect to payments of interest under any Loan Document, executed originals of IRS Form W-8BEN or W-8BEN-E, as applicable, (or successor form) establishing an

exemption from, or reduction of, U.S. federal withholding Tax pursuant to the "interest" article of such tax treaty and (y) with respect to any other applicable payments under any Loan Document, IRS Form W-8BEN or W-8BEN-E, as applicable, (as successor form) establishing an exemption from, or reduction of, U.S. federal withholding Tax pursuant to the "business profits" or "other income" article of such tax treaty;

(2) executed originals of IRS Form W-8ECI (or successor form);

(3) in the case of a Foreign Lender claiming the benefits of the exemption for portfolio interest under Section 881(c) of the Code, (x) a certificate substantially in the form of <u>Exhibit K-1</u> to the effect that such Foreign Lender is not a "bank" within the meaning of Section 881(c)(3)(A) of the Code, a "10 percent shareholder" of the Borrower within the meaning of Section 881(c)(3)(B) of the Code, or a "controlled foreign corporation" described in Section 881(c)(3)(C) of the Code (a "<u>U.S. Tax Compliance Certificate</u>") and (y) executed originals of IRS Form W-8BEN or W-8BEN-E, as applicable (or successor form); or

(4) to the extent a Foreign Lender is not the beneficial owner, executed originals of IRS Form W-8IMY (or successor form), accompanied by IRS Form W-8ECI, IRS Form W-8BEN, W-8BEN-E, a U.S. Tax Compliance Certificate substantially in the form of <u>Exhibit K-2</u> or <u>Exhibit K-3</u>, IRS Form W-9, and/or other certification documents from each beneficial owner, as applicable; provided that if the Foreign Lender is a partnership and one or more direct or indirect partners of such Foreign Lender are claiming the portfolio interest exemption, such Foreign Lender may provide a U.S. Tax Compliance Certificate substantially in the form of <u>Exhibit K-4</u> on behalf of each such direct and indirect partner;

(C) any Foreign Lender shall, to the extent it is legally entitled to do so, deliver to the Borrower and the Administrative Agent (in such number of copies as shall be requested by the recipient) on or prior to the date on which such Foreign Lender becomes a Lender under this Agreement (and from time to time thereafter upon the reasonable request of the Borrower or the Administrative Agent), executed originals of any other form prescribed by applicable law as a basis for claiming exemption from or a reduction in U.S. federal withholding Tax, duly completed, together with such supplementary documentation as may be prescribed by applicable law to permit the Borrower or the Administrative Agent to determine the withholding or deduction required to be made; and

(D) if a payment made to a Lender under any Loan Document would be subject to U.S. federal withholding Tax imposed by FATCA if such Lender were to fail to comply with the applicable reporting requirements of FATCA (including those contained in Section 1471(b) or 1472(b) of the Code, as applicable), such Lender shall deliver to the Borrower and the Administrative Agent at the time or times prescribed by law and at such time or times reasonably requested by the Borrower or the Administrative Agent such documentation prescribed by applicable law (including as prescribed by Section 1471(b)(3)(C)(i) of the Code) and such additional documentation reasonably requested by the Borrower or the Administrative Agent as may be necessary for the Borrower and the Administrative Agent to comply with their obligations under FATCA and to determine that such Lender has complied with such Lender's obligations under FATCA or to determine the amount to deduct and withhold from such payment. Solely for purposes of this clause (D), "FATCA" shall include any amendments made to FATCA after the date of this Agreement.

Each Lender agrees that if any form or certification it previously delivered expires or becomes obsolete or inaccurate in any respect, it shall update such form or certification or promptly notify the Borrower and the Administrative Agent in writing of its legal inability to do so.

Treatment of Certain Refunds. If any party determines, in its sole discretion (h) exercised in good faith, that it has received a refund of any Taxes as to which it has been indemnified pursuant to this Section 3.03 (including by the payment of additional amounts pursuant to this Section 3.03), it shall pay to the indemnifying party an amount equal to such refund (but only to the extent of indemnity payments made under this Section with respect to the Taxes giving rise to such refund), net of all out-of-pocket expenses (including Taxes) of such indemnified party and without interest (other than any interest paid by the relevant Governmental Authority with respect to such refund). Such indemnifying party, upon the request of such indemnified party, shall repay to such indemnified party the amount paid over pursuant to this paragraph (h) (plus any penalties, interest or other charges imposed by the relevant Governmental Authority) in the event that such indemnified party is required to repay such refund to such Governmental Authority. Notwithstanding anything to the contrary in this paragraph (h), in no event will the indemnified party be required to pay any amount to an indemnifying party pursuant to this paragraph (h) the payment of which would place the indemnified party in a less favorable net after-Tax position than the indemnified party would have been in if the Tax subject to indemnification and giving rise to such refund had not been deducted, withheld or otherwise imposed and the indemnification payments or additional amounts with respect to such Tax had never been paid. This paragraph shall not be construed to require any indemnified party to make available its Tax returns (or any other information relating to its Taxes that it deems confidential) to the indemnifying party or any other Person.

(i) <u>Survival</u>. Each party's obligations under this <u>Section 3.03</u> shall survive the resignation or replacement of the Administrative Agent or any assignment of rights by, or the replacement of, a Lender, the termination of the Commitments and the repayment, satisfaction or discharge of all obligations under any Loan Document.

Section 3.04 Change of Lending Office; Replacement of Lenders.

(a) Each Lender agrees that, upon the occurrence of any event giving rise to the operation of <u>Section 3.01(a)(ii)</u> or (iii), <u>3.01(c)</u> or <u>3.03</u> requiring the payment of additional amounts to the Lender, such Lender will, if requested by the Borrower, use reasonable efforts (subject to overall policy considerations of such Lender) to designate another Applicable Lending Office for any Loans or Commitments affected by such event; provided that, such designation is made on such terms that such Lender and its Applicable Lending Office suffer no economic, legal or regulatory disadvantage, with the object of avoiding the consequence of the event giving rise to the operation of any such Section. The Borrower hereby agrees to pay all reasonable costs and expenses incurred by any Lender in connection with any such designation or assignment.

(b) If (i) any Lender requests any compensation, reimbursement or other payment under Section 3.01(a)(ii) or (iii) or 3.01(c) with respect to such Lender, (ii) the Borrower is, or because of a matter in existence as of the date that the Borrower is seeking to exercise its rights under this Section will be, required to pay any additional amount to any Lender or Governmental Authority pursuant to Section 3.03, or (iii) or if any Lender is a Defaulting Lender, then the Borrower may, at its sole expense and effort, upon notice to such Lender and the Administrative Agent, require such Lender to assign and

delegate, without recourse (in accordance with the restrictions contained in Section 11.06(c)), all its interests, rights and obligations under this Agreement to an Eligible Assignee that shall assume such obligations; provided that, (1) the Borrower shall have received the prior written consent of the Administrative Agent, which consent shall not be unreasonably withheld or delayed, (2) such Lender shall have received payment of an aggregate amount equal to the outstanding principal of its Loans, accrued interest thereon, accrued fees and all other amounts payable to it hereunder, from the assignee (to the extent of such outstanding principal and accrued interest and fees) or the Borrower (in the case of all other amounts, including any breakage compensation under Section 3.02 hereof), and (3) in the case of any such assignment resulting from a claim for compensation, reimbursement or other payments required to be made under Section 3.01(a)(ii) or (iii) or Section 3.01(c) with respect to such Lender, or resulting from any required payments to any Lender or Governmental Authority pursuant to Section 3.03, such assignment will result in a reduction in such compensation, reimbursement or payments. A Lender shall not be required to make any such assignment and delegation if, prior thereto, as a result of a waiver by such Lender or otherwise, the circumstances entitling the Borrower to require such assignment and delegation cease to apply.

(c) Nothing in this <u>Section 3.04</u> shall affect or postpone any of the obligations of the Borrower or the right of any Lender provided in <u>Sections 3.01</u> or <u>3.03</u>.

ARTICLE IV

CONDITIONS PRECEDENT

Section 4.01 <u>Conditions Precedent at Closing Date</u>. The obligation of the Lenders to make Loans is subject to the satisfaction of each of the following conditions on or prior to the Closing Date:

(i) <u>Credit Agreement</u>. This Agreement shall have been executed by the Borrower, the Administrative Agent and each of the Lenders.

(ii) <u>Notes</u>. The Borrower shall have executed and delivered to the Administrative Agent the appropriate Note or Notes for the account of each Lender that has requested the same.

(iii) <u>Guaranty</u>. The Guarantors shall have duly executed and delivered a Guaranty of Payment (the "<u>Guaranty</u>"), substantially in the form attached hereto as <u>Exhibit C</u>.

(iv) <u>Final Order</u>. The Final Order shall have been entered by the Bankruptcy Court in the Chapter 11 Cases and shall have been in form and substance satisfactory to the Administrative Agent and the Required Lenders in their reasonable discretion, and shall be in full force and effect and shall not have been vacated, stayed, revised, modified, or amended in any manner without the prior written consent of the Administrative Agent and the Required Lenders.

(v) <u>Fees</u>. The Borrower shall have (A) paid to the Administrative Agent, for the account of the Lenders, the Commitment Fees required to be paid by it pursuant to <u>Section</u> 2.09(b), (B) paid to the Administrative Agent, for its own account, the fees required to be paid by it on the Closing Date pursuant to <u>Section 2.09(b)</u> and (C) paid or caused to be paid all reasonable fees and expenses of the Administrative Agent and of special counsel to the Administrative Agent that have been invoiced on or prior to the Closing Date in connection with the preparation, execution and delivery of this Agreement and the other Loan Documents and the consummation of the transactions contemplated hereby and thereby.

(vi) <u>Corporate Resolutions and Approvals</u>. The Administrative Agent shall have received certified copies of the resolutions of the Board of Directors (or similar governing body) of each Credit Party approving the Loan Documents to which such Credit Party is or may become a party, and of all documents evidencing other necessary corporate or other organizational action, as the case may be, and governmental and third party consents and approvals, if any, with respect to the execution, delivery and performance by such Credit Party of Loan Transaction (including Hart-Scott Rodino clearance, if applicable) and the Loan Documents to which it is or may become a party and the expiration of all applicable waiting periods, all of which documents to be in form and substance satisfactory to the Administrative Agent.

(vii) <u>Incumbency Certificates</u>. The Administrative Agent shall have received a certificate of the Secretary or an Assistant Secretary of each Credit Party certifying the names and true signatures of the officers of such Credit Party authorized to sign the Loan Documents to which such Credit Party is a party and any other documents to which such Credit Party is a party that may be executed and delivered in connection herewith.

(viii) <u>Evidence of Insurance</u>. The Administrative Agent shall have (A) received certificates of insurance and other evidence satisfactory to it of compliance with the insurance requirements of this Agreement and (B) received endorsements naming the Administrative Agent, for the benefit of the Lenders, as an additional insured on the liability insurance policies of the Credit Parties and as a lenders loss payee on the property insurance policies of the Credit Parties.

(ix) <u>Financial Statements; Budget</u>. The Administrative Agent shall have received (A) the financial statements set forth in <u>Section 5.07</u> and the Budget.

(x) <u>Closing Certificate</u>. The Administrative Agent shall have received a closing certificate in the form attached hereto as <u>Exhibit D</u>, dated as of the Closing Date, and executed by the Borrower.

(xi) <u>Proceedings and Documents</u>. All corporate and other proceedings and all documents incidental to the transactions contemplated hereby shall be satisfactory in substance and form to the Administrative Agent and the Administrative Agent and its special counsel shall have received all such counterpart originals or certified or other copies of such documents as the Administrative Agent or its special counsel may reasonably request.

(xii) <u>Intercompany Subordination Agreement</u>. The Credit Parties shall have duly executed and delivered the Intercompany Subordination Agreement.

(xiii) <u>Refinancing</u>. On the Closing Date, and substantially concurrently with the use of the Term Loans to refinance in part the Term Loans and the Delayed Draw Loans (as such terms are defined in the Pre-Petition Credit Agreement) under the Pre-Petition Credit Agreement on such date, and subject to the Final Order, all commitments under the Pre-Petition Credit Agreement shall have been terminated, and all letters of credit issued pursuant to the Pre-Petition Credit Agreement shall have been terminated and the Administrative Agent shall have received reasonably satisfactory evidence of the same.

(xiv) <u>No Material Adverse Change</u>. As of the Closing Date, no event, change or condition shall have occurred since the Petition Date that has had or could reasonably be expected, either individually or in the aggregate, to have a Material Adverse Effect.

(xv) <u>Patriot Act</u>. The Administrative Agent shall have received, at least five Business Days prior to the Closing Date, all documentation and other information required by regulatory authorities under applicable "know your customer", beneficial ownership and anti-money laundering rules and regulations, including the USA Patriot Act.

(xvi) <u>Notice of Borrowing</u>. The Administrative Agent shall have received a Notice of Borrowing no later than 11:00 a.m. three (3) Business Days in advance of the Closing Date (or such later time or date as the Administrative Agent may agree).

Section 4.02 <u>Conditions Precedent to All Credit Events</u>. Each Credit Event is subject, at the time thereof, to the satisfaction of all conditions set forth in <u>Section 4.01</u> plus the following conditions:

(a) <u>Revolving Credit Exposure</u>. Immediately after giving effect to any such Credit Event, the Aggregate Revolving Facility Exposure shall not exceed the Revolving Availability then in effect;

(b) <u>Notice</u>. The Administrative Agent shall have received, as applicable, (i) a Notice of Borrowing meeting the requirements of <u>Section 2.04(b)</u> with respect to any Borrowing (other than a Continuation or Conversion) or (ii) a Notice of Continuation or Conversion meeting the requirements of <u>Section 2.08(b)</u> with respect to a Continuation or Conversion.

(c) <u>No Default; Representations and Warranties</u>. At the time of each Credit Event and also after giving effect thereto, (i) there shall exist no Default or Event of Default and (ii) all representations and warranties of the Credit Parties contained herein or in the other Loan Documents shall be true and correct in all material respects with the same effect as though such representations and warranties had been made on and as of the date of such Credit Event, except to the extent that such representations and warranties expressly relate to an earlier specified date, in which case such representations and warranties shall have been true and correct in all material respects as of the date when made (except to the extent any such representation or warranty is qualified by "materiality or "Material Adverse Effect" or a similar term, in which case such representation and warranty shall be true and correct in all respects).

The acceptance of the benefits of (i) the Credit Events on the Closing Date shall constitute a representation and warranty by the Borrower to the Administrative Agent and each of the Lenders that all of the applicable conditions specified in <u>Section 4.01</u> have been satisfied as of the times referred to in such Section and (ii) each Credit Event thereafter shall constitute a representation and warranty by the Borrower to the Administrative Agent and each of the Lenders that all of the applicable conditions specified in <u>Section 4.01</u> have been satisfied as of the times referred to in such Section 4.02 have been satisfied as of the times referred to in such Section.

ARTICLE V

REPRESENTATIONS AND WARRANTIES

In order to induce the Administrative Agent and the Lenders to enter into this Agreement and to make the Loans provided for herein, subject to the entry of the Orders and the terms thereof, the Borrower makes the following representations and warranties to the Administrative Agent and the Lenders, all of which shall survive the execution and delivery of this Agreement and each Credit Event:

Section 5.01 <u>Corporate Status</u>. Each Credit Party (i) is a duly organized or formed and validly existing corporation, partnership or limited liability company, as the case may be, in good standing or in full force and effect under the laws of the jurisdiction of its formation and has the corporate, partnership

or limited liability company power and authority, as applicable, to own its property and assets and to transact the business in which it is engaged and presently proposes to engage, and (ii) has duly qualified and is authorized to do business in all jurisdictions where it is required to be so qualified or authorized except where the failure to be so qualified would not have a Material Adverse Effect.

Section 5.02 <u>Corporate Power and Authority</u>. (a) Each Credit Party has the corporate or other organizational power and authority to execute, deliver and carry out the terms and provisions of the Loan Documents to which it is party and has taken all necessary corporate or other organizational action to authorize the execution, delivery and performance of the Loan Documents to which it is party and (b) each Credit Party has duly executed and delivered each Loan Document to which it is party and each Loan Document to which it is party constitutes the legal, valid and binding agreement and obligation of such Credit Party enforceable in accordance with its terms, except to the extent that the enforceability thereof may be limited by applicable bankruptcy, insolvency, reorganization, moratorium or other similar laws generally affecting creditors' rights and by equitable principles (regardless of whether enforcement is sought in equity or at law).

Section 5.03 <u>No Violation</u>. Neither the execution, delivery and performance by any Credit Party of the Loan Documents to which it is party nor compliance with the terms and provisions thereof (i) will contravene any provision of any law, statute, rule, regulation, order, writ, injunction or decree of any Governmental Authority applicable to such Credit Party or its properties and assets, (ii) will result in any breach of, any of the material terms, covenants, conditions or provisions of, or constitute a default under, or result in the creation or imposition of (or the obligation to create or impose) any Lien (other than the Liens described in <u>Section 2.15</u>) upon any of the property or assets of such Credit Party pursuant to the terms of (A) any Material Contract, or (B) any other promissory note, bond, debenture, indenture, mortgage, deed of trust, credit or loan agreement, or any other agreement or other instrument, to which such Credit Party is a party or by which it or any of its property or assets are bound or to which it may be subject, or (iii) will violate any provision of the Organizational Documents of such Credit Party.

Section 5.04 <u>Governmental Approvals</u>. No order, consent, approval, license, authorization, or validation of, or filing, recording or registration with, or exemption by, any Governmental Authority is required to authorize or is required as a condition to (i) the execution, delivery and performance by any Credit Party of any Loan Document to which it is a party or any of its obligations thereunder, or (ii) the legality, validity, binding effect or enforceability of any Loan Document to which any Credit Party is a party, except the filing and recording of financing statements and other documents necessary in order to perfect the Liens created by the Security Agreement.

Section 5.05 <u>Litigation</u>. There are no actions, suits, investigations or proceedings pending or to the knowledge of any Credit Party, threatened in writing with respect to any Credit Party or against any of their respective properties (i) that have had, or could reasonably be expected to have, a Material Adverse Effect, that are not subject to the automatic stay imposed pursuant to Section 362 of the Bankruptcy Code, or (ii) that question the validity or enforceability of any of the Loan Documents, or of any action to be taken by any Credit Party pursuant to any of the Loan Documents.

Section 5.06 Use of Proceeds; Margin Regulations.

(a) The Debtors will use the proceeds of the Revolving Loans to finance ongoing working capital requirements of the Debtors and to pay for fees, costs, and expenses relating to the Chapter 11 Cases, each in accordance with this Agreement. Upon the Closing Date, the Debtors will use the proceeds of the Term Loans to pay in part the Term Loans and Delayed Draw Loans (each as defined in the Pre-Petition Credit Agreement) owing to the Lenders prior to the Petition Date under the Pre-Petition Credit Agreement.

(b) No part of the proceeds of any Credit Event will be used directly or indirectly to purchase or carry Margin Stock, or to extend credit to others for the purpose of purchasing or carrying any Margin Stock, in violation of any of the provisions of Regulations T, U or X of the Board of Governors of the Federal Reserve System. No Credit Party is engaged in the business of extending credit for the purpose of purchasing or carrying any Margin Stock. At no time would more than 25% of the value of the assets of the Borrower or of the Borrower and its consolidated Subsidiaries that are subject to any "arrangement" (as such term is used in Section 221.2(g) of such Regulation U) hereunder be represented by Margin Stock.

Financial Statements. The Borrower has furnished to the Administrative Agent Section 5.07 and the Lenders complete and correct copies of: (i) the audited consolidated balance sheets of the Borrower and its consolidated Subsidiaries for the fiscal year ended December 31, 2016 and the related audited consolidated statements of income, shareholders' equity, and cash flows of the Borrower and its consolidated Subsidiaries for the fiscal year of the Borrower then ended, accompanied by the report thereon of Grant Thornton, LLP, and (ii) the interim consolidated balance sheet, and the related statements of income and of cash flows, of (1) the Borrower and its Subsidiaries for each fiscal quarter and fiscal month ended after December 31, 2017 and ending at least 45 days prior to the Closing Date. All such financial statements have been prepared in accordance with historic accounting practices. consistently applied (except as stated therein), and fairly present the financial position of the Borrower and its Subsidiaries, in each case, as of the respective applicable dates indicated and the consolidated results of their operations and cash flows for the respective periods indicated, subject in the case of any such financial statements that are unaudited, to normal audit adjustments. The Borrower and its Subsidiaries did not have, as of the date of the latest financial statements referred to above, and will not have as of the Closing Date after giving effect to the incurrence of Loans hereunder, any material or significant contingent liability or liability for taxes, long-term lease or unusual forward or long-term commitment that is not reflected in the foregoing financial statements or the notes thereto and that in any such case is material in relation to the business, operations, properties, assets, financial or other condition or prospects of the Borrower and its Subsidiaries.

Section 5.09 <u>No Material Adverse Change</u>. Since the Petition Date, there has been no change in the condition, business, affairs or prospects of the Credit Parties taken as a whole, or their properties and assets considered as an entirety, except for: (a) changes none of which, individually or in the aggregate, has had or could reasonably be expected to have, a Material Adverse Effect or (b) changes which are consistent with the Budget and/or the sale milestones set forth in <u>Section 6.21</u>.

Section 5.10 <u>Tax Returns and Payments</u>. Each Credit Party has filed all federal income tax returns and all other tax returns, domestic and foreign, required to be filed by it and has paid all taxes and assessments payable by it that have become due, other than those not yet delinquent and except for those contested in good faith or those for which extensions have been filed, including franchise taxes, which have not been paid. No Credit Party knows of any proposed assessment for additional federal, foreign or state taxes for any period, or of any basis therefor, which, individually or in the aggregate, taking into account such charges, accruals and reserves in respect thereof as the Borrower and its Subsidiaries have made, could reasonably be expected to have a Material Adverse Effect.

(g) <u>Notices</u>. Promptly, and in any event within two Business Days, after the Borrower determines that it has likely occurred, notice of:

(A) the occurrence of any event that constitutes a Default or Event of Default, which notice shall specify the nature thereof, the period of existence thereof and what action the Borrower proposes to take with respect thereto;

(B) the commencement of, or any other material development concerning, any litigation or governmental or regulatory proceeding pending or investigation against any Credit Party or any Subsidiary or the occurrence of any other event, if the same could be reasonably likely to have a Material Adverse Effect;

(C) any amendment or waiver of the terms of, or notice of default under, the Subordinated Debt Documents; or

(D) any event that could reasonably be expected to have a Material Adverse Effect.

(h) <u>ERISA</u>. (b) Each Credit Party will at all times keep its respective property that is subject to the Liens described in <u>Section 2.15</u> insured in favor of the Administrative Agent, for the benefit of the Lenders and all policies or certificates (or certified copies thereof) with respect to such insurance (and any other insurance maintained by the Credit Parties) (i) shall be endorsed to the Administrative Agent's satisfaction for the benefit of the Administrative Agent (including, without limitation, by naming the Administrative Agent as loss payee (with respect to Collateral) or, to the extent permitted by applicable law, as an additional insured), (ii) shall state that such insurance policies shall not be canceled without 30 days' prior written notice thereof (or 10 days' prior written notice in the case of cancellation for the non-payment of premiums) by the respective insurer to the Administrative Agent, (iii) shall provide that the respective insurers irrevocably waive any and all rights of subrogation with respect to the Administrative Agent and the Lenders, and (iv) shall in the case of any such certificates or endorsements in favor of the Administrative Agent, be delivered to or deposited with the Administrative Agent.

(c) If any Credit Party shall fail to maintain any insurance in accordance with this <u>Section 6.03</u>, or if any Credit Party shall fail to so endorse and deliver or deposit all endorsements or certificates with respect thereto, the Administrative Agent shall have the right (but shall be under no obligation) to procure such insurance and the Borrower agrees to reimburse the Administrative Agent on demand for all costs and expenses of procuring such insurance.

Payment of Taxes and Claims. Subject to Bankruptcy Code limitations, each Section 6.04 Credit Party will pay and discharge, and will cause each of its Subsidiaries to pay and discharge, all taxes, assessments and governmental charges or levies imposed upon it or upon its income or profits, or upon any properties belonging to it, prior to the date on which penalties attach thereto, and all lawful claims that, if unpaid, might become a Lien or charge upon any properties of any Credit Party or any of their respective Subsidiaries; provided that, no Credit Party nor any of their respective Subsidiaries shall be required to pay any such tax, assessment, charge, levy or claim for which extensions have been filed, including franchise taxes, which have not been paid or that is otherwise being contested in good faith and by proper proceedings if (i) it has maintained adequate reserves with respect thereto in accordance with GAAP and (ii) in the case of a tax or claim that has or may become a Lien against any of the Collateral, such proceedings conclusively operate to stay the sale of any portion of the Collateral to satisfy such tax or claim. Without limiting the generality of the foregoing, each Credit Party will, and will cause each of its Subsidiaries to, pay in full all of its wage obligations in accordance with the Fair Labor Standards Act (29 U.S.C. Sections 206-207), with respect to its employees subject thereto, and any comparable provisions of applicable law.

Section 6.05 <u>Corporate Franchises</u>. Each Credit Party will do, and will cause each of its Subsidiaries to do, or cause to be done, all things necessary to preserve and keep in full force and effect its corporate existence, rights and authority, qualification, franchises, privileges, licenses, permits and governmental approvals and authorizations; provided that, nothing in this <u>Section 6.05</u> shall be deemed to prohibit any transaction permitted by <u>Section 7.02</u>.

Section 6.06 <u>Good Repair</u>. Each Credit Party will, and will cause each of its Subsidiaries to, ensure that its material properties and equipment used or useful in its business in whomsoever's possession they may be, are kept in reasonably good repair, working order and condition, normal wear and tear excepted, and that from time to time there are made in such properties and equipment all needful and proper repairs, renewals, replacements, extensions, additions, betterments and improvements thereto, in each case, to the extent and in the manner customary for companies in similar businesses.

Section 6.07 <u>Compliance with Statutes, etc.</u> Each Credit Party will, and will cause each of its Subsidiaries to, comply with all applicable statutes, regulations and orders of, and all applicable restrictions imposed by, all Governmental Authorities in respect of the conduct of its business and the ownership of its property, including all applicable Environmental Laws and Healthcare Laws, other than those the noncompliance with which would not individually or in the aggregate be reasonably expected to have a Material Adverse Effect. Borrower will, in its reasonable business judgment, maintain in effect and enforce policies and procedures designed to ensure compliance, in all material respects, by Borrower, its Subsidiaries and their respective directors, officers, employees and agents with Anti-Corruption Laws and anti-money laundering rules and regulations applicable to the Credit Parties and their Subsidiaries.

Section 6.08 <u>Compliance with Environmental Laws</u>. Without limitation of the covenants contained in <u>Section 6.07</u>:

(a) Each Credit Party will comply, and will cause each of its Subsidiaries to comply, with all Environmental Laws applicable to the ownership, lease or use of all Real Property now or hereafter owned, leased or operated by such Credit Party or any of its Subsidiaries, and will promptly pay or cause to be paid all costs and expenses incurred in connection with such compliance, except to the extent that such compliance with Environmental Laws is being contested in good faith and by appropriate proceedings and for which adequate reserves have been established to the extent required by GAAP, and the reasonably likely outcome in such proceedings could not reasonably be expected to have a Material Adverse Effect.

(b) Each Credit Party will keep or cause to be kept, and will cause each of its Subsidiaries to keep or cause to be kept, all such Real Property free and clear of any Liens imposed pursuant to such Environmental Laws other than Permitted Liens.

(c) No Credit Party nor any of its Subsidiaries will generate, use, treat, store, release or dispose of, or permit the generation, use, treatment, storage, release or disposal of, Hazardous Materials on any Real Property now or hereafter owned, leased or operated by the Credit Parties or any of their Subsidiaries or transport or permit the transportation of Hazardous Materials to or from any such Real Property other than in compliance with applicable Environmental Laws and in the ordinary course of business, except to the extent that any noncompliance with Environmental Laws is being contested in good faith and by appropriate proceedings and for which adequate reserves have been established to the extent required by GAAP, and the reasonably likely outcome in such proceedings could not reasonably be expected to have a Material Adverse Effect.

(d) If required to do so under any applicable order of any Governmental Authority, each Credit Party will undertake, and cause each of its Subsidiaries to undertake any clean up, removal,

remedial or other action necessary to remove and clean up any Hazardous Materials from any Real Property owned, leased or operated by the Credit Parties or any of their Subsidiaries in accordance with, in all material respects, the requirements of all applicable Environmental Laws and in accordance with, in all material respects, such orders of all Governmental Authorities, except to the extent that such Credit Party or such Subsidiary contesting such order in good faith and by appropriate proceedings and for which adequate reserves have been established to the extent required by GAAP, and the reasonably likely outcome in such proceedings could not reasonably be expected to have a Material Adverse Effect.

Section 6.09 <u>Further Assurances</u>. The Credit Parties will, and will cause each of their respective Subsidiaries to, at the expense of the Borrower, make, execute, endorse, acknowledge, file and/or deliver to the Administrative Agent from time to time such conveyances, financing statements, transfer endorsements, powers of attorney, certificates, and other assurances or instruments and take such further steps relating to the Collateral covered by any of the Liens described in <u>Section 2.15</u> as the Administrative Agent may reasonably require, including any documents, instruments and filings required by the Assignment of Claims Act of 1940.

Section 6.10 <u>Material Contracts</u>. Except as otherwise excused by or rejected in accordance with the Bankruptcy Code, each Credit Party will perform and observe in all material respects all the terms and provisions of each Material Contract to be performed or observed by it, and no Credit Party will take any action that would cause any such Material Contract to not be in full force and effect, and cause each of its Subsidiaries to do so except, in each case, where the failure to do so, either individually or in the aggregate, could not reasonably be expected to have a Material Adverse Effect.

Section 6.11 <u>Senior Debt</u>. The Obligations shall, and the Credit Parties shall take all necessary action to ensure that the Obligations shall, at all times rank prior in right of payment, to the extent set forth in the applicable subordination agreement, to the Subordinated Indebtedness.

Section 6.12 <u>Subordination</u>. Each Credit Party shall cause all Indebtedness and other obligations now or hereafter owed by it to any of its Affiliates (other than, in the case of management of the Credit Parties, payroll obligations) to be subordinated in right of payment and security to the Indebtedness and other Obligations owing to the Administrative Agent and the Lenders in accordance with the Intercompany Subordination Agreement or another subordination agreement in form and substance reasonably satisfactory to the Administrative Agent.

Section 6.13 [Reserved].

Section 6.14 <u>Use of Proceeds</u>. The Borrower will use the proceeds of the Loans only for the purposes set forth in <u>Section 5.06</u>.

Section 6.15 <u>Monitoring of Expenses</u>. Notwithstanding any Bankruptcy Court authorization to pay "critical vendors", prior to making such payment, the Borrower shall implement procedures, which shall be acceptable to the Lenders in their sole discretion, for monitoring and controlling the Credit Parties' compliance with the Budget, which shall include, without limitation, implementation of protocols by the Borrower's financial advisors, which protocols shall include training and implementation of standards for paying expenses in accordance with the Budget.

Section 6.16 <u>Budget Compliance</u>.

(a) The Debtors shall comply with the Budget such that as of the end of every other week (beginning with the week ending June ___, 2018): (i) the aggregate amount of all disbursements (exclusive of debt service, professional fees, adequate protection, U.S. Trustee's fees and capital

expenditures) actually paid by the Debtors from the Petition Date through the end of such reporting period is not more than 105% (the "<u>Permitted Disbursement Variance</u>") of the aggregate, cumulative disbursements (exclusive of debt service, professional fees, adequate protection, U.S. Trustee's fees and capital expenditures) set forth in the Budget for such period; (ii) the aggregate amount of all cash receipts received by the Debtors from the Petition Date through the end of such reporting period is not less than 90% (the "<u>Permitted Receipts Variance</u>") of the total cash receipts projected in the Budget for such period; (iii) the actual cash balance (after adding back any debt service, professional fees, adequate protection, U.S. Trustee fees and capital expenditures) on the Friday preceding the delivery of the Budget Variance Report is not more than \$1,100,000 less than the projected cash balance (after adding back any debt service, professional fees, adequate protection, U.S. Trustee fees and capital expenditures) on the Friday preceding the delivery of the Budget Variance Report; and (iv) the aggregate amount of capital expenditures for the two-week reporting period then ended does not exceed the amount of capital expenditures set forth in the Budget for such period, unless the Debtors have obtained prior written approval from the Administrative Agent.

(b) <u>Measurement</u>. The Budget compliance covenants set forth in this Section shall be measured by the Administrative Agent upon the Administrative Agent's receipt of the bi-weekly Budget Variance Report required to be delivered by the Borrower pursuant to <u>Section 6.01(c)</u>.

Section 6.17 <u>Financial Consultant</u>. The Borrower shall employ (and continue to employ) a financial consultant/crisis management firm acceptable to the Administrative Agent and upon terms and conditions acceptable to the Administrative Agent, including permitting such firm to assist the Borrower with the ongoing operation and restructuring of its business.

Section 6.18 <u>Final Order</u>. The Credit Parties shall comply with all the terms and conditions of the Final Order, as it may be modified from time to time with the approval of the Bankruptcy Court, the Administrative Agent, and the Required Lenders.

Section 6.19 [Reserved].

Section 6.20 <u>First and Second Day Orders</u>. The Debtors shall cause all proposed First Day Orders, "second day" orders, and all other orders establishing procedures for administration of the Chapter 11 Cases or approving significant transactions submitted to the Bankruptcy Court to be in accordance with and permitted by the terms of this Agreement and reasonably acceptable to the Administrative Agent in all respects; it being understood and agreed that the forms of orders approved by the Administrative Agent prior to the Petition Date are in accordance with and permitted by the terms of this Agreement in all respects and are reasonably acceptable and any orders that provide for the termination of the Revolving Commitments and the Term Loan Commitments and the indefeasible repayment in full of the Obligations are reasonably acceptable.

Section 6.21 Chapter 11 Sale Milestones.

(a) <u>Sale/Bidding Procedures Motion</u>. On the Petition Date the Debtors shall have filed and properly served a motion, in form and substance satisfactory to the Pre-Petition Administrative Agent, the Administrative Agent, the Secured Creditors, and the Lenders, in the Chapter 11 Cases (the <u>"Sale/Bidding Procedures Motion</u>") seeking the Bankruptcy Court's approval of: (i) the sale of all or substantially all of the Debtors' assets relating to the Debtors' Freestanding Emergency Room business through one or more transactions and (ii) bidding procedures acceptable to the Pre-Petition Administrative Agent, the Administrative Agent, the Secured Creditors, and the Lenders in their sole discretion for the sale of all or substantially all of the Debtors' assets relating to the Debtors' assets relating to the Debtors' Freestanding Emergency Room business, pursuant to Section 363 and Section 365 of the Bankruptcy Code. The terms

of each such sale transaction shall be acceptable to the Administrative Agent and the Pre-Petition Administrative Agent in their sole discretion.

(b) <u>Bidding Procedures Order</u>. Within 21 days after the Petition Date, unless the Pre-Petition Administrative Agent, Required Lenders (as defined in the Pre-Petition Credit Agreement and herein called the "<u>Pre-Petition Required Lenders</u>")), the Administrative Agent and the Required Lenders (which shall mean the "Required Lenders", as defined in this Agreement) agree otherwise, the Court shall have entered a sales procedures order (the "<u>Bidding Procedures Order</u>") approving the bidding procedures contained in the Sale/Bidding Procedures Motion, which Bidding Procedures Order (including the bidding procedures approved therein) shall be acceptable to the Pre-Petition Administrative Agent, Pre-Petition Required Lenders, Administrative Agent and Required Lenders in their sole discretion. The Bidding Procedures Order shall not be amended, modified, supplemented or waived by the Debtors without the written consent of the Pre-Petition Administrative Agent, Pre-Petition Required Lenders, Administrative Agent, and Required Agent, Pre-Petition Required Lenders.

(c) <u>Bid Due Date</u>. Within 45 days after the Petition Date, unless the Pre-Petition Administrative Agent, Pre-Petition Required Lenders, Administrative Agent and Required Lenders agree otherwise, all qualified bids (which bids, among other things, shall not contain any financing or diligence conditions) shall be due.

(d) <u>Auction</u>. Within 60 days after the Petition Date, unless the Pre-Petition Administrative Agent, Pre-Petition Required Lenders, Administrative Agent and Required Lenders agree otherwise, the Debtors shall have held and completed an auction in accordance with the provisions of the Bidding Procedures Order, and shall have selected for approval by the Court, at a sale hearing to be held in accordance with the Bidding Procedures Order, the highest and otherwise best bid(s) for the applicable assets made by any bidder(s) at the auction, (each such highest and otherwise best bid, a "<u>Winning Bid</u>"). No bid that fails to provide for irrevocable payment in full in cash of all of the Obligations and the Secured Claim (as defined in the Orders) at closing shall constitute, or be eligible to constitute, a Winning Bid unless such bid is acceptable to the Pre-Petition Administrative Agent, Pre-Petition Required Lenders, Administrative Agent and Required Lenders in their respective sole discretion.

(e) <u>Sale Approval Order</u>. Within 70 days after the Petition Date, unless the Pre-Petition Administrative Agent, Pre-Petition Required Lenders, Administrative Agent and Required Lenders agree otherwise, the Court shall have entered one or more orders (the "<u>Sale Approval Order</u>") approving the Winning Bid(s), the transaction or transactions contemplated by the Winning Bid(s) (each, an "<u>Approved Transaction</u>," and the terms and conditions of the Approved Transaction and the documents evidencing or otherwise relating to each Approved Transaction, the "<u>Approved Transaction</u> <u>Documents</u>"), which Sale Approval Order and Approved Transaction(s) shall be in form and substance acceptable to the Pre-Petition Administrative Agent, Pre-Petition Required Lenders, Administrative Agent and Required Lenders in their sole discretion.

(f) <u>Sale Closing</u>. On or before the date that is sixty (60) days after the entry of the Sale Approval Order, unless the Pre-Petition Administrative Agent, Pre-Petition Required Lenders, Administrative Agent and Required Lenders agree otherwise, Debtors shall have executed all Approved Transaction Documents and the Approved Transaction(s) shall have been consummated. The Approved Transaction Documents shall be in form and substance acceptable to the Pre-Petition Administrative Agent, Pre-Petition Required Lenders, Administrative Agent, Pre-Petition Required Lenders, Administrative Agent and Required Lenders in their sole discretion.

(g) <u>Remaining Assets</u>. With respect to any assets relating to the Debtors' Freestanding Emergency Room business that are not sold pursuant to any Approved Transaction, unless

the Pre-Petition Administrative Agent, Pre-Petition Required Lenders, Administrative Agent and Required Lenders agree otherwise, the Debtors shall use commercially reasonable efforts to sell, liquidate or otherwise dispose of such assets on terms and conditions and pursuant to a timeline to be agreed upon by the Debtors, the Pre-Petition Administrative Agent, Pre-Petition Required Lenders, Administrative Agent and Required Lenders.

(h) <u>Twice Weekly Calls</u>. At the request of the Administrative Agent on a twice weekly basis (or more frequently as reasonably requested by the Administrative Agent) from and after the date hereof, management of the Debtors and the Investment Bankers shall conduct a telephonic meeting to be attended by the respective management representatives of the Debtors and the Administrative Agent and their respective representatives. At such telephonic meeting, the Debtors and the Investment Bankers shall present an update on the sale process (including an assessment of any proposed sale transaction or any indication of interest or other offer from any prospective purchaser).

Until such time as the Obligations are indefeasibly paid in full, the Debtors shall (i) continue to retain one or more investment bankers reasonably acceptable to the Administrative Agent and Required Lenders (collectively, the "Investment Bankers") on terms and conditions acceptable to the Administrative Agent and Required Lenders in their sole discretion, to assist the Debtors to sell their respective assets and businesses, and no proceeds of the Collateral (as defined in the Orders and herein called the "Pre-Petition Collateral")), the Collateral, or the proceeds of the Loans may be used to pay, and the Carve-Out shall not include, any fees and expenses of any investment banker or other financial advisor retained by any Debtor unless the Administrative Agent and Required Lenders have consented in writing to the terms and conditions of such retention. Additionally, the Debtors shall authorize and direct the Investment Bankers, upon the request of the Administrative Agent: (i) to fully and promptly disclose to the Administrative Agent, and its advisors, all material documents, information and developments in connection with the efforts of the Debtors and/or the Investment Bankers to market and sell the Pre-Petition Collateral and/or the Collateral; and (ii) to regularly consult with, and promptly respond to the inquiries of, the Administrative Agent and its advisors, in connection with any sale transaction. the marketing and sale process relating thereto, and any and all other matters relating to the affairs, finances and business of the Debtors, the assets and capital stock of the Debtors, and the Investment Bankers' activities related to any and all of the foregoing.

ARTICLE VII

NEGATIVE COVENANTS

Each of the Borrower and the Subsidiaries hereby covenants and agrees that on the Closing Date and thereafter for so long as this Agreement is in effect and until such time as the Commitments have been terminated, no Notes remain outstanding and the Loans, together with interest, Fees and all other Obligations incurred hereunder and under the other Loan Documents, have been paid in full as follows:

Section 7.01 <u>Changes in Business</u>. No Credit Party nor any of its Subsidiaries will engage in any business other than the businesses engaged in by the Credit Parties and its Subsidiaries on the Closing Date and any other business reasonably related thereto. NPG will not engage in any business other than the provision of physicians to practice at the Operating Companies.

Section 7.02 <u>Consolidation, Merger, Acquisitions, Asset Sales, etc.</u> No Credit Party will, nor will any Credit Party permit any of its Subsidiaries to, (i) wind up, liquidate or dissolve its affairs, (ii) enter into any transaction of merger or consolidation, (iii) make or otherwise effect any Acquisition, (iv)

effect any Asset Sale or (v) have any Subsidiary not existing on the Closing Date, except that, each of the following shall be permitted:

- (a) [reserved];
- (b) [reserved];

(c) any Asset Sale approved by the Bankruptcy Court and consented to by the Administrative Agent and the Required Lenders;

(d) any transaction permitted pursuant to <u>Section 7.05;</u> and

(e) any winding up, liquidation, dissolution, merger, consolidation or amalgamation approved by the Bankruptcy Court and consented to by the Administrative Agent and the Required Lenders.

Section 7.03 <u>Liens</u>. No Credit Party will, nor will any Credit Party permit its Subsidiaries to, create, incur, assume or suffer to exist any Lien upon or with respect to any property or assets of any kind of such Credit Party or such Subsidiary whether now owned or hereafter acquired, except that the foregoing shall not apply to:

- (a) any Standard Permitted Lien;
- (b) Liens in existence on the Petition Date that are listed in <u>Schedule 7.03</u> hereto;

and

(c) any Lien granted to the Administrative Agent securing any of the Obligations or any other Indebtedness of the Credit Parties under the Loan Documents.

Section 7.04 Indebtedness. No Credit Party will, nor will any Credit Party permit any of its Subsidiaries to, contract, create, incur, assume or suffer to exist any Indebtedness of the Credit Parties or any of their respective Subsidiaries, except:

- (a) Indebtedness incurred under this Agreement and the other Loan Documents;
- (b) the Indebtedness existing on the Petition Date and set forth on <u>Schedule 7.04</u>

hereto;

(c) [Reserved];

(d) any intercompany loans made by the Borrower or any Subsidiary of the Borrower to any Credit Party, provided that such intercompany loans are subject to the Intercompany Subordination Agreement;

- (e) [Reserved];
- (f) Indebtedness constituting Guaranty Obligations permitted by <u>Section 7.05;</u>

(g) Indebtedness under the Permitted Notes, in each case, as in effect on May 9, 2017, but only so long as the Permitted Note Subordination Agreement shall remain in full force and effect; and

(h) Indebtedness arising from agreements of any Credit Party or any of their Subsidiaries providing for indemnification, adjustment of purchase price, working capital adjustments or similar adjustments (including earn-out obligations), in each case, incurred or assumed in connection with any Asset Sale or Investment permitted under this Agreement (any such obligations, "<u>Deferred Acquisition Obligations</u>"), provided that, so long as no Event of Default exists and is continuing at the time of incurrence of such Indebtedness or would result therefrom, payment of such Deferred Acquisition Obligations shall be permitted.

Section 7.05 <u>Investments and Guaranty Obligations</u>. No Credit Party will, nor will any Credit Party permit any of its Subsidiaries to, directly or indirectly, (i) make or commit to make any Investment or (ii) be or become obligated under any Guaranty Obligations, except:

(a) Investments by the Borrower or any of its Subsidiaries in cash and Cash Equivalents;

(b) any endorsement of a check or other medium of payment for deposit or collection, or any similar transaction in the normal course of business;

(c) the Borrower and its Subsidiaries may acquire and hold receivables and similar items owing to them in the ordinary course of business and payable or dischargeable in accordance with customary trade terms;

(d) any Permitted Creditor Investment;

(e) loans and advances to employees for business-related travel expenses, moving expenses, costs of replacement homes, business machines or supplies, automobiles and other similar expenses, in each case incurred in the ordinary course of business, provided that the aggregate outstanding amount of all such loans and advances shall not exceed \$25,000 at any time;

(f) Investments existing as of the Petition Date and described on <u>Schedule 7.05</u> hereto;

(g) any Guaranty Obligations of the Credit Parties or any of their respective Subsidiaries in favor of the Administrative Agent and the Lenders;

(h) Investments of the Borrower and its Subsidiaries in Hedge Agreements permitted to be entered into pursuant to this Agreement;

(i) Investments (A) of the Borrower or any of its Subsidiaries in any Subsidiary existing as of the Petition Date, (B) of the Borrower in any Credit Party made after the Petition Date or (C) of any Credit Party in any other Credit Party (other than the Borrower) made after the Petition Date;

(j) intercompany loans and advances permitted by <u>Section 7.04(d)</u>; and

(k) any Guaranty Obligation incurred by any Credit Party with respect to Indebtedness of another Credit Party that is permitted by <u>Section 7.04</u>.

Section 7.06 <u>Restricted Payments</u>. No Credit Party will, nor will any Credit Party permit any of its Subsidiaries to, declare or make, or agree to pay or make, directly or indirectly, any Restricted Payment, except:

(a) [reserved];

(b) any Subsidiary of the Borrower may declare and pay or make Restricted Payments to the Borrower or any Subsidiary Guarantor;

(c) dividends or distributions by any Subsidiary to the Borrower in order to fund the consolidated or combined federal, foreign, state and local income taxes payable by the Borrower on behalf of an affiliated group filing consolidated or combined returns which includes Borrower;

(d) Tax Distributions consented to in writing by the Administrative Agent and Required Lenders in their sole and absolute discretion; and

(e) any Subsidiary may make distributions to the Borrower in the amount required for the Borrower to pay franchise, income and other taxes owing by it.

Section 7.07 Limitation on Certain Restrictive Agreements. No Credit Party will, nor will any Credit Party permit any of its Subsidiaries to, directly or indirectly, enter into, incur or permit to exist or become effective, any "negative pledge" covenant or other agreement, restriction or arrangement that prohibits, restricts or imposes any condition upon (a) the ability of any Credit Party or any of their respective Subsidiaries to create, incur or suffer to exist any Lien upon any of its property or assets as security for Indebtedness, or (b) the ability of any such Credit Party or any such Subsidiary to make Capital Distributions or any other interest or participation in its profits owned by any Credit Party or any Subsidiary, or pay any Indebtedness owed to any Credit Party or any Subsidiary, or to make loans or advances to any Credit Party or any Subsidiary, or transfer any of its property or assets to any Credit Party or any Subsidiary, except for such restrictions existing under or by reason of (i) applicable law, (ii) this Agreement and the other Loan Documents, (iii) customary provisions restricting subletting or assignment of any lease governing a leasehold interest, (iv) customary provisions restricting assignment of any licensing agreement entered into in the ordinary course of business, (v) customary provisions restricting the transfer or further encumbering of assets subject to Liens permitted under Section 7.03(b). (vi) customary restrictions affecting only a Subsidiary of the Borrower under any agreement or instrument governing any of the Indebtedness of a Credit Party permitted pursuant to Section 7.04, (vii) any document relating to Indebtedness secured by a Lien permitted by Section 7.03, insofar as the provisions thereof limit grants of junior Liens on the assets securing such Indebtedness and (viii) any Operating Lease or Capital Lease, insofar as the provisions thereof limit grants of a security interest in, or other assignments of, the related leasehold interest to any other Person.

Section 7.08 <u>Transactions with Affiliates</u>. No Credit Party will, nor will any Credit Party permit any of its Subsidiaries to, enter into any transaction or series of transactions with any Affiliate (other than, in the case of the Borrower, any Subsidiary, and in the case of a Subsidiary, the Borrower or another Subsidiary) other than in the ordinary course of business of and pursuant to the reasonable requirements of such Credit Party's or such Subsidiary than would be obtained in a comparable arm's-length transaction with a Person other than an Affiliate, except (i) sales of goods to an Affiliate for use or distribution outside the United States that in the good faith judgment of the Credit Parties comply with any applicable legal requirements of the Code, or (ii) agreements and transactions with and payments to officers, directors and shareholders that are either (A) entered into in the ordinary course of business and not prohibited by any of the other provisions of this Agreement, or (B) entered into outside the ordinary course of business of the Borrower, any of the other provisions of this Agreement or anot prohibited by any of the other provisions of any law, rule or regulation.

Section 7.09 Modification of Certain Agreements.

Debtor-In-Possession Credit Agreement - Page 64

(a) Subject to the Orders and the terms thereof, without the prior written consent of the Required Lenders, no Credit Party will amend, modify, supplement, waive or otherwise change, or consent or agree to any amendment, modification, supplement, waiver or other change to, or enter into any forbearance from exercising any rights with respect to the terms or provisions contained in:

(i) any Subordinated Debt Document (other than any amendment, modification, supplement, waiver or other change for which no fee is payable to the holders of the Subordinated Indebtedness and that (A) extends the maturity or reduces the amount of any repayment, prepayment or redemption of the principal of such Subordinated Indebtedness, (B) reduces the rate or extends any date for payment of interest, premium (if any) or fees payable on such Subordinated Indebtedness or (C) makes the covenants, events of default or remedies in such Subordinated Debt Documents less restrictive on any applicable Credit Party);

(ii) any of the terms of any preferred Equity Interests of the Credit Parties which (i) causes the scheduled redemption date to occur earlier or increases the amount of any scheduled redemption payment or (ii) increases the rate or causes any date for payment of dividends thereon to occur earlier; or

(iii) the Organizational Documents of any Credit Party if such amendment, modification, supplement, waiver or other change would be adverse to the interests of the Lenders.

(b) Without the consent (such consent not to be unreasonably withheld or delayed) of the Administrative Agent, neither the Borrower nor the Limited Partner shall amend, modify, supplement or otherwise change the Organizational Documents of the Borrower or the Limited Partner.

Section 7.10 <u>Anti-Terrorism Laws</u>. No Credit Party nor any of their respective Subsidiaries shall violate any law, regulation, or list of any government agency (including, without limitation, the U.S. Office of Foreign Asset Control list, Executive Order No. 13224 or the USA Patriot Act) that prohibits or limits the conduct of business with or the receiving of funds, goods or services to or for the benefit of certain Persons specified therein or that prohibits or limits any Lender from making any advance or extension of credit to the Borrower or from otherwise conducting business with the Borrower or any other Credit Party.

Section 7.11 <u>Fiscal Year</u>. No Credit Party shall, nor shall it permit any of its Subsidiaries to, change its Fiscal Year end from December 31.

Section 7.12 <u>Issuance of Disqualified Equity Interests</u>. No Credit Party shall, nor shall it permit any of its Subsidiaries to, issue or sell any Disqualified Equity Interests.

Section 7.13 <u>Sale and Lease-Back Transaction</u>. The Borrower and its Subsidiaries will not enter into any Sale and Lease-Back Transaction.

Section 7.14 <u>Accounting Changes</u>. Each Credit Party will not, and will not permit any of its Subsidiaries to, make or permit any material change in its accounting policies or financial reporting practices and procedures, except changes in accounting policies which are required or permitted by GAAP and changes in financial reporting practices and procedures which are required or permitted by GAAP.

Section 7.15 <u>Unfunded Capital Expenditures</u>. The Borrower, NPG and each of their Subsidiaries will not make Unfunded Capital Expenditures.

Section 7.16 <u>Leases</u>. No Credit Party may enter into any lease for real property or assume any lease for real property (other than those leases existing on the Petition Date) without the written approval of the Administrative Agent in its reasonable discretion.

Section 7.17 <u>Certain Payments</u>. Except as expressly provided or permitted hereunder (including, without limitation, to the extent pursuant to any First Day Order or "second day" order complying with the terms of this Agreement) or, with the prior consent of the Administrative Agent, as provided pursuant to any other order of the Bankruptcy Court, no Credit Party shall, nor shall it permit any of its Subsidiaries to, make any payment or distribution to any non-Debtor affiliate or corporate insider outside of the ordinary course of business.

Section 7.18 <u>Material Contracts</u>. No Credit Party shall, nor shall it permit any of its Subsidiaries to, enter into a material contractual obligation without the consent of the Administrative Agent.

Section 7.19 <u>DIP Financing</u>. No Debtor shall incur or apply to the Bankruptcy Court for authority to incur, or suffer to exist, any indebtedness having the priority afforded by Section 364(c) or (d) of the Bankruptcy Code (including any Superpriority Claims) other than the financing provided for under this Agreement unless such financing would pay in full the Obligations under this Agreement and the Pre-Petition First Lien Obligations.

Section 7.20 <u>Alteration of Rights of Lenders</u>. No Credit Party shall, nor shall it permit any of its Subsidiaries to, limit, affect or modify, or apply to the Bankruptcy Court to limit, adversely affect or modify any of the Lenders' rights with respect to the Obligations, including rights with respect to the Pre-Petition Collateral and Collateral and the priority thereof and payment of various amounts, pursuant to any Bankruptcy Plan or otherwise.

Section 7.21 <u>Chapter 11 Claims</u>. Except for the Carve-Out, no Debtor shall apply to the Bankruptcy Court for the authority or allow to be incurred, created, assumed, suffered or permitted any Lien (other than Permitted Liens) against such Debtor, or any of its assets in the Chapter 11 Cases to be <u>pari passu</u> with, or senior to, the Liens of the Lenders granted and arising hereunder and under the Orders.

Section 7.22 <u>Reclamation Claims; Bankruptcy Code § 546(c) Agreements</u>.

(a) Unless authorized by Bankruptcy Court Order, no Debtor shall make any payments or transfer any property on account of claims asserted by such Debtor's vendors for reclamation in accordance with UCC Section 2-702 and Bankruptcy Code Section 546(c) in excess of an amount to be agreed upon, in each case, by such Debtor, the Administrative Agent and the Required Lenders.

(b) No Debtor shall enter into any agreements or file any motion seeking a Bankruptcy Court order for the return of inventory or supplies to any vendor pursuant to Bankruptcy Code Section 546(c) without the written consent of the Lenders.

Section 7.23 <u>506(c) Claims</u>. Except pursuant to a Bankruptcy Court Order, no Debtor shall make or impose any claim of any kind upon or against any Lender, the Administrative Agent or the Collateral pursuant to Section 506(c) of the Bankruptcy Code or otherwise. In addition the Borrower shall cause the priority of all liens of the Lenders and the Administrative Agent on the Collateral to be maintained in full force and effect and in accordance with this Agreement, the other Loan Documents and the Orders. The Borrower will ensure that except as otherwise provided in this Agreement, no person or entity shall be permitted to exercise any rights or remedies with respect to the Collateral unless and until all amounts due under this Agreement and the other Loan Documents have been paid in full.

ARTICLE VIII

EVENTS OF DEFAULT

Section 8.01 Events of Default. Any of the following specified events shall constitute an Event of Default (each an "Event of Default"):

(a) <u>Payments</u>: the Borrower shall (i) default in the payment when due (whether at maturity, on a date fixed for a scheduled repayment, on a date on which a required prepayment is to be made, upon acceleration or otherwise) of any principal of the Loans; or (ii) default, and such default shall continue for two or more Business Days, in the payment when due of any interest on the Loans, any Fees or any other Obligations; or

(b) <u>Representations, etc.</u>: any representation, warranty or statement made by the Borrower or any other Credit Party herein or in any other Loan Document or in any statement or certificate delivered or required to be delivered pursuant hereto or thereto shall prove to be untrue in any material respect (without duplication as to any materiality modifiers, qualifications, or limitations applicable thereto) on the date as of which made, deemed made, or confirmed; or

(c) <u>Certain Covenants</u>: the Borrower shall default in the due performance or observance by it of any term, covenant or agreement contained in (1) <u>Section 6.01</u> (other than <u>Sections (j)</u> through (o)), <u>6.11</u> or <u>6.16</u> through <u>6.21</u> or <u>Article VII</u> of this Agreement, or (2) <u>Sections 6.01(j)</u> through (o), <u>6.03</u>, <u>6.04</u>, <u>6.05</u> or <u>6.10</u> of this Agreement and such default is not remedied for a period of 10 days; or

(d) <u>Other Covenants</u>: any Credit Party shall default in the due performance or observance by it of any term, covenant or agreement contained in this Agreement or any other Loan Document (other than those referred to in <u>Section 8.01(a)</u>, (b) or (c) above) and such default is not remedied within 10 days after the earlier of (i) an Authorized Officer of any Credit Party obtaining knowledge of such default or (ii) the Borrower receiving written notice of such default from the Administrative Agent or the Required Lenders (any such notice to be identified as a "notice of default" and to refer specifically to this paragraph); or

(e) Cross Default Under Other Agreements; Hedge Agreements: any Credit Party or any of its Subsidiaries shall (i) default in any payment with respect to any Material Indebtedness (other than the Obligations), and such default shall continue after the applicable grace period, if any, specified in the agreement or instrument relating to such Material Indebtedness; or (ii) default in the observance or performance of any agreement or condition relating to any Material Indebtedness or contained in any instrument or agreement evidencing, securing or relating thereto (and all grace periods applicable to such observance, performance or condition shall have expired), or any other event shall occur or condition exist, the effect of which default or other event or condition is to cause, or to permit the holder or holders of such Material Indebtedness (or a trustee or agent on behalf of such holder or holders) to cause any such Material Indebtedness to become due prior to its stated maturity; or any such Material Indebtedness of any Credit Party or any of its Subsidiaries shall be declared to be due and payable, or shall be required to be prepaid (other than by a regularly scheduled required prepayment or redemption, prior to the stated maturity thereof); or (iii) without limitation of the foregoing clauses, default in any payment obligation under a Hedge Agreement, and such default shall continue after the applicable grace period, if any, specified in such Hedge Agreement or any other agreement or instrument relating thereto; or

(f) <u>Invalidity of Loan Documents</u>: any provision of any Loan Document, at any time after its execution and delivery and for any reason other than as expressly permitted hereunder or under such Loan Document or satisfaction in full of all the Obligations, ceases to be in full force and effect; or any Credit Party or any other Person contests in any manner the validity or enforceability of any provision of any Loan Document; or any Credit Party denies that it has any or further liability or obligation under any Loan Document, or purports to revoke, terminate or rescind any Loan Document or the Administrative Agent fails to have; or

(g) <u>Invalidity of Liens</u>: any security interest and Lien described in <u>Section 2.15</u> shall cease to be in full force and effect (other than in accordance with the terms hereof and thereof), or shall cease to give the Administrative Agent, for the benefit of the Lenders, the Liens, rights, powers and privileges as described in <u>Section 2.15</u> (including a perfected first priority security interest in and Lien on, all of the Collateral thereunder (except as otherwise expressly provided in <u>Section 2.15</u>)) or shall be asserted by any Credit Party not to be, a valid, perfected, first priority (except as otherwise expressly provided in this Agreement) security interest in or Lien on any Collateral covered thereby; or

Judgments: (i) one or more judgments, orders or decrees (or any settlement of (h) any claim that, if breached, could result in a judgment order or decree) shall be entered against any Credit Party and/or any of its Subsidiaries involving a post-Petition liability (other than a liability covered by insurance, as to which the carrier has adequate claims paying ability and has not effectively reserved its rights) of \$500,000 or more in the aggregate for all such judgments, orders, decrees and settlements for the Credit Parties and their Subsidiaries, and any such judgments or orders or decrees or settlements shall not have been vacated, discharged or stayed or bonded pending appeal within 20 days (or such longer period, not in excess of 60 days, during which enforcement thereof, and the filing of any judgment lien, is effectively stayed or prohibited) from the entry thereof; (ii) one or more judgments, orders, decrees or settlements involving a post-Petition liability shall be entered against any Credit Party and/or any of its Subsidiaries involving a required divestiture of any material properties, assets or business reasonably estimated to have a fair value in excess of \$500,000, and any such judgments, orders or decrees shall not have been vacated, discharged or staved or bonded pending appeal within 20 days (or such longer period, not in excess of 60 days, during which enforcement thereof, and the filing of any judgment lien, is effectively stayed or prohibited) from the entry thereof; (iii) one or more judgments, orders, decrees or settlements shall be entered against any Credit Party involving a required divestiture of any material properties, assets or business reasonably estimated to have a fair value in excess of \$500,000, and any such judgments, orders or decrees shall not have been vacated, discharged or stayed (including by virtue of the automatic stay under Section 362 of the Bankruptcy Code) or bonded pending appeal within 20 days (or such longer period, not in excess of 60 days, during which enforcement thereof, and the filing of any judgment lien, is effectively stayed or prohibited) from the entry thereof, or (iv) one or more nonmonetary judgments, order, decrees or settlements shall be entered against any Credit Party that in the aggregate could reasonably be expected to have a Material Adverse Effect and any such judgments or orders or decrees or settlements shall not have been vacated, discharged or stayed or bonded pending appeal within 20 days (or such longer period, not in excess of 60 days, during which enforcement thereof, and the filing of any judgment lien, is effectively stayed or prohibited) from the entry thereof;

(i) <u>Insolvency Event</u>: any Insolvency Event other than (i) the Chapter 11 Cases with respect to the Debtors and (ii) the Chapter 7 Cases with respect to the Chapter 7 Subsidiaries shall occur with respect to any Credit Party or any of its Subsidiaries; or

(j) <u>Bankruptcy Related Defaults</u>:

(i) The Bankruptcy Court shall enter an order with respect to any Debtor dismissing its Chapter 11 Case or converting it to a case under chapter 7 of the Bankruptcy Code, or

appointing a trustee in its Chapter 11 Case (other than at the request of the Lenders) or appointing a responsible officer or an examiner (other than at the request of the Lenders); or

(ii) The Bankruptcy Court shall enter an order granting relief from the automatic stay applicable under Section 362 of the Bankruptcy Code to the holder of any Lien other than Liens in favor of the Lenders in any assets of any Debtor having an aggregate value in excess of \$500,000; or

(iii) An order of the Bankruptcy Court shall be entered in any of the Chapter 11 Cases amending, supplementing, staying, vacating or otherwise modifying any of the Orders, or any Credit Party shall apply for authority to do so; <u>provided</u>, that no Event of Default shall occur under this clause to the extent that any such amendment, supplement or other modification is made in compliance with this Agreement and is not adverse, in the sole and absolute judgment of the Lenders, to the rights and interests of the Lenders under this Agreement and the Loan Documents; or

(iv) Any Debtor shall support (in any such case by way of any motion or other pleading filed with the Bankruptcy Court or any other writing to another party-in-interest executed by or on behalf of such Debtor or by way of other written or unwritten statements to the Bankruptcy Court) any other Person's opposition of any motion made in the Bankruptcy Court by the Lenders seeking confirmation of the amount of the Lenders' claim or the validity and enforceability of the Liens in favor of the Lenders and/or the Administrative Agent for the benefit of the Lenders; or

(v) From and after the date of entry thereof, the Final Order shall cease to be in full force and effect (or shall have been vacated, stayed, reversed, modified or amended), in each case without the consent of the Required Lenders; or

(vi) Any Debtor shall make any payments on any Indebtedness of such Debtor (other than as permitted under the Orders or permitted hereunder) arising before the Petition Date; or

(vii) Any Debtor shall fail to comply with the terms of the Orders in all material respects; or

(viii) The Debtors shall have failed to file an Acceptable Bankruptcy Plan and Disclosure Statement, within the meaning of Section 1125 of the Bankruptcy Code, on or before November 9, 2018; or

(ix) Any of the Collateral is attached, seized, or repossessed or transferred, actually or constructively, to the possession of a trustee, receiver, custodian or similar client; or

(x) Any motion shall have been filed or any claim shall have been asserted against the Collateral under Section 506(c) or 552 of the Bankruptcy Code; or

(xi) Any objections and other challenges shall have been filed by any party with respect to the validity, priority, secured status or amount of any of Lenders' or Administrative Agent's liens or claims (whether pre- or post-petition) as provided for herein that has not been overruled, withdrawn or otherwise dismissed within fifteen (15) days of such filing; or

(xii) Any Debtor (i) shall be unable to pay its debts as they become due other than debts as to which such Debtor either (a) is relieved from paying by operation of the Bankruptcy

Code or order of the Bankruptcy Court, or (b) has made an application to the Bankruptcy Court for an extension of time to pay (and such application has not been denied), or (ii) shall cease to do business as a going concern; or

 $(\rm xiii)~~A$ Bankruptcy Plan to which the Required Lenders have not consented is filed with the Bankruptcy Court.

(k) <u>ERISA</u>: any ERISA Event shall have occurred and either (i) such event or events could reasonably be expected to have a Material Adverse Effect or (ii) there shall result from any such event or events the imposition of a Lien; or

(1) <u>Change in Control</u>: if there occurs a Change in Control; or

(m) <u>Subordinated Indebtedness</u>: (i) any of the Obligations for any reason shall cease to be "Senior Indebtedness" or "Designated Senior Indebtedness" (or any comparable terms) under, and as defined in, any Subordinated Debt Document, (ii) any Indebtedness other than the Obligations shall constitute "Designated Senior Indebtedness" (or any comparable term) under, and as defined in, any Subordinated Debt Document, (iii) any holder of Subordinated Indebtedness that is an Affiliate of any Credit Party shall fail to perform or comply with any of the subordinated Indebtedness, or (iv) the subordinated Debt Document evidencing or governing any Subordinated Indebtedness shall, in whole or in part, terminate, cease to be effective or cease to be legally valid, binding and enforceable against any holder of the applicable Subordinated Indebtedness.

Section 8.02 <u>Remedies</u>.

(a) <u>Further Advances; Acceleration, Etc.</u> Upon the occurrence of any Event of Default, and at any time thereafter, if any Event of Default shall then be continuing, and without further order of the Bankruptcy Court, the Administrative Agent (i) may, in its discretion, or (ii) shall, upon the written request of the Required Lenders, by written notice to the Borrower, take any or all of the following actions, without prejudice to the rights of the Administrative Agent or any Lender to enforce its claims against the Borrower or any other Credit Party in any manner permitted under applicable law:

(i) declare the Commitments terminated, whereupon the Commitment of each Lender shall forthwith terminate immediately without any other notice of any kind;

(ii) declare the principal of and any accrued interest in respect of all Loans and all other Obligations owing hereunder and thereunder to be, whereupon the same shall become, forthwith due and payable without presentment, demand, protest or other notice of any kind, all of which are hereby waived by the Borrower; and/or

(iii) terminate any Debtor's ability to use the cash collateral provided for by the Final Order.

(b) <u>Relief from Stay</u>. Three (3) Business Days after written notice to the Borrower by the Administrative Agent of the occurrence of any one or more Events of Default, the Administrative Agent, on behalf of the lenders, shall be entitled to file an emergency motion seeking to exercise relief from the automatic stay imposed by Section 362 of the Bankruptcy Code and the Lenders may seek relief from the Bankruptcy Court to proceed to protect and enforce its rights under this Agreement and the other Loan Documents by exercising such remedies as are available to the Lenders in respect thereof under applicable law, either by suit in equity or by action at law, or both, whether for specific performance of

any provision contained in this Agreement or any of the other Loan Documents or in aid of the exercise of any power granted in this Agreement or any of the other Loan Documents.

(c) <u>Appointment of Chapter 11 Trustee</u>. Upon the occurrence of any one or more Events of Default, upon the motion of the Administrative Agent on behalf of itself and the Lenders and in accordance with Section 1104 of the Bankruptcy Code, the Debtors shall consent to the appointment of a chapter 11 trustee acceptable to the Lenders, subject to approval by Bankruptcy Court Order.

(d) <u>Sale of Property</u>. Upon the occurrence of any one or more Events of Default, upon the motion of the Administrative Agent requesting authority under Section 363 of the Bankruptcy Code, on behalf of itself and the Lenders, the Bankruptcy Court shall authorize the Administrative Agent to conduct absolute auction sales in accordance with Section 363 of the Bankruptcy Code of the Debtors' interests in any of the Collateral. To the extent that (i) any such property interests are encumbered by a lien securing an obligation owed to a creditor other than the Lenders, and (ii) such lien ranks prior to the lien securing the Obligations, then the proceeds of any such auction sale shall be used to pay such obligation owed to such creditor prior to the payment of the Obligations.

Section 8.03 <u>Application of Certain Payments and Proceeds</u>. All payments and other amounts received by the Administrative Agent or any Lender through the exercise of remedies hereunder or under the other Loan Documents shall, unless otherwise required by the terms of the other Loan Documents or by applicable law, be applied as follows:

(a) first, to the payment of that portion of the Obligations constituting fees, indemnities and expenses and other amounts (including attorneys' fees and amounts due under <u>Article III</u>) payable to the Administrative Agent in its capacity as such;

(b) second, to the payment of that portion of the Obligations constituting fees, indemnities and expenses (including attorneys' fees and amounts due under <u>Article III</u>) payable to each Lender, ratably among them in proportion to the aggregate of all such amounts;

(c) third, to the payment of that portion of the Obligations constituting accrued and unpaid interest on the Loans, ratably among the Lenders in proportion to the aggregate of all such amounts;

(d) fourth, pro rata to the payment of that portion of the Obligations constituting unpaid principal of the Revolving Loans, ratably among the Lenders with outstanding Revolving Loans in proportion to the aggregate of all such amounts;

(e) fifth, pro rata to the payment of that portion of the Obligations constituting unpaid principal of the Term Loans, ratably among the Lenders with outstanding Term Loans in proportion to the aggregate of all such amounts;

(f) sixth, to the payment of all other Obligations of the Credit Parties owing under or in respect of the Loan Documents that are then due and payable to the Administrative Agent and the Lenders, ratably based upon the respective aggregate amounts of all such Obligations owing to them on such date; and

(g) finally, any remaining surplus after all of the Obligations have been paid in full, to the Borrower or to whomsoever shall be lawfully entitled thereto.

ARTICLE IX

THE ADMINISTRATIVE AGENT

Section 9.01 Appointment.

Each Lender hereby irrevocably designates and appoints the Administrative (a) Agent to act as specified herein and in the other Loan Documents, and each such Lender hereby irrevocably authorizes the Administrative Agent for such Lender, to take such action on its behalf under the provisions of this Agreement and the other Loan Documents and to exercise such powers and perform such duties as are expressly delegated to the Administrative Agent by the terms of this Agreement and the other Loan Documents, together with such other powers as are reasonably incidental thereto. The Administrative Agent agrees to act as such upon the express conditions contained in this Article. Notwithstanding any provision to the contrary elsewhere in this Agreement, the Administrative Agent shall not have any duties or responsibilities, except those expressly set forth herein or in the other Loan Documents, nor any fiduciary relationship with any Lender, and no implied covenants, functions, responsibilities, duties, obligations or liabilities shall be read into this Agreement or otherwise exist against the Administrative Agent. The provisions of this Article IX are solely for the benefit of the Administrative Agent and the Lenders, and no Credit Party shall have any rights as a third-party beneficiary of any of the provisions hereof. In performing its functions and duties under this Agreement, the Administrative Agent shall act solely as agent of the Lenders and does not assume and shall not be deemed to have assumed any obligation or relationship of agency or trust with or for the Credit Parties or any of their respective Subsidiaries.

(b) Each Lender hereby further irrevocably authorizes the Administrative Agent on behalf of and for the benefit of the Lenders, to be the agent for and representative of the Lenders with respect to the Guaranty, the Collateral and any other Loan Document. Subject to <u>Section 11.12</u>, without further written consent or authorization from Lenders, the Administrative Agent may execute any documents or instruments necessary to (i) release any Lien encumbering any item of Collateral that is the subject of a sale or other disposition of assets permitted hereby or to which the Required Lenders (or such other Lenders as may be required to give such consent under <u>Section 11.12</u>) have otherwise consented, or (ii) release any Guarantor from the Guaranty with respect to which the Required Lenders (or such other Lenders as may be required to give such consent under <u>Section 11.12</u>) have otherwise consented.

(c) Anything contained in any of the Loan Documents to the contrary notwithstanding, the Borrower, the Administrative Agent and each Lender hereby agree that (i) no Lender shall have any right individually to realize upon any of the Collateral or to enforce the Guaranty, it being understood and agreed that all powers, rights and remedies hereunder may be exercised solely by the Administrative Agent, on behalf of the Lenders in accordance with the terms hereof and all powers, rights and remedies under the Loan Documents may be exercised solely by the Administrative Agent, and (ii) in the event of a foreclosure by the Administrative Agent on any of the Collateral pursuant to a public or private sale, the Administrative Agent or any Lender may be the purchaser of any or all of such Collateral at any such sale and the Administrative Agent, as agent for and representative of the Lenders (but not any Lender or Lenders in its or their respective individual capacities unless the Required Lenders shall otherwise agree in writing) shall be entitled, for the purpose of bidding and making settlement or payment of the purchase price for all or any portion of the Collateral sold at any such public sale, to use and apply any of the Obligations as a credit on account of the purchase price for any collateral payable by the Administrative Agent at such sale.

Section 9.02 <u>Delegation of Duties</u>. The Administrative Agent may execute any of its duties under this Agreement or any other Loan Document by or through agents, sub-agents or attorneys-in-fact,

and shall be entitled to advice of counsel concerning all matters pertaining to such duties. The Administrative Agent shall not be responsible for the negligence or misconduct of any agents, sub-agents or attorneys-in-fact selected by it with reasonable care except to the extent otherwise required by Section 9.03. All of the rights, benefits and privileges (including the exculpatory and indemnification provisions) of Section 9.03 shall apply to any such sub-agent and to the Affiliates of any such sub-agent, and shall apply to their respective activities as sub-agent as if such sub-agent and Affiliates were named herein. Notwithstanding anything herein to the contrary, with respect to each sub-agent appointed by the Administrative Agent, (i) such sub-agent shall be a third party beneficiary under this Agreement with respect to all such rights, benefits and privileges (including exculpatory and rights to indemnification) and shall have all of the rights, benefits and privileges of a third party beneficiary, including an independent right of action to enforce such rights, benefits and privileges (including exculpatory rights and rights to indemnification) directly, without the consent or joinder of any other Person, against any or all of the Credit Parties and the Lenders, (ii) such rights, benefits and privileges (including exculpatory rights and rights to indemnification) shall not be modified or amended without the consent of such sub-agent, and (iii) such sub-agent shall only have obligations to the Administrative Agent and not to any Credit Party, any Lender or any other Person and no Credit Party, Lender or any other Person shall have the rights, directly or indirectly, as a third party beneficiary or otherwise, against such sub-agent.

Section 9.03 Exculpatory Provisions. Neither the Administrative Agent nor any of its Related Parties shall be (a) liable for any action lawfully taken or omitted to be taken by it or such Person under or in connection with this Agreement or any other Loan Document (except for its or such Related Parties' own gross negligence or willful misconduct as determined by a final non-appealable judgment of a court of competent jurisdiction) or (b) responsible in any manner to any of the Lenders for any recitals, statements, representations or warranties made by the Credit Parties or any of their respective Subsidiaries or any of their respective officers contained in this Agreement, any other Loan Document or in any certificate, report, statement or other document referred to or provided for in, or received by the Administrative Agent under or in connection with, this Agreement or any other Loan Document or for any failure of any Credit Party or any of its officers to perform its obligations hereunder or thereunder. The Administrative Agent shall not be under any obligation to any Lender to ascertain or to inquire as to the observance or performance of any of the agreements contained in, or conditions of, this Agreement or any other Loan Document, or to inspect the properties, books or records of the Credit Parties or any of their respective Subsidiaries. The Administrative Agent shall not be responsible to any Lender for the effectiveness, genuineness, validity, enforceability, collectability or sufficiency of this Agreement or any Loan Document or for any representations, warranties, recitals or statements made herein or therein or made in any written or oral statement or in any financial or other statements, instruments, reports, certificates or any other documents in connection herewith or therewith furnished or made by the Administrative Agent to the Lenders or by or on behalf of the Credit Parties or any of their respective Subsidiaries to the Administrative Agent or any Lender or be required to ascertain or inquire as to the performance or observance of any of the terms, conditions, provisions, covenants or agreements contained herein or therein or as to the use of the proceeds of the Loans or of the existence or possible existence of any Default or Event of Default.

Section 9.04 <u>Reliance by Administrative Agent</u>. The Administrative Agent shall be entitled to rely, and shall be fully protected in relying, upon any note, writing, resolution, notice, consent, certificate, affidavit, letter, cablegram, telegram, e-mail or other electronic transmission, facsimile transmission, telex or teletype message, statement, order or other document or conversation believed by it, in good faith, to be genuine and correct and to have been signed, sent or made by the proper Person or Persons and upon advice and statements of legal counsel (including, without limitation, counsel to the Borrower or any of its Subsidiaries), independent accountants and other experts selected by the Administrative Agent. The Administrative Agent shall be fully justified in failing or refusing to take any action under this Agreement or any other Loan Document unless it shall first receive such advice or concurrence of the Required

Lenders as it deems appropriate or it shall first be indemnified to its satisfaction by the Lenders against any and all liability and expense that may be incurred by it by reason of taking or continuing to take any such action. The Administrative Agent shall in all cases be fully protected in acting, or in refraining from acting, under this Agreement and the other Loan Documents in accordance with a request of the Required Lenders or all of the Lenders, as applicable, as to any matter that, pursuant to <u>Section 11.12</u>, can only be effectuated with the consent of all Required Lenders, or all applicable Lenders, as the case may be), and such request and any action taken or failure to act pursuant thereto shall be binding upon all the Lenders.

Section 9.05 <u>Notice of Default</u>. The Administrative Agent shall not be deemed to have knowledge or notice of the occurrence of any Default or Event of Default hereunder unless the Administrative Agent has received notice from a Lender or the Borrower referring to this Agreement, describing such Default or Event of Default and stating that such notice is a "notice of default." If the Administrative Agent receives such a notice, the Administrative Agent shall give prompt notice thereof to the Lenders. The Administrative Agent shall take such action with respect to such Default or Event of Default as shall be reasonably directed by the Required Lenders; provided that, unless and until the Administrative Agent shall have received such directions, the Administrative Agent may (but shall not be obligated to) take such action, or refrain from taking such action, with respect to such Default or Event of Default as it shall deem advisable in the best interests of the Lenders.

Section 9.06 Non-Reliance. Each Lender expressly acknowledges that neither the Administrative Agent nor any of its Related Parties has made any representations or warranties to it and that no act by the Administrative Agent hereinafter taken, including, without limitation, any review of the affairs of the Credit Parties or their respective Subsidiaries, shall be deemed to constitute any representation or warranty by the Administrative Agent to any Lender. Each Lender represents to the Administrative Agent that it has, independently and without reliance upon the Administrative Agent, or any other Lender, and based on such documents and information as it has deemed appropriate, made its own appraisal of, and investigation into, the business, assets, operations, property, financial and other conditions, prospects and creditworthiness of the Credit Parties and their Subsidiaries and made its own decision to make its Loans hereunder and enter into this Agreement. Each Lender also represents that it will, independently and without reliance upon the Administrative Agent, or any other Lender, and based on such documents and information as it shall deem appropriate at the time, continue to make its own credit analysis, appraisals and decisions in taking or not taking action under this Agreement, and to make such investigation as it deems necessary to inform itself as to the business, assets, operations, property, financial and other conditions, prospects and creditworthiness of the Credit Parties and their Subsidiaries. The Administrative Agent shall not have any duty or responsibility to provide any Lender with any credit or other information concerning the business, operations, assets, property, financial and other conditions, prospects or creditworthiness of the Credit Parties and their Subsidiaries that may come into the possession of the Administrative Agent or any of its Related Parties.

Section 9.07 <u>No Reliance on Administrative Agent's Customer Identification Program</u>. Each Lender acknowledges and agrees that neither such Lender, nor any of its Affiliates, participants or assignees, may rely on the Administrative Agent to carry out such Lender's, Affiliate's, participants or assignee's customer identification program, or other obligations required or imposed under or pursuant to the USA Patriot Act or the regulations thereunder, including the regulations contained in 31 CFR 103.121 (as hereafter amended or replaced, the "<u>CIP Regulations</u>"), or any other Anti-Terrorism Law, including any programs involving any of the following items relating to or in connection with the Credit Parties or their respective Subsidiaries, any of their respective Affiliates or agents, the Loan Documents or the transactions hereunder: (a) any identity verification procedures, (b) any record keeping, (c) any comparisons with government lists, (d) any customer notices or (e) any other procedures required under the CIP Regulations or such other laws.

Section 9.08 <u>USA Patriot Act</u>. Each Lender or assignee or participant of a Lender that is not organized under the laws of the United States of America or a state thereof (and is not excepted from the certification requirement contained in Section 313 of the USA Patriot Act and the applicable regulations because it is both (a) an affiliate of a depository institution or foreign bank that maintains a physical presence in the United States or foreign country, and (b) subject to supervision by a banking authority regulating such affiliated depository institution or foreign bank) shall deliver to the Administrative Agent the certification, or, if applicable, recertification, certifying that such Lender is not a "shell" and certifying to other matters as required by Section 313 of the USA Patriot Act and the applicable regulations: (i) within 10 days after the Closing Date, and (ii) at such other times as are required under the USA Patriot Act.

Section 9.09 Indemnification. The Lenders agree to severally indemnify the Administrative Agent and its Related Parties, ratably according to their pro rata share of the Aggregate Credit Facility Exposure, from and against any and all liabilities, obligations, losses, damages, penalties, actions, judgments, suits, costs, reasonable expenses or disbursements of any kind whatsoever that may at any time (including, without limitation, at any time following the payment of the Obligations) be imposed on, incurred by or asserted against the Administrative Agent or such Related Parties in any way relating to or arising out of this Agreement or any other Loan Document, or any documents contemplated by or referred to herein or the transactions contemplated hereby or any action taken or omitted to be taken by the Administrative Agent or such Related Parties under or in connection with any of the foregoing, but only to the extent that any of the foregoing is not paid by the Borrower; provided that, no Lender shall be liable to the Administrative Agent or any of its Related Parties for the payment of any portion of such liabilities, obligations, losses, damages, penalties, actions, judgments, suits, costs, expenses or disbursements to the extent resulting solely from the Administrative Agent's or such Related Parties' gross negligence or willful misconduct as determined by a final non-appealable judgment of a court of competent jurisdiction. If any indemnity furnished to the Administrative Agent or any such Related Parties for any purpose shall, in the opinion of the Administrative Agent, be insufficient or become impaired, the Administrative Agent may call for additional indemnity and cease, or not commence, to do the acts indemnified against until such additional indemnity is furnished. The agreements in this Section shall survive the payment of all Obligations.

Section 9.10 <u>The Administrative Agent in Individual Capacity</u>. The Administrative Agent and its Affiliates may make loans to, accept deposits from and generally engage in any kind of business with the Credit Parties, their respective Subsidiaries and their Affiliates as though not acting as Administrative Agent hereunder. With respect to the Loans made by it and all Obligations owing to it, the Administrative Agent shall have the same rights and powers under this Agreement as any Lender and may exercise the same as though it were not the Administrative Agent, and the terms "Lender" and "Lenders" shall include the Administrative Agent in its individual capacity.

Section 9.11 <u>Successor Administrative Agent</u>. The Administrative Agent may resign at any time upon not less than 30 days' notice to the Lenders and the Borrower. Upon receipt of any such notice of resignation, the Required Lenders shall have the right, in consultation with the Borrower, to appoint a successor. If no such successor shall have been so appointed by the Required Lenders and shall have accepted such appointment within 30 days after the retiring Administrative Agent gives notice of its resignation, then the retiring Administrative Agent may on behalf of the Lenders, appoint a successor Administrative Agent; provided that, if the Administrative Agent shall notify the Borrower and the Lenders that no such successor is willing to accept such appointment, then such resignation shall nonetheless become effective in accordance with such notice and (i) the retiring Administrative Agent shall be discharged from its duties and obligations hereunder and under the other Loan Documents (except that in the case of any collateral security held by the Administrative Agent on behalf of the Lenders under any of the Loan Documents, the retiring Administrative Agent shall continue to hold such

collateral security until such time as a successor Administrative Agent is appointed) and (ii) all payments, communications and determinations provided to be made by, to or through the Administrative Agent shall instead be made by or to each Lender directly, until such time as the Required Lenders appoint a successor Administrative Agent as provided for above in this paragraph. Upon the acceptance of a successor's appointment as Administrative Agent hereunder, such successor shall succeed to and become vested with all of the rights, powers, privileges and duties of the retiring (or retired) Administrative Agent, and the retiring Administrative Agent shall be discharged from all of its duties and obligations hereunder or under the other Loan Documents (if not already discharged therefrom as provided above in this paragraph). The fees payable by the Borrower to a successor Administrative Agent shall be the same as those payable to its predecessor unless otherwise agreed between the Borrower and such successor. After the retiring Administrative Agent's resignation hereunder and under the other Loan Documents, the provisions of this Article and <u>Section 11.02</u> shall continue in effect for the benefit of such retiring Administrative Agent, its sub-agents and their respective Related Parties in respect of any actions taken or omitted to be taken by any of them while the retiring Administrative Agent was acting as Administrative Agent.

Section 9.12 <u>Other Agents</u>. Any Lender identified herein as a Co-Agent, Syndication Agent, Documentation Agent, Managing Agent, Manager or any other corresponding title, other than "Administrative Agent," shall have no right, power, obligation, liability, responsibility or duty under this Agreement or any other Loan Document except those applicable to all Lenders as such. Each Lender acknowledges that it has not relied, and will not rely, on any Lender so identified in deciding to enter into this Agreement or in taking or not taking any action hereunder.

Section 9.13 Collateral Matters. The Administrative Agent may from time to time make such disbursements and advances ("Agent Advances") that the Administrative Agent, in its sole discretion, deems necessary or desirable to preserve, protect, prepare for sale or lease or dispose of the Collateral or any portion thereof, to enhance the likelihood or maximize the amount of repayment by the Borrower of the Loans and other Obligations or to pay any other amount chargeable to the Borrower or the other Credit Parties pursuant to the terms of this Agreement, including, without limitation, costs, fees and expenses as described in Section 11.01; provided that the aggregate amount of such Agent Advances shall not exceed 10% of the Total Revolving Commitment and in no event shall the Agent Advances, together with the Aggregate Revolving Facility Exposure, exceed the Total Revolving Commitment. The Agent Advances shall constitute Obligations hereunder, shall be repayable on demand, shall be secured by the Collateral and shall bear interest at a rate per annum equal to the rate then applicable to Revolving Loans that are Base Rate Loans. The Administrative Agent shall notify each Lender and the Borrower in writing of each such Agent Advance, which notice shall include a description of the purpose of such Agent Advance. Without limitation to its obligations pursuant to Section 9.09, each Lender agrees that it shall make available to the Administrative Agent, upon the Administrative Agent's demand, in Dollars in immediately available funds, the amount equal to such Lender's pro rata share of each such Agent Advance. If such funds are not made available to the Administrative Agent by such Lender, the Administrative Agent shall be entitled to recover such funds on demand from such Lender, together with interest thereon for each day from the date such payment was due until the date such amount is paid to the Administrative Agent, at the Federal Funds Effective Rate for three Business Days and thereafter at the Base Rate.

Section 9.14 <u>Agency for Perfection</u>. The Administrative Agent and each Lender hereby appoints the Administrative Agent and each other Lender as agent and bailee for the purpose of perfecting the security interests in and liens upon the Collateral in assets that, in accordance with <u>Article 9</u> of the UCC, can be perfected only by possession or control (or where the security interest of a secured party with possession or control has priority over the security interest of another secured party) and the Administrative Agent and each Lender hereby acknowledges that it holds possession of or otherwise

controls any such Collateral for the benefit of the Administrative Agent and the Lenders as secured party. Should any Lender obtain possession or control of any such Collateral, such Lender shall notify the Administrative Agent thereof, and, promptly upon the Administrative Agent's request therefor shall deliver such Collateral to the Administrative Agent or in accordance with the Administrative Agent's instructions. Without limiting the generality of the foregoing, each Lender hereby appoints the Administrative Agent for the purpose of perfecting the Administrative Agent's Liens on deposit accounts or securities accounts of any Credit Party. Each Credit Party by its execution and delivery of this Agreement hereby consents to the foregoing.

Section 9.15 <u>Proof of Claim</u>. The Lenders and the Borrower hereby agree that in case of the pendency of any receivership, insolvency, liquidation, bankruptcy, reorganization, arrangement, adjustment, composition or other judicial proceeding relative to the Borrower or any of the Guarantors, the Administrative Agent (irrespective of whether the principal of any Loan shall then be due and payable as herein expressed or by declaration or otherwise and irrespective of whether the Administrative Agent shall have made any demand on the Borrower or any of the Guarantors) shall be entitled and empowered, by intervention in such proceeding or otherwise:

(a) to file and prove a claim for the whole amount of principal and interest owing and unpaid in respect of the Loans and any other Obligations that are owing and unpaid and to file such other papers or documents as may be necessary or advisable in order to have the claims of the Lenders and the Administrative Agent (including any claim for the reasonable compensation, expenses, disbursements and advances of the Lenders and the Administrative Agent and their agents and counsel and all other amounts due the Lenders and the Administrative Agent hereunder) allowed in such judicial proceeding; and

(b) to collect and receive any moneys or other property payable or deliverable on any such claims and to distribute the same;

and any custodian, receiver, assignee, trustee, liquidator, sequestrator or other similar official in any such judicial proceeding is hereby authorized by each Lender to make such payments to the Administrative Agent and, in the event that the Administrative Agent shall consent to the making of such payments directly to the Lenders, to pay to the Administrative Agent any amount due for the reasonable compensation, expenses, disbursements and advances of the Administrative Agent and its agents and counsel, and any other amounts due the Administrative Agent and other agents hereunder. Nothing herein contained shall be deemed to authorize the Administrative Agent to authorize or consent to or accept or adopt on behalf of any Lender any plan of reorganization, arrangement, adjustment or composition affecting the Obligations or the rights of any Lenders or to authorize the Administrative Agent to vote in respect of the claim of any Lender in any such proceeding. Further, nothing contained in this Section 9.15 shall affect or preclude the ability of any Lender to (i) file and prove such a claim in the event that the Administrative Agent and prove such a claim in the event that the Administrative Agent has not acted within ten (10) days prior to any applicable bar date and (ii) require an amendment of the proof of claim to accurately reflect such Lender's outstanding Obligations.]

Section 9.16 Posting of Approved Electronic Communications.

(a) <u>Delivery of Communications</u>. Each Credit Party hereby agrees, unless directed otherwise by the Administrative Agent or unless the electronic mail address referred to below has not been provided by the Administrative Agent to such Credit Party that it will, or will cause its Subsidiaries to, provide to the Administrative Agent all information, documents and other materials that it is obligated to furnish to the Administrative Agent or to the Lenders pursuant to the Loan Documents, including all notices, requests, financial statements, financial and other reports, certificates and other information materials, but excluding any such communication that (i) is or relates to a Notice of Borrowing or a

Notice of Continuation or Conversion, (ii) relates to the payment of any principal or other amount due under this Agreement prior to the scheduled date therefor, (iii) provides notice of any Default under this Agreement or any other Loan Document or (iv) is required to be delivered to satisfy any condition precedent to the effectiveness of this Agreement and/or any Loan or other extension of credit hereunder (all such non-excluded communications being referred to herein collectively as "Communications"), by transmitting the Communications in an electronic/soft medium that is properly identified in a format acceptable to the Administrative Agent to an electronic mail address as directed by the Administrative Agent. In addition, each Credit Party agrees, and agrees to cause its Subsidiaries, to continue to provide the Communications to the Administrative Agent or the Lenders, as the case may be, in the manner specified in the Loan Documents but only to the extent requested by the Administrative Agent.

(b) <u>Platform</u>. Each Credit Party further agrees that Administrative Agent may make the Communications available to the Lenders by posting the Communications on Intralinks, SyndTrak, Debt Domain or a substantially similar electronic transmission system (the "Platform").

No Warranties as to Platform. THE PLATFORM IS PROVIDED "AS IS" AND (c) "AS AVAILABLE." THE INDEMNITEES DO NOT WARRANT THE ACCURACY OR COMPLETENESS OF THE COMMUNICATIONS OR THE ADEQUACY OF THE PLATFORM AND DISCLAIM LIABILITY FOR ERRORS OR EXPRESSLY OMISSIONS IN THE COMMUNICATIONS. NO WARRANTY OF ANY KIND, EXPRESS, IMPLIED OR STATUTORY, INCLUDING ANY WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NON-INFRINGEMENT OF THIRD PARTY RIGHTS OR FREEDOM FROM VIRUSES OR OTHER CODE DEFECTS IS MADE BY THE INDEMNITEES IN CONNECTION WITH THE COMMUNICATIONS OR THE PLATFORM. IN NO EVENT SHALL THE INDEMNITEES HAVE ANY LIABILITY TO ANY LENDER OR ANY OTHER PERSON FOR DAMAGES OF ANY KIND. WHETHER OR NOT BASED ON STRICT LIABILITY AND INCLUDING DIRECT OR INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, LOSSES OR EXPENSES (WHETHER IN TORT. CONTRACT OR OTHERWISE) ARISING OUT OF THE ADMINISTRATIVE AGENT'S TRANSMISSION OF COMMUNICATIONS THROUGH THE INTERNET, EXCEPT TO THE EXTENT THE LIABILITY OF ANY INDEMNITEES IS FOUND IN A FINAL, NON-APPEALABLE ORDER BY A COURT OF COMPETENT JURISDICTION TO HAVE RESULTED PRIMARILY FROM SUCH INDEMNITEE'S GROSS NEGLIGENCE OR WILLFUL MISCONDUCT.

(d) <u>Delivery Via Platform</u>. The Administrative Agent agrees that the receipt of the Communications by the Administrative Agent at its electronic mail address set forth above shall constitute effective delivery of the Communications to the Administrative Agent for purposes of the Loan Documents. Each Lender agrees that receipt of notice to it (as provided in the next sentence) specifying that the Communications have been posted to the Platform shall constitute effective delivery of the Communications to such Lender for purposes of the Loan Documents. Each Lender agrees to notify the Administrative Agent in writing (including by electronic communication) from time to time of such Lender's electronic mail address to which the foregoing notice may be sent by electronic transmission and that the foregoing notice may be sent to such electronic mail address.

(e) <u>No Prejudice to Notice Rights</u>. Nothing herein shall prejudice the right of the Administrative Agent or any Lender to give any notice or other communication pursuant to any Loan Document in any other manner specified in such Loan Document.

Section 9.17 <u>Credit Bidding</u>. Each Lender hereby irrevocably authorizes the Administrative Agent, based upon the instruction of the Required Lenders, to credit bid and purchase (either directly or through one or more acquisition vehicles) all or any portion of the Collateral at any sale thereof conducted under the provisions of the UCC, including pursuant to Sections 9-610 or 9-620 thereof, at any sale

ARTICLE XI

MISCELLANEOUS

Section 11.01 Payment of Expenses etc. Each Credit Party agrees to pay (or reimburse the Administrative Agent, the Lenders or their Affiliates, as the case may be) all of the following: (i) whether or not the transactions contemplated hereby are consummated, for all reasonable and invoiced out-ofpocket costs and expenses of the Administrative Agent in connection with the negotiation, preparation, syndication, administration and execution and delivery of the Loan Documents and the documents and instruments referred to therein and the syndication of the Commitments; (ii) all reasonable and invoiced out-of-pocket costs and expenses of the Administrative Agent in connection with any amendment, waiver or consent relating to any of the Loan Documents; (iii) all reasonable out-of-pocket costs and expenses of the Administrative Agent in connection with the enforcement of any of the Loan Documents or the other documents and instruments referred to therein, including, without limitation, the reasonable fees and disbursements of any individual counsel to the Administrative Agent; (iv) any and all present and future stamp and other similar taxes with respect to the foregoing matters and save the Administrative Agent and each of the Lenders harmless from and against any and all liabilities with respect to or resulting from any delay or omission (other than to the extent attributable to any such indemnified Person) to pay such taxes; (v) all the actual costs and expenses of creating and perfecting Liens in favor of the Administrative Agent, for the benefit of Lenders, including filing and recording fees, expenses and amounts owed pursuant to Article III, search fees, title insurance premiums and fees, expenses and disbursements of counsel to the Administrative Agent and of counsel providing any opinions that the Administrative Agent or the Required Lenders may request in respect of the Collateral; (vi) all the actual costs and fees, expenses and disbursements of any auditors, accountants, consultants or appraisers whether internal or external; (vii) all the actual costs and expenses (including the reasonable and documented fees, expenses and disbursements of counsel (including allocated costs of internal counsel) and of any appraisers, consultants, advisors and agents employed or retained by the Administrative Agent and its counsel) in connection with the custody or preservation of any of the Collateral; and (viii) all out-of-pocket costs and expenses of the Administrative Agent and each Lender incurred in connection with the enforcement of any rights or remedies under this Agreement or the other Loan Documents (including all such costs and expenses incurred during any legal proceeding or in connection with any workout or restructuring), including the fees, disbursements and other charges of counsel (limited to the fees, disbursements and other charges of one counsel to the Administrative Agent and the Lenders taken as a whole, and, in the event any legal conflict of interest exists, one additional counsel for the Lenders taken as a whole, if deemed advisable by the Administrative Agent or the Lenders).

Section 11.02 <u>Indemnification</u>. Each Credit Party agrees to indemnify the Administrative Agent, each Lender, and their respective Related Parties (collectively, the "Indemnitees") from and hold each of them harmless against any and all losses, liabilities, claims, damages or expenses reasonably incurred by any of them as a result of, or arising out of, or in any way related to, or by reason of (i) any

investigation, litigation or other proceeding (whether or not any Indemnitee is a party thereto) related to the entering into and/or performance of any Loan Document or the use of the proceeds of any Loans hereunder or the consummation of any transactions contemplated in any Loan Document, other than any such investigation, litigation or proceeding arising out of transactions solely between any of the Lenders or the Administrative Agent, transactions solely involving the assignment by a Lender of all or a portion of its Loans and Commitments, or the granting of participations therein, as provided in this Agreement, or arising solely out of any examination of a Lender by any regulatory or other Governmental Authority having jurisdiction over it that is not in any way related to the entering into and/or performance of any Loan Document, or (ii) the actual or alleged presence of Hazardous Materials in the air, surface water or groundwater or on the surface or subsurface of any Real Property owned, leased or at any time operated by the Credit Parties or any of their respective Subsidiaries, the release, generation, storage, transportation, handling or disposal of Hazardous Materials at any location, whether or not owned or operated by the Credit Parties or any of their respective Subsidiaries, if the Borrower, such Credit Party or any such Subsidiary could have or is alleged to have any responsibility in respect thereof, the noncompliance of any such Real Property with foreign, federal, state and local laws, regulations and ordinances (including applicable permits thereunder) applicable thereto, or any Environmental Claim asserted against any Credit Party or any of their respective Subsidiaries, in respect of any such Real Property, including, in the case of each of (i) and (ii) above, without limitation, the reasonable documented fees and disbursements of one outside counsel for all Indemnitees and, if necessary, one special counsel and one firm of local counsel in each relevant material jurisdiction (which may include a single special counsel acting in multiple jurisdictions) incurred in connection with any such investigation, litigation or other proceeding (but excluding any such losses, liabilities, claims, damages or expenses of any Indemnitee to the extent (A) arising from (x) the gross negligence or willful misconduct of such Indemnitee (but in the case of any agent or advisor, only to the extent such agent or advisor was acting at the direction of the applicable Indemnitee) to the extent determined by a final non-appealable judgment of a court of competent jurisdiction or (y) a material breach by such Indemnitee of their obligations under the Loan Documents, in each case, as determined by a final nonappealable judgment of a court of competent jurisdiction or (B) arising solely from a dispute among Indemnitees (other than a claim against the Administrative Agent solely in its capacity as such) not resulting from any action or inaction of the Borrower, any Subsidiary Guarantor or any Credit Party). To the extent that the undertaking to indemnify, pay or hold harmless any Person set forth in the preceding sentence may be unenforceable because it is violative of any law or public policy, each Credit Party shall make the maximum contribution to the payment and satisfaction of each of the indemnified liabilities that is permissible under applicable law.

Section 11.03 Right of Setoff. In addition to any rights now or hereafter granted under applicable law or otherwise, and not by way of limitation of any such rights, upon the occurrence and during the continuance of an Event of Default, each Lender is hereby authorized at any time or from time to time, without presentment, demand, protest or other notice of any kind to any Credit Party or to any other Person, any such notice being hereby expressly waived, to set off and to appropriate and apply any and all deposits (general or special) and any other Indebtedness at any time held or owing by such Lender (including, without limitation, by branches, agencies and Affiliates of such Lender wherever located) to or for the credit or the account of any Credit Party against and on account of the Obligations and liabilities of any Credit Party to such Lender under this Agreement or under any of the other Loan Documents, including, without limitation, all claims of any nature or description arising out of or connected with this Agreement or any other Loan Document, irrespective of whether or not such Lender shall have made any demand hereunder and although said Obligations, liabilities or claims, or any of them, shall be contingent or unmatured; provided that in the event that any Defaulting Lender shall exercise any such right of setoff, (a) all amounts so set off shall be paid over immediately to the Administrative Agent for further application in accordance with the provisions of Section 2.13 and. pending such payment, shall be segregated by such Defaulting Lender from its other funds and deemed

held in trust for the benefit of the Administrative Agent and the Lenders, and (y) the Defaulting Lender shall provide promptly to the Administrative Agent a statement describing in reasonable detail the Obligations owing to such Defaulting Lender as to which it exercised such right of setoff. Each Lender agrees to promptly notify the Borrower after any such set off and application, provided that, the failure to give such notice shall not affect the validity of such set off and application.

Section 11.04 Equalization.

Equalization. If at any time any Lender receives any amount hereunder (a) (whether by voluntary payment, by realization upon security, by the exercise of the right of setoff or banker's lien, by counterclaim or cross action, by the enforcement of any right under the Loan Documents, or otherwise) that is applicable to the payment of the principal of or interest on, the Loans or Fees (other than Fees that are intended to be paid solely to the Administrative Agent and amounts payable to a Lender under Article III), of a sum that with respect to the related sum or sums received by other Lenders is in a greater proportion than the total of such Obligation then owed and due to such Lender bears to the total of such Obligation then owed and due to all of the Lenders immediately prior to such receipt, then such Lender receiving such excess payment shall purchase for cash without recourse or warranty from the other Lenders an interest in the Obligations to such Lenders in such amount as shall result in a proportional participation by all of the Lenders in such amount. The provisions of this Section 11.04(a) shall not be construed to apply to (i) any payment made by the Borrower pursuant to and in accordance with the express terms of this Agreement (including the application of funds arising from the existence of a Defaulting Lender), or (ii) any payment obtained by a Lender as consideration for the assignment of or sale of a participation in any of its Loans to any assignee or participant, other than to the Borrower or any Subsidiary thereof (as to which the provisions of this paragraph shall apply).

(b) <u>Recovery of Amounts</u>. If any amount paid to any Lender pursuant to subpart (a) above is recovered in whole or in part from such Lender, such original purchase shall be rescinded, and the purchase price restored ratably to the extent of the recovery.

(c) <u>Consent of Borrower</u>. The Borrower consents to the foregoing and agrees, to the extent it may effectively do so under applicable law, that any Lender acquiring a participation pursuant to the foregoing arrangements may exercise against the Borrower rights of set-off and counterclaim with respect to such participation as fully as if such Lender were a direct creditor of the Borrower in the amount of such participation.

Section 11.05 Notices.

(a) <u>Generally</u>. Except in the case of notices and other communications expressly permitted to be given by telephone (and except as provided in subpart (c) below), all notices and other communications provided for herein shall be in writing and shall be delivered by hand or overnight courier service, mailed by certified or registered mail or sent by facsimile as follows:

(A) if to the Borrower or any other Credit Party, to it at 10800 Richmond Avenue, Houston, Texas 77042, Attention: Chief Restructuring Officer, (Facsimile No. (713) 436-9669);

(B) if to the Administrative Agent, to it at the Notice Office and to Sally C. Barton, 127 Public Square, Cleveland, OH 444144; and

(C) if to a Lender, to it at its address (or facsimile number) set forth next to its name on the signature pages hereto or, in the case of any Lender that becomes a party to this Agreement

by way of assignment under <u>Section 11.06</u> of this Agreement, to it at the address set forth in the Assignment Agreement to which it is a party;

(b) <u>Receipt of Notices</u>. Notices and communications sent by hand or overnight courier service, or mailed by certified or registered mail, shall be deemed to have been given when received; notices sent by facsimile shall be deemed to have been given when sent and receipt has been confirmed by telephone. Notices delivered through electronic communications to the extent provided in subpart (c) below shall be effective as provided in said subpart (c).

Electronic Communications. Notices and other communications to the (c)Administrative Agent or any Lender hereunder and required to be delivered pursuant to Section 6.01 may be delivered or furnished by electronic communication (including e-mail and Internet or intranet web sites) pursuant to procedures approved by the Administrative Agent. The Administrative Agent and the Borrower may, in their discretion, agree in a separate writing to accept notices and other communications to them hereunder by electronic communications pursuant to procedures approved by it, provided that approval of such procedures may be limited to particular notices or communications. Unless the Administrative Agent otherwise prescribes, (i) notices and other communications sent to an e-mail address shall be deemed received upon the sender's receipt of an acknowledgement from the intended recipient (such as by the "return receipt requested" function, as available, return e-mail or other written acknowledgement), provided that if such notice or other communication is not sent during the normal business hours of the recipient, such notice or communication shall be deemed to have been sent at the opening of business on the next Business Day for the recipient, and (ii) notices or communications posted to an Internet or intranet web site shall be deemed received upon the deemed receipt by the intended recipient at its e-mail address as described in the foregoing clause (i) of notification that such notice or communication is available and identifying the web site address therefor.

(d) <u>Change of Address, Etc.</u> Any party hereto may change its address or facsimile number for notices and other communications hereunder by notice to each of the other parties hereto in accordance with <u>Section 11.05(a)</u>.

Section 11.06 Successors and Assigns.

(a) <u>Successors and Assigns Generally</u>. This Agreement shall be binding upon and inure to the benefit of and be enforceable by the parties hereto and their respective successors and assigns; provided that, the Borrower may not assign or transfer any of its rights or obligations hereunder without the prior written consent of all the Lenders, provided, further, that any assignment or participation by a Lender of any of its rights and obligations hereunder shall be effected in accordance with this <u>Section 11.06</u>.

(b) <u>Participations</u>. Each Lender may at any time grant participations in any of its rights hereunder or under any of the Notes to an Eligible Assignee, an Eligible Participant or any other Person, provided that in the case of any such participation,

(i) the participant shall not have any rights under this Agreement or any of the other Loan Documents, including rights of consent, approval or waiver (the participant's rights against such Lender in respect of such participation to be those set forth in the agreement executed by such Lender in favor of the participant relating thereto),

(ii) such Lender's obligations under this Agreement (including, without limitation, its Commitments hereunder) shall remain unchanged,

(iii) such Lender shall remain solely responsible to the other parties hereto for the performance of such obligations,

(iv) such Lender shall remain the holder of the Obligations owing to it and of any Note issued to it for all purposes of this Agreement, and

(v) the Borrower, the Administrative Agent, and the other Lenders shall continue to deal solely and directly with the selling Lender in connection with such Lender's rights and obligations under this Agreement,

and, provided, further, that no Lender shall transfer, grant or sell any participation under which the participant shall have rights to approve any amendment to or waiver of this Agreement or any other Loan Document except to the extent (A) such participant is an Affiliate or an Approved Fund of the Lender granting the participations or (B) such amendment or waiver would (x) extend the final scheduled maturity of the date of any of the Loans in which such participant is participating, or reduce the rate or extend the time of payment of interest or Fees thereon (except in connection with a waiver of the applicability of any post-default increase in interest rates), or reduce the principal amount thereof, or increase such participant's participating interest in any Commitment over the amount thereof then in effect (it being understood that a waiver of any Default or Event of Default shall not constitute a change in the terms of any such Commitment), (y) release all or any substantial portion of the Collateral, or release any guarantor from its guaranty of any of the Obligations, except in accordance with the terms of the Loan Documents, or (z) consent to the assignment or transfer by the Borrower of any of its rights and obligations under this Agreement and, provided still further that each participant shall be entitled to the benefits of Section 3.03 with respect to its participation as if it was a Lender, except that a participant shall (i) only deliver the forms described in <u>Section 3.03(g)</u> to the Lender granting it such participation and (ii) not be entitled to receive any greater payment under Section 3.03(g) than the applicable Lender would have been entitled to receive absent the participation, except to the extent such entitlement to a greater payment arose from a Change in Law occurring after the participant became a participant hereunder.

In the event that any Lender sells participations in a Loan, such Lender shall, acting for this purpose as a non-fiduciary agent of the Borrower, maintain a register on which it enters the name of all participants in such Loan and the principal amount of (and stated interest on) the portion of such Loan that is the subject of the participation (the "Participant Register"). The entries in the Participant Register shall be conclusive absent manifest error, and each Borrower, the Administrative Agent and each Lender shall treat each person whose name is recorded in the Participant Register as the owner of the participation in question for all purposes of this Agreement notwithstanding any notice to the contrary. A Loan (and the registered note, if any, evidencing the same) may be participated in whole or in part only by registration of such participation on the Participant Register (and each registered note shall expressly so provide). Any participation of a Loan (and the registered note, if any, evidencing the same) may be effected only by the registration of such participation on the Participant Register. The Participant Register shall be available for inspection by the Borrower and any Lender at any reasonable time and from time to time upon reasonable prior notice; provided that, no Lender shall have any obligation to disclose all or any portion of the Participant Register (including the identity of any Participant or any information relating to a Participant's interest in any commitments, loans, letters of credit or its other obligations under any Loan Document) to any Person except to the extent that such disclosure is necessary to establish that such commitment, loan, letter of credit or other obligation is in registered form under Section 5f.103-1(c) of the United States Treasury Regulations. For the avoidance of doubt, the Administrative Agent (in its capacity as Administrative Agent) shall have no responsibility for maintaining a Participant Register.

(c) Assignments by Lenders.

(A) Any Lender may assign all, or if less than all, a fixed portion, of its Loans and/or Commitments and its rights and obligations hereunder to one or more Eligible Assignees, each of which shall become a party to this Agreement as a Lender by execution of an Assignment Agreement; provided that,

(1) except in the case of (x) an assignment of the entire remaining amount of the assigning Lender's Loans and/or Commitments or (y) an assignment to another Lender, an Affiliate of such Lender or an Approved Fund with respect to such Lender, the aggregate amount of the Commitment so assigned (which for this purpose includes the Loans outstanding thereunder) shall not be less than \$1,000,000 in the case of any assignment in respect of the Revolving Facility and \$1,000,000 in the case of any assignment in respect of the Term Loans;

(2) in the case of any assignment to an Eligible Assignee at the time of any such assignment the Lender Register shall be deemed modified to reflect the Commitments of such new Lender and of the existing Lenders;

(3) upon surrender of the old Notes, if any, upon request of the new Lender, new Notes will be issued, at the Borrower's expense, to such new Lender and to the assigning Lender, to the extent needed to reflect the revised Commitments;

(4) unless waived by the Administrative Agent, the Administrative Agent shall receive at the time of each such assignment, from the assigning or assignee Lender, the payment of a non-refundable assignment fee of \$3,500;

(5) the Administrative Agent's consent (which consent shall not be unreasonably withheld or delayed) shall be required for any assignment unless such assignment is to another Lender or an Affiliate of a Lender; and

(6) the Borrower's consent (which consent shall not be unreasonably withheld or delayed) shall be required for any assignment of Revolving Loans unless (x) an Event of Default has occurred and is continuing or (y) such assignment is to another Lender or an Affiliate of a Lender.

(B) To the extent of any assignment pursuant to this subpart (c), the assigning Lender shall be relieved of its obligations hereunder with respect to its assigned Commitments provided that, except to the extent otherwise expressly agreed by the affected parties, no assignment by a Defaulting Lender will constitute a waiver or release of any claim of any party hereunder arising from that Lender's having been a Defaulting Lender.

(C) At the time of each assignment pursuant to this subpart (c), to a Person that is not already a Lender hereunder and that is not a U.S. Person for Federal income tax purposes, the respective assignee Lender shall provide to the Borrower and the Administrative Agent the applicable Internal Revenue Service Forms (and any necessary additional documentation) described in <u>Section 3.03(g)</u>.

(D) With respect to any Lender, the transfer of any Commitment of such Lender and the rights to the principal of, and interest on, any Loan made pursuant to such Commitment shall not be effective until such transfer is recorded on the Lender Register maintained by the

Administrative Agent (on behalf of and acting solely for this purpose as a non-fiduciary agent of the Borrower) with respect to ownership of such Commitment and Loans, including the name and address of the Lenders and the principal amount of the Loans (and stated interest thereon). Prior to such recordation, all amounts owing to the transferor with respect to such Commitment and Loans shall remain owing to the transferor. The registration of assignment or transfer of all or part of any Commitments and Loans shall be recorded by the Administrative Agent on the Lender Register only upon the acceptance by the Administrative Agent of a properly executed and delivered Assignment Agreement pursuant to this subpart (c). The Lender Register shall be available for the inspection by the Borrower at any reasonable time and from time to time upon reasonable prior notice.

(E) Nothing in this Section shall prevent or prohibit (A) any Lender that is a bank, trust company or other financial institution from pledging its Notes or Loans to a Federal Reserve Bank or to any Person that extends credit to such Lender in support of borrowings made by such Lender from such Federal Reserve Bank or such other Person, or (B) any Lender that is a trust, limited liability company, partnership or other investment company from pledging its Notes or Loans to a trustee or agent for the benefit of holders of certificates or debt securities issued by it. No such pledge, or any assignment pursuant to or in lieu of an enforcement of such a pledge, shall relieve the transferor Lender from its obligations hereunder.

(F) In connection with any assignment of rights and obligations of any Defaulting Lender hereunder, no such assignment shall be effective unless and until, in addition to the other conditions thereto set forth herein, the parties to the assignment shall make such additional payments to the Administrative Agent in an aggregate amount sufficient, upon distribution thereof as appropriate (which may be outright payment, purchases by the assignee of participations or subparticipations, or other compensating actions, including funding, with the consent of the Borrower and the Administrative Agent, the applicable pro rata share of Loans previously requested but not funded by the Defaulting Lender, to each of which the applicable assignee and assignor hereby irrevocably consent), to (x) pay and satisfy in full all payment liabilities then owed by such Defaulting Lender to the Administrative Agent and each Lender hereunder (and interest accrued thereon), and (y) acquire (and fund as appropriate) its full pro rata share of all Loans in accordance with its Revolving Facility Percentage. Notwithstanding the foregoing, in the event that any assignment of rights and obligations of any Defaulting Lender hereunder shall become effective under applicable law without compliance with the provisions of this paragraph, then the assignee of such interest shall be deemed to be a Defaulting Lender for all purposes of this Agreement until such compliance occurs.

(d) <u>No SEC Registration or Blue Sky Compliance</u>. Notwithstanding any other provisions of this Section, no transfer or assignment of the interests or obligations of any Lender hereunder or any grant of participation therein shall be permitted if such transfer, assignment or grant would require the Borrower to file a registration statement with the SEC or to qualify the Loans under the "Blue Sky" laws of any State.

(e) <u>Representations of Lenders</u>. Each Lender initially party to this Agreement hereby represents, and each Person that becomes a Lender pursuant to an assignment permitted by this Section will, upon its becoming party to this Agreement, represents that it is a commercial lender, other financial institution or other "accredited" investor (as defined in SEC Regulation D) that makes or acquires loans in the ordinary course of its business and that it will make or acquire Loans for its own account in the ordinary course of such business; *provided that*, subject to the preceding <u>Section 11.06(b)</u> and (c), the disposition of any promissory notes or other evidences of or interests in Indebtedness held by such Lender shall at all times be within its exclusive control.

(f)Special Purpose Funding Vehicles. Notwithstanding anything to the contrary contained herein, any Lender ("Granting Lender") may grant to a special purpose funding vehicle (a "SPC"), identified as such in writing from time to time by the Granting Lender to the Administrative Agent and the Borrower, the option to provide to the Borrower all or any part of any Loan that such Granting Lender would otherwise be obligated to make to the Borrower pursuant to this Agreement; provided that (x) nothing herein shall constitute a commitment by any SPC to make any Loans and (y) if an SPC elects not to exercise such option or otherwise fails to provide all or any part of such Loan, the Granting Lender shall be obligated to make such Loan pursuant to the terms hereof. The making of a Loan by an SPC hereunder shall utilize the Commitment of the Granting Lender to the same extent, and as if, such Loan were made by such Granting Lender. Each party hereto hereby agrees that no SPC shall be liable for any indemnity or similar payment obligation under this Agreement (all liability for which shall remain with the Granting Lender). In furtherance of the foregoing, each party hereto hereby agrees (which agreement shall survive the termination of this Agreement) that, prior to the date that is one year and one day after the payment in full of all outstanding commercial paper or other senior indebtedness of any SPC, it will not institute against, or join any other person in instituting against, such SPC any bankruptcy, reorganization, arrangement, insolvency or liquidation proceedings under the laws of the United States or any State thereof. In addition, notwithstanding anything to the contrary contained in this clause, any SPC may (i) with notice to, but without the prior written consent of, the Borrower or the Administrative Agent and without paying any processing fee therefor, assign all or a portion of its interests in any Loans to the Granting Lender or to any financial institutions (consented to by the Borrower and the Administrative Agent) providing liquidity and/or credit support to or for the account of such SPC to support the funding or maintenance of Loans and (ii) disclose on a confidential basic any non-public information relating to its Loans to any rating agency, commercial paper dealer or provider of any surety, guarantee or credit or liquidity enhancement to such SPC. This may not be amended without the written consent of the SPC. The Borrower acknowledges and agrees, subject to the next sentence, that, to the fullest extent permitted under applicable law, each SPC, for purposes of Sections 2.08, 2.12, 3.01, 3.03, 11.01, 11.02 and 11.03, shall be considered a Lender.

Section 11.07 <u>No Waiver; Remedies Cumulative</u>. No failure or delay on the part of the Administrative Agent or any Lender in exercising any right, power or privilege hereunder or under any other Loan Document and no course of dealing between the Borrower and the Administrative Agent or any Lender shall operate as a waiver thereof; nor shall any single or partial exercise of any right, power or privilege hereunder or under any other Loan Document preclude any other or further exercise thereof or the exercise of any other right, power or privilege hereunder. No notice to or demand on the Borrower in any case shall entitle the Borrower to any other or further notice or demand in similar or other circumstances or constitute a waiver of the rights of the Administrative Agent or the Lenders to any other or further action in any circumstances without notice or demand. Without limiting the generality of the foregoing, the making of a Loan shall not be construed as a waiver of any Default or Event of Default, regardless of whether the Administrative Agent or any Lender may have had notice or knowledge of such Default or Event of Default at the time. The rights and remedies herein expressly provided are cumulative and not exclusive of any rights or remedies that the Administrative Agent or any Lender would otherwise have.

Section 11.08 Governing Law; Submission to Jurisdiction; Venue; Waiver of Jury Trial.

(a) THIS AGREEMENT AND EACH OTHER LOAN DOCUMENT (EXCEPT AS OTHERWISE EXPRESSLY SET FORTH IN A LOAN DOCUMENT) AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER AND THEREUNDER SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK. (b) EACH CREDIT PARTY HEREBY IRREVOCABLY CONSENTS TO THE NON-EXCLUSIVE JURISDICTION OF ANY UNITED STATES FEDERAL OR NEW YORK STATE COURT SITTING IN NEW YORK CITY IN ANY LITIGATION OR OTHER PROCEEDING BASED HEREON, OR ARISING OUT OF, UNDER, OR IN CONNECTION WITH, ANY LOAN DOCUMENT, OR ANY COURSE OF CONDUCT, COURSE OF DEALING, STATEMENTS (WHETHER ORAL OR WRITTEN) OR ACTIONS OF THE ADMINISTRATIVE AGENT, THE LENDERS OR THE CREDIT PARTIES IN CONNECTION HEREWITH OR THEREWITH; PROVIDED THAT, ANY SUIT SEEKING ENFORCEMENT AGAINST ANY COLLATERAL OR OTHER PROPERTY MAY BE BROUGHT, AT THE ADMINISTRATIVE AGENT'S OPTION, IN THE COURTS OF ANY JURISDICTION WHERE SUCH COLLATERAL OR OTHER PROPERTY MAY BE FOUND; PROVIDED, FURTHER, THAT NOTHING HEREIN SHALL LIMIT THE RIGHT OF THE ADMINISTRATIVE AGENT OR ANY LENDER TO BRING PROCEEDINGS AGAINST ANY CREDIT PARTY IN THE COURTS OF ANY OTHER JURISDICTION.

EACH CREDIT PARTY IRREVOCABLY CONSENTS TO THE SERVICE OF (c)PROCESS BY REGISTERED MAIL, POSTAGE PREPAID, OR BY PERSONAL SERVICE WITHIN OR WITHOUT THE STATE OF NEW YORK AT THE ADDRESS FOR NOTICES SPECIFIED IN SECTION 11.05. EACH CREDIT PARTY HEREBY EXPRESSLY AND IRREVOCABLY WAIVES. TO THE FULLEST EXTENT PERMITTED BY LAW, ANY OBJECTION THAT IT MAY HAVE OR HEREAFTER MAY HAVE TO THE LAYING OF VENUE OF ANY SUCH LITIGATION BROUGHT IN ANY SUCH COURT REFERRED TO IN CLAUSE (b) ABOVE AND ANY CLAIM THAT ANY SUCH LITIGATION HAS BEEN BROUGHT IN AN INCONVENIENT FORUM. TO THE EXTENT THAT ANY CREDIT PARTY HAS OR HEREAFTER MAY ACQUIRE ANY IMMUNITY FROM JURISDICTION OF ANY COURT OR FROM ANY LEGAL PROCESS WHETHER THROUGH SERVICE OR NOTICE, ATTACHMENT PRIOR TO JUDGMENT, ATTACHMENT IN AID OF EXECUTION OR OTHERWISE) WITH RESPECT TO ITSELF OR ITS PROPERTY, SUCH CREDIT PARTY HEREBY IRREVOCABLY WAIVES TO THE FULLEST EXTENT PERMITTED BY LAW SUCH IMMUNITY IN RESPECT OF ITS OBLIGATIONS UNDER THE LOAN DOCUMENTS. EACH CREDIT PARTY HEREBY WAIVES, TO THE MAXIMUM EXTENT NOT PROHIBITED BY LAW, ANY RIGHT THAT IT MAY HAVE TO CLAIM OR RECOVER IN ANY LEGAL ACTION OR PROCEEDING REFERRED TO IN THIS SECTION ANY SPECIAL, EXEMPLARY, PUNITIVE OR CONSEQUENTIAL DAMAGES.

(d) THE ADMINISTRATIVE AGENT, EACH LENDER AND EACH CREDIT PARTY HEREBY KNOWINGLY, VOLUNTARILY AND INTENTIONALLY WAIVE TO THE FULLEST EXTENT PERMITTED BY LAW ANY RIGHTS IT MAY HAVE TO A TRIAL BY JURY IN RESPECT OF ANY LITIGATION BASED HEREON, OR ARISING OUT OF, UNDER, OR IN CONNECTION WITH, ANY LOAN DOCUMENT, OR ANY COURSE OF CONDUCT, COURSE OF DEALING, STATEMENTS (WHETHER ORAL OR WRITTEN) OR ACTIONS OF THE ADMINISTRATIVE AGENT, SUCH LENDER OR SUCH CREDIT PARTY IN CONNECTION THEREWITH. EACH CREDIT PARTY ACKNOWLEDGES AND AGREES THAT IT HAS RECEIVED FULL AND SUFFICIENT CONSIDERATION FOR THIS PROVISION (AND EACH OTHER PROVISION OF EACH OTHER LOAN DOCUMENT TO WHICH IT IS A PARTY) AND THAT THIS PROVISION IS A MATERIAL INDUCEMENT FOR THE ADMINISTRATIVE AGENT AND EACH LENDER ENTERING INTO THE LOAN DOCUMENTS.

Section 11.09 <u>Counterparts</u>. This Agreement may be executed in any number of counterparts and by the different parties hereto on separate counterparts, each of which when so executed and delivered shall be an original, but all of which shall together constitute one and the same agreement. A set of counterparts executed by all the parties hereto shall be lodged with the Borrower and the Administrative Agent.

Section 11.10 <u>Integration</u>. This Agreement, the other Loan Documents and any separate letter agreements with respect to fees payable to the Administrative Agent, for its own account and benefit and/or for the account, benefit of, and distribution to, the Lenders, constitute the entire contract among the parties relating to the subject matter hereof and thereof and supersede any and all previous agreements and understandings, oral or written, relating to the subject matter hereof or thereof. To the extent that there is any conflict between the terms and provisions of this Agreement and the terms and provisions of any other Loan Document, the terms and provisions of this Agreement will prevail.

Section 11.11 <u>Headings Descriptive</u>. The headings of the several Sections and other portions of this Agreement are inserted for convenience only and shall not in any way affect the meaning or construction of any provision of this Agreement.

Section 11.12 Amendment or Waiver; Acceleration by Required Lenders.

(a) Neither this Agreement nor any other Loan Document, nor any terms hereof or thereof, may be amended, changed, waived or otherwise modified unless such amendment, change, waiver or other modification is in writing and signed by the Borrower, the Administrative Agent and the Required Lenders or by the Administrative Agent acting at the written direction of the Required Lenders; provided that,

(A) no change, waiver or other modification shall:

(1) increase the amount of any Commitment of any Lender hereunder, without the written consent of such Lender;

(2) extend or postpone the Termination Date or extend or postpone any scheduled expiration or termination date provided for herein that is applicable to a Commitment of any Lender, without the written consent of such Lender;

(3) reduce the principal amount of any Loan made by any Lender, or reduce the rate or extend, defer or delay the time of payment of, or excuse the payment of, principal or interest thereon (other than as a result of (x) waiving the applicability of any post-default increase in interest rates or (y) any amendment or modification of defined terms used in financial covenants), without the written consent of such Lender; or

(4) reduce the rate or extend the time of payment of, or excuse the payment of, any Fees to which any Lender is entitled hereunder, without the written consent of such Lender; and

(B) no change, waiver or other modification or termination shall, without the written consent of each Lender affected thereby,

(1) release the Borrower from any of its obligations hereunder;

(2) release any Credit Party from the Guaranty, except, in the case of a Subsidiary Guarantor, in accordance with a transaction permitted under this Agreement;

(3) release all or substantially all of the Collateral, except in connection with a transaction permitted under this Agreement;

(4) amend, modify or waive any provision of this <u>Section 11.12</u>, <u>Section 8.03</u>, <u>Section 11.04</u> or any other provision of any of the Loan Documents pursuant to which the consent or approval of all Lenders, or a number or specified percentage or other required grouping of Lenders or Lenders having Commitments, is by the terms of such provision explicitly required;

(5) reduce the percentage specified in, or otherwise modify, the definition of Required Lenders;

(6) consent to the assignment or transfer by the Borrower of any of its rights and obligations under this Agreement; or

(7) amend, modify or waive any provision of Section 2.05(b), Section 2.12(b) or Section 2.12(e).

Any waiver or consent with respect to this Agreement given or made in accordance with this Section shall be effective only in the specific instance and for the specific purpose for which it was given or made.

(b) No provision of <u>Article IX</u> may be amended without the consent of the Administrative Agent.

(c) To the extent (i) the Required Lenders consent to any sale, transfer or other disposition of any Collateral otherwise prohibited under this Agreement, (A) such Collateral (but not any proceeds thereof) shall be sold, transferred or disposed of free and clear of the Liens set forth in <u>Section 2.15</u>; (B) if such Collateral includes all of the capital stock of a Subsidiary that is a party to the Guaranty or whose stock is pledged pursuant to the Liens set forth in <u>Section 2.15</u>, such capital stock (but not any proceeds thereof) shall be released from Liens set forth in <u>Section 2.15</u> and such Subsidiary shall be released from the Guaranty; and (C) the Administrative Agent shall be authorized to take actions deemed appropriate by it in order to effectuate the foregoing.

In no event shall the Required Lenders, without the prior written consent of each (d)Lender, direct the Administrative Agent to accelerate and demand payment of the Loans held by one Lender without accelerating and demanding payment of all other Loans or to terminate the Commitments of one or more Lenders without terminating the Commitments of all Lenders. Each Lender agrees that, except as otherwise provided in any of the Loan Documents and without the prior written consent of the Required Lenders, it will not take any legal action or institute any action or proceeding against any Credit Party with respect to any of the Obligations or Collateral, or accelerate or otherwise enforce its portion of the Obligations. Without limiting the generality of the foregoing, none of Lenders may exercise any right that it might otherwise have under applicable law to credit bid at foreclosure sales, uniform commercial code sales or other similar sales or dispositions of any of the Collateral except as authorized by the Required Lenders. Notwithstanding anything to the contrary set forth in this Section 11.12(e) or elsewhere herein, each Lender shall be authorized to take such action to preserve or enforce its rights against any Credit Party where a deadline or limitation period is otherwise applicable and would, absent the taking of specified action, bar the enforcement of Obligations held by such Lender against such Credit Party, including the filing of proofs of claim in any insolvency proceeding.

(e) Notwithstanding anything to the contrary contained in this <u>Section 11.12</u>, (x) Loan Documents and related documents executed by Subsidiaries of the Borrower in connection with this Agreement may be in a form reasonably determined by the Administrative Agent and may be amended, supplemented and waived with the consent of the Administrative Agent and the Borrower without the need to obtain the consent of any other Person if such amendment, supplement or waiver is

delivered in order (i) to comply with local law or advice of local counsel, (ii) to cure ambiguities, omissions, mistakes or defects or (iii) to cause such Loan Document or other document to be consistent with this Agreement and the other Loan Documents and (y) if following the Closing Date, the Administrative Agent and the Borrower shall have jointly identified an ambiguity, inconsistency, obvious error or any error or omission of a technical or immaterial nature, in each case, in any provision of the Loan Documents, then the Administrative Agent and the Credit Parties shall be permitted to amend such provision and such amendment shall become effective without any further action or consent of any other party to any Loan Documents if the same is not objected to in writing by the Required Lenders within five (5) Business Days following receipt of notice thereof.

(f) Notwithstanding the provisions of <u>Section 11.12(a)</u>, this Agreement may be amended (or amended and restated) with the written consent of the Required Lenders, the Administrative Agent and the Credit Parties (i) to add one or more additional credit facilities to this Agreement and to permit the extensions of credit from time to time thereunder and the accrued interest and fees in respect thereof to share ratably in the benefits of this Agreement and the other Loan Documents with the Term Loans and the Revolving Loans and the accrued interest and fees in respect thereof, and (ii) to include appropriately the Lenders holding such credit facilities in any determination of the Required Lenders

If, in connection with any proposed amendment, modification, termination, (g) waiver or consent with respect to any provisions hereof as contemplated by this Section 11.12 that requires the consent of a greater percentage of the Lenders than the Required Lenders, the consent of the Required Lenders shall have been obtained but the consent of a Lender whose consent is required shall not have been obtained (each a "Non-Consenting Lender"), then the Borrower may, at its sole expense and effort, upon notice to such Lender and the Administrative Agent, require such Lender to assign and delegate, without recourse (in accordance with the restrictions contained in Section 11.04(c)), all its interests, rights and obligations under this Agreement to an Eligible Assignee that shall assume such obligations; provided that (A) the Borrower shall have received the prior written consent of the Administrative Agent, which consent shall not be unreasonably withheld or delayed, (B) such Lender shall have received payment of an amount equal to the outstanding principal of its Loans, accrued interest thereon, accrued fees and all other amounts payable to it hereunder, from the assignee (to the extent of such outstanding principal and accrued interest and fees) or the Borrower (in the case of all other amounts, including any breakage compensation under Section 3.02 and any amounts accrued and owing to such Lender under Section 3.01(a)(i), Section 3.01(c), Section 3.03 or Section 3.04), and (C) such Eligible Assignee shall consent at the time of such assignment to each matter in respect of which such Non-Consenting Lender did not consent. Each Lender agrees that, if it becomes a Non-Consenting Lender and is being replaced in accordance with this Section 11.12(g), it shall execute and deliver to the Administrative Agent an Assignment Agreement to evidence such assignment and shall deliver to the Administrative Agent any Notes previously delivered to such Non-Consenting Lender. A Lender shall not be required to make any such assignment and delegation if, prior thereto, as a result of a waiver by such Lender or otherwise, the circumstances entitling the Borrower to require such assignment and delegation cease to apply.

Section 11.13 <u>Survival of Indemnities</u>. All indemnities set forth herein including, without limitation, in <u>Article III</u>, <u>Section 9.09</u> or <u>Section 11.02</u> shall survive the execution and delivery of this Agreement and the making and repayment of the Obligations.

Section 11.14 <u>Domicile of Loans</u>. Each Lender may transfer and carry its Loans at, to or for the account of any branch office, subsidiary or affiliate of such Lender; provided that, the Borrower shall not be responsible for costs arising under <u>Section 3.01</u> resulting from any such transfer (other than a transfer pursuant to <u>Section 3.05</u>) to the extent not otherwise applicable to such Lender prior to such transfer.

Section 11.15 Confidentiality.

Each of the Administrative Agent and the Lenders agrees to maintain the (a) confidentiality of the Confidential Information, except that Confidential Information may be disclosed (1) to its and its Affiliates' directors, officers, employees and agents, including accountants, legal counsel and other advisors (it being understood that the persons to whom such disclosure is made will be informed of the confidential nature of such Confidential Information and instructed to keep such Confidential Information confidential), (2) to any direct or indirect contractual counterparty in any Hedge Agreement (or to any such contractual counterparty's professional advisor), so long as such contractual counterparty (or such professional advisor) agrees to be bound by the provisions of this Section, (3) to the extent requested by any regulatory authority, (4) to the extent required by applicable laws or regulations or by any subpoena or similar legal process, (5) to any other party to this Agreement, (6) to any other creditor of any Credit Party that is a direct or intended beneficiary of any of the Loan Documents, (7) in connection with the exercise of any remedies hereunder or under any of the other Loan Documents, or any suit, action or proceeding relating to this Agreement or any of the other Loan Documents or the enforcement of rights hereunder or thereunder, (8) subject to an agreement containing provisions substantially the same as those of this Section, to any assignee of or participant in any of its rights or obligations under this Agreement, or in connection with transactions permitted pursuant to Section 11.06(c)(v) or Section 11.06(f), (9) with the consent of the Borrower, or (10) to the extent such Confidential Information (i) becomes publicly available other than as a result of a breach of this Section 11.15, or (ii) becomes available to the Administrative Agent or any Lender on a non-confidential basis from a source other than a Credit Party and not otherwise in violation of this Section 11.15.

(b) As used in this Section, "Confidential Information" shall mean all information received from the Borrower relating to the Borrower or its business, other than any such information that is available to the Administrative Agent or any Lender on a non-confidential basis prior to disclosure by the Borrower; provided that, in the case of information received from the Borrower after the Closing Date, such information is clearly identified at the time of delivery as confidential.

(c) Any Person required to maintain the confidentiality of Confidential Information as provided in this Section shall be considered to have complied with its obligation to do so if such Person has exercised the same degree of care to maintain the confidentiality of such Confidential Information as such Person would accord to its own confidential information. The Borrower hereby agrees that the failure of the Administrative Agent or any Lender to comply with the provisions of this Section shall not relieve the Borrower, or any other Credit Party, of any of its obligations under this Agreement or any of the other Loan Documents.

Section 11.16 <u>General Limitation of Liability</u>. No claim may be made by any Credit Party, any Lender, the Administrative Agent or any other Person against the Administrative Agent or any other Lender or the Affiliates, directors, officers, employees, attorneys or agents of any of them for any damages other than actual compensatory damages in respect of any claim for breach of contract or any other theory of liability arising out of or related to the transactions contemplated by this Agreement or any of the other Loan Documents, or any act, omission or event occurring in connection therewith; and the Borrower, each Lender and the Administrative Agent hereby, to the fullest extent permitted under applicable law, waive, release and agree not to sue or counterclaim upon any such claim for any special, consequential or punitive damages, whether or not accrued and whether or not known or suspected to exist in their favor.

Section 11.17 <u>No Duty</u>. All attorneys, accountants, appraisers, consultants and other professional persons (including the firms or other entities on behalf of which any such Person may act) retained by the Administrative Agent or any Lender with respect to the transactions contemplated by the

Loan Documents shall have the right to act exclusively in the interest of the Administrative Agent or such Lender, as the case may be, and shall have no duty of disclosure, duty of loyalty, duty of care, or other duty or obligation of any type or nature whatsoever to the Borrower, to any of its Subsidiaries, or to any other Person, with respect to any matters within the scope of such representation or related to their activities in connection with such representation. The Borrower agrees, on behalf of itself and its Subsidiaries, not to assert any claim or counterclaim against any such persons with regard to such matters, all such claims and counterclaims, now existing or hereafter arising, whether known or unknown, foreseen or unforeseeable, being hereby waived, released and forever discharged.

Section 11.18 <u>Lenders and Agent Not Fiduciary to Borrower, etc.</u> The relationship among the Borrower and its Subsidiaries, on the one hand, and the Administrative Agent and the Lenders, on the other hand, is solely that of debtor and creditor, and the Administrative Agent and the Lenders have no fiduciary or other special relationship with the Borrower and its Subsidiaries, and no term or provision of any Loan Document, no course of dealing, no written or oral communication, or other action, shall be construed so as to deem such relationship to be other than that of debtor and creditor.

Section 11.19 <u>Survival of Representations and Warranties</u>. All representations and warranties herein shall survive the making of Loans hereunder, the execution and delivery of this Agreement, the Notes and the other documents the forms of which are attached as Exhibits hereto, the issue and delivery of the Notes, any disposition thereof by any holder thereof, and any investigation made by the Administrative Agent or any Lender or any other holder of any of the Notes or on its behalf. All statements contained in any certificate or other document delivered to the Administrative Agent or any Lender or any behalf of the Borrower or any of its Subsidiaries pursuant hereto or otherwise specifically for use in connection with the transactions contemplated hereby shall constitute representations and warranties by the Borrower hereunder, made as of the respective dates specified therein or, if no date is specified, as of the respective dates furnished to the Administrative Agent or any Lender.

Section 11.20 <u>Severability</u>. Any provision of this Agreement held to be invalid, illegal or unenforceable in any jurisdiction shall, as to such jurisdiction, be ineffective to the extent of such invalidity, illegality or unenforceability without affecting the validity, legality and enforceability of the remaining provisions hereof; and the invalidity of a particular provision in a particular jurisdiction shall not invalidate such provision in any other jurisdiction.

Section 11.21 Interest Rate Limitation. Notwithstanding anything herein to the contrary, if at any time the interest rate applicable to any Loan, together with all fees, charges and other amounts that are treated as interest on such Loan under applicable law (collectively, the "Charges"), shall exceed the maximum lawful rate (the "Maximum Rate") that may be contracted for, charged, taken, received or reserved by the Lender holding such Loan in accordance with applicable law, the rate of interest payable in respect of such Loan hereunder, together with all Charges payable in respect thereof, shall be limited to the Maximum Rate and, to the extent lawful, the interest and Charges that would have been payable in respect of such Loan but were not payable as a result of the operation of this Section shall be cumulated and the interest and Charges payable to such Lender in respect of other Loans or periods shall be increased (but not above the Maximum Rate therefor) until such cumulated amount, together with interest thereon at the Base Rate to the date of repayment, shall have been received by such Lender.

Section 11.22 <u>USA Patriot Act</u>. Each Lender subject to the USA Patriot Act hereby notifies the Borrower that pursuant to the requirements of the USA Patriot Act, it is required to obtain, verify and record information that identifies the Borrower, which information includes the name and address of the Borrower and other information that will allow such Lender to identify the Borrower in accordance with the USA Patriot Act.

Section 11.23 <u>Advertising and Publicity</u>. No Credit Party shall issue or disseminate to the public (by advertisement, including without limitation any "tombstone" advertisement, press release or otherwise), submit for publication or otherwise cause or seek to publish any information describing the credit or other financial accommodations made available by the Lenders pursuant to this Agreement and the other Loan Documents without the prior written consent of the Administrative Agent. Nothing in the foregoing shall be construed to prohibit any Credit Party from making any submission or filing which it is required to make by applicable law or pursuant to judicial process; provided that, (i) such filing or submission shall contain only such information as is necessary to comply with applicable law or judicial process and (ii) unless specifically prohibited by applicable law or court order, the Borrower shall promptly notify the Administrative Agent of the requirement to make such submission or filing and provide the Administrative Agent with a copy thereof.

Section 11.24 Release of Guarantees and Liens. Notwithstanding anything to the contrary contained herein or in any other Loan Document, the Administrative Agent is hereby irrevocably authorized by each Lender (without requirement of notice to or consent of any Lender) to take any action requested by the Borrower having the effect of releasing any Collateral or guarantee obligations (i) to the extent necessary to permit consummation of any transaction permitted by any Loan Document or that has been consented to in accordance with the terms hereof or (ii) under the circumstances described in the next succeeding sentence. When this Agreement has been terminated and all of the Obligations have been fully and finally discharged (other than contingent indemnity obligations) and the obligations of the Administrative Agent and the Lenders to provide additional credit under the Loan Documents have been terminated irrevocably, and the Credit Parties have delivered to the Administrative Agent a written release of all claims against the Administrative Agent and the Lenders, in form and substance satisfactory to the Administrative Agent, the Administrative Agent will, at the Borrower's sole expense, execute and deliver any termination statements, lien releases, mortgage releases, re-assignments of intellectual property, discharges of security interests, and other similar discharge or release documents (and, if applicable, in recordable form) as are necessary or advisable to release, as of record, the Administrative Agent's Liens and all notices of security interests and liens previously filed by the Administrative Agent with respect to the Obligations.

Section 11.25 <u>Payments Set Aside</u>. To the extent that any Lender receives a payment from or on behalf of the Borrower or any other Credit Party, from the proceeds of any Collateral, from the exercise of its rights of setoff, any enforcement action or otherwise, and such payment is subsequently, in whole or in part, invalidated, declared to be fraudulent or preferential, set aside or required to be repaid to a trustee, receiver or any other party, then to the extent of such recovery, the obligations or part thereof originally intended to be satisfied, and all Liens, rights and remedies therefor, shall be revived and continued in full force and effect as if such payment had not occurred.
