



4. The Claimant reserves all rights and remedies which it may have, in addition to filing of and in pursuit of this Proof of Claim, against any other person or entity, including (without limitation): (i) rights against indemnitors, other guarantors, successors in interest, agents or directors or officers, and (ii) the right to assert any of the matters asserted herein by way of defense, counterclaim, offset, or recoupment against any claim asserted against the Claimant by the Debtor or any representative or affiliate thereof or successors thereto.

5. The Claimant reserves all rights available to it by applicable law or rule to amend the Proof of Claim based upon additional facts and circumstances giving rise to additional claims

and upon claims that are presently contingent becoming fixed and upon determination of liquidated amounts for the portions of claims made hereunder which are not presently liquidated.
