**NOTICE OF HEARING ON
CONFIRMATION OF PLAN THAT
PROVIDES FOR AN INJUNCTION
PURSUANT TO FED. R. BANKR. P.
2002(c)(3)**

NOTICE IS HEREBY GIVEN, pursuant to Federal Rule of Bankruptcy Procedure 2002(c)(3), that section 10.1 of Debtors’ and the Committee’s Second Amended Joint Plan of Liquidation [ECF No. 976] (the “Plan”) contains the following injunction:

Except as otherwise provided in the Plan or in the Confirmation Order, confirmation of the Plan shall act as a permanent injunction applicable to entities against (a) the commencement or continuation, including the issuance or employment of process, of a judicial, administrative, or other action or proceeding against Debtors, or any of Debtors, or the Released Parties that was or could have been commenced against Debtors or the Released Parties before entry of the Confirmation Order, excepting from such injunction any affirmative defense asserted by a director, officer or former director or officer in any action filed by Debtor or Debtors’ estates; (b) the enforcement against the Released Parties or Debtors or their assets of a judgment obtained before the Petition Date; and (c) any act to obtain possession of or to exercise control over, or to create, perfect, or enforce a lien upon all or any part of the assets of the Consolidated Debtors.

Capitalized terms in the above provision are defined in the text of the Plan. The hearing on confirmation of the Plan, at which testimony will be received if offered and admissible, will be held via telephone on **11/6/20 at 09:30 AM, Call in Number: (888) 684-8852, Access Code: 1238244**. Participants must comply with telephone hearing requirements and deadlines as listed on the separately served Order Approving Disclosure Statement and Fixing Time for Filing Acceptances or Rejections of Plan; and Notice of Confirmation Hearing [ECF No. 985].
