WITHDRAWAL OF OBJECTION TO PROOF OF CLAIM NOS. 135 & 136

Allison Byman, Plan Administrator for Nuvectra Corporation (the “Plan Administrator”), hereby gives notice that she is withdrawing her Objection (defined below) to Proof of Claim Nos. 135 & 136 filed by the Oregon Department of Revenue (“Claimant”) (Claimant and Plan Administrator are collectively referred to as the “Parties”):

WHEREAS, on July 6, 2020, Claimant filed Proof of Claim Nos. 135 & 136 in the above entitled case asserting claims based on taxes owed; and

WHEREAS, on June 25, 2021, the Plan Administrator filed its Omnibus Objection to Late Filed Claims, which objected to Claimant’s Proof of Claim Nos. 135 & 136 (the “Objection”) [Docket No. 427]; and

WHEREAS, Proof of Claim No. 135 asserted a claim for \$3,686.19. Claimant asserted that \$3,636.19 was entitled to priority under §507(a)(8) and asserted \$50.00 as a general unsecured claim. On August 3, 2021, Claimant filed Proof of Claim No. 147 which amended Proof of Claim No. 135 to reflect that Claimant had a claim for \$0.00. Therefore, the Plan Administrator wishes to withdraw the Objection to Proof of Claim No. 135 and allow the claim as a general unsecured claim in the amount of \$0.00 (as reflected in Proof of Claim No. 147); and

WHEREAS, Proof of Claim No. 136 asserted a claim for \$7,947.39 and asserted that the entire amount was entitled to administrative priority for taxes arising post-petition. On August 3, 2021, Claimant filed Proof of Claim No. 146 which amended Proof of Claim No. 136 to reflect that Claimant had an administrative claim for \$113.30. Therefore, the Plan Administrator wishes to withdraw the Objection to Proof of Claim No. 136 and allow the claim as an administrative priority claim in the amount of \$113.30 (as reflected in Proof of Claim No. 146).

NOW, THEREFORE, the Plan Administrator gives notice that she has withdrawn her Objection to Proof of Claim Nos. 135 & 136 and the claims should be allowed as amended by Proof of Claim Nos. 146 & 147.
