FOURTH INTERIM AND FINAL APPLICATION OF BERKELEY RESEARCH GROUP, LLC FOR COMPENSATION FOR SERVICES RENDERED AND REIMBURSEMENT OF EXPENSES INCURRED AS FINANCIAL ADVISOR TO THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS DURING THE PERIOD FROM MARCH 27, 2018 THROUGH MAY 31, 2019

Berkeley Research Group, LLC ("BRG"), financial advisor to the Official Committee of Unsecured Creditors (the "Committee") of the above-captioned debtor and debtor-in-possession (collectively, the "Debtor"), hereby submits its fourth interim and final fee application (the "Application") for an order pursuant to sections 105(a), 330 and 331 chapter 11 of title 11 of the United States Code (the "Bankruptcy Code"), Rule 2016 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), Rule 2016-2 of the Local Rules of Bankruptcy Practice and Procedure for the United States Bankruptcy Court of the District of Delaware (the "Local Rules"), the Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals (the "Interim Compensation Order"), entered April 17, 2018, and the United States Trustee's Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses of Expenses filed under 11 U.S.C. § 330, effective January 30, 1996 (the "U.S. Trustee Guidelines")

seeking (a) the allowance of reasonable compensation for professional services rendered by BRG to the Committee during the period from December 1, 2018 through May 31, 2019 (the "Interim Fee Period")², (b) the allowance of reasonable compensation for professional services rendered by BRG to the Committee during the period from March 27, 2018 through May 31, 2019 (the "Final Fee Period"), and (c) reimbursement of actual and necessary charges and disbursements incurred by BRG during the Final Fee Period in the rendition of required professional services on behalf of the Committee. In support of this Application, BRG represents as follows:

JURISDICTION

- 1. The United States Bankruptcy Court for the District of Delaware (the "Court") has jurisdiction over the Application pursuant to 28 U.S.C. §§ 157 and 1334 and the *Amended Standing Order of Reference from the United States District Court for The District of Delaware*, dated February 29, 2012. Venue is proper in this district pursuant to 28 U.S.C. §§ 1408 and 1409. This is a core proceeding pursuant to 28 U.S.C. § 157(b)(2)(A).
- 2. The statutory bases for the relief requested herein are sections 105(a), 330, 331, and 503(b) of the Bankruptcy Code and Bankruptcy Rule 2016.

BACKGROUND

3. On March 12, 2018 (the "<u>Petition Date</u>"), the Debtor filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code with the Court (the "<u>Case</u>"). The Debtor is authorized to continue to operate its business and manage its properties as debtor-in-possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. No trustee or examiner has been appointed in this case.

- 4. On March 27, 2018, (the "Formation Date"), the Office of the United States Trustee for the District of Delaware (the "U.S. Trustee") appointed three of the Debtor's unsecured creditors to serve as members of the Committee. The Committee is presently comprised of the following members: (i) Wilmington Savings Fund Society, FSB as Indenture Trustee, (ii) McKesson, Specialty Health, and (iii) Young & Rubicam, LLC.
- 5. On the Formation Date, the Committee selected BRG to serve as its financial advisor. The Committee has also selected Irell & Manella LLP and Elliott Greenleaf P.C. (together, "Counsel") to serve as its counsel and Delaware counsel respectively. On May 15, 2018, the Court entered an order approving the retention of BRG *nunc pro tunc* to March 27, 2018.
- 6. On March 6, 2019, the Debtor filed the *Debtor's Plan of Liquidation* and concurrently filed the related Disclosure Statement (together the "<u>Plan</u>"). The Plan was subsequently amended, and on May 17, 2019 the Court entered an order confirming the Plan. On May 31, 2019, the effective date of the Plan occurred (the "<u>Effective Date</u>").

FEE PROCEDURES ORDER

7. On April 17, 2018, this Court signed the Interim Compensation Order. Pursuant to the Interim Compensation Order, on or after the fifteenth (15) day of each full calendar month (the "Fee Filing Period") following the month for which compensation and reimbursement is sought (the "Compensation Period"), each Professional seeking interim compensation may file with the Court a monthly application (each a "Monthly Fee Application") pursuant to section 331 of the Bankruptcy Code for interim approval and allowance of compensation for services rendered and reimbursement of expenses during the Compensation Period. Each Notice Party shall have fourteen (14) days after service of a Monthly Fee Application to review the Monthly Fee Application and object thereto (the "Objection Deadline"). Upon the expiration of the Objection Deadline, if no objections have been filed, the Professional shall file a certificate of no objection

and the Debtor shall then be authorized to pay such Professional eighty percent (80%) of the fees and one hundred percent (100%) of the expenses requested in the Monthly Fee Application not subject to an objection.

SUMMARY OF SERVICES RENDERED

- 8. BRG is a global strategic advisory and expert consulting firm that provides independent expert testimony, litigation and regulatory support, authoritative studies, strategic advice, advisory services relating to restructuring and turnaround, due diligence, valuation, and capital markets, and document and data analytics to major law firms, Fortune 500 corporations, government agencies, and regulatory bodies around the world.
- 9. Since being retained by the Committee, BRG has rendered professional services to the Committee as requested and as necessary and appropriate in furtherance of the interests of the unsecured creditors of the Debtor's estate. BRG respectfully submits that the professional services that it rendered on behalf of the Committee were necessary and have directly benefited the creditor constituents represented by the Committee and have contributed to the effective administration of these cases.
- 10. BRG submits that the interim and final fees applied for herein for professional services rendered in performing services for the Committee in this proceeding are fair and reasonable in view of the time spent, the extent of work performed, the nature of the Debtor's capitalization structure and financial condition, the Debtor's financial accounting resources and the results obtained. BRG's fees typically are based on the actual hours charged at BRG's standard hourly rates, which are in effect when the services are rendered
- 11. BRG expended an aggregate of 17.3 hours during the Interim Fee Period and 585.0 hours during the Final Fee Period, substantially all of which was expended by the professional staff of BRG. The work involved, and thus the time expended, was carefully assigned in light of

the experience and expertise required for a particular task. A small staff was utilized to optimize efficiencies and avoid redundant efforts. The staff of the Debtor or its advisors has been utilized where practical and prudent.

- 12. BRG believes that there has been no duplication of services between BRG and any other consultants or accountants to the bankruptcy estate.
- 13. BRG's approach is to utilize senior, experienced personnel and to encourage the Debtor to provide the staff-level support and analysis to minimize total cost. In addition, BRG's per diem rates for professionals of comparable experience, are at or below those of firms we consider our competitors. We believe that the compensation in this Application is based on the customary compensation charged by comparably skilled professionals in cases other than cases under Title 11.
- 14. Because BRG's core staff consists of senior professionals who performed a vast amount of the work, time spent communicating internally and reviewing the work product of junior associates was kept to a minimum.
- 15. No agreement or understanding exists between BRG and any other person for the sharing of compensation received or to be received for services rendered in connection with the chapter 11 cases, except for internal agreements among employees and contractors of BRG regarding the sharing of revenue or compensation. Neither BRG nor any of its employees or contractors has entered into an agreement or understanding to share compensation with any entity as described in Bankruptcy Rule 2016.
- 16. BRG's travel time policy is to not charge such time to a client unless productive work is performed during the travel period. In this engagement, non-productive travel time is not being charged to the Debtor.

- 17. BRG's time records for the Interim Fee Period are attached hereto as **Exhibit A**. These records include daily time logs describing the time spent by each BRG professional and administrative-level person in these cases.
- 18. BRG also maintains records of all actual and necessary out-of-pocket expenses incurred in connection with the rendition of its professional services. No expenses were incurred during the Fee Period.
- 19. The general summary of the services rendered by BRG during the Final Fee Period based on tasks and number of hours is set forth below.

Asset Acquisition/Disposition - Task Code 01

- 20. This task code includes time charges for BRG's evaluation and monitoring of the sale process. Specific tasks undertaken include (i) reviewing the terms of the bid procedures motion and stalking horse asset purchase agreement (the "APA"), (ii) reviewing the contents of the data room made available to prospective buyers to evaluate the adequacy of information provided by the Debtor, (iii) researching potential buyers for the Debtor's assets to ensure completeness of the marketing process, (iv) reviewing and modeling terms of the APA, (v) analyzing the allocation of potential proceeds under the APA, (vi) reviewing documentation related to the sale, (vii) reviewing various motions objecting to and orders affirming various aspects of the sale process, and (viii) preparing for and participating in discussions with the Committee, Committee counsel and the Debtor's financial advisors, investment bankers and counsel regarding the Debtor's sale process.
 - 21. BRG has expended 37.6 hours on this category for a fee of \$29,380.50.

DIP Financing – Task Code 04

- 22. This task code includes time charges for BRG's review and analysis of the DIP financing, including the DIP motion, the terms and conditions of the DIP credit agreement and the Debtor's DIP budgets, to ensure appropriateness of the DIP credit facility, and cash flow variances relative to the DIP budget. Time was also spent in discussions with the Committee, the Committee's counsel, the Debtor's financial advisors and legal counsel, and the DIP lenders' financial advisors and counsel regarding the same.
 - 23. BRG has expended 58.1 hours on this category for a fee of \$23,859.50.

Professional Retention/ Fee Application Preparation - Task Code 05

- 24. Time charged to this task code relates to the preparation and review of BRG's retention documents including the retention application, affidavit, draft order, and review of the conflict check results, BRG's first, second, and third interim fee applications and fourth interim and final fee application.
 - 25. BRG has expended 30.5 hours on this category for a fee of \$8,278.50.

Attend Hearings/ Related Activities – Task Code 06

- 26. Time charged to this task code relates to BRG's attendance at the bidding procedures hearing but not related to the preparation and giving of testimony at that hearing.
 - 27. BRG has expended 15.0 hours on this category for a fee of \$8,285.00.

Interaction/ Meeting with Debtor/ Counsel - Task Code 07

28. Time charged to this task code relates to BRG's preparation for and attendance on calls and at meetings, as well as other communications with the Debtor and the Debtor's financial advisors and legal counsel in order to obtain general case information and updates, including

information on the Debtor's operations, capital structure, unsecured claims pool and cash management.

29. BRG has expended 19.6 hours on this category for a fee of \$10,737.00.

Interaction/ Meetings with Creditors/ Counsel - Task Code 08

- 30. Time charged to this task code relates to BRG's preparation for and attendance on calls and at meetings with the Committee, and Committee Counsel in order to update the Committee on case issues and advise the Committee and develop strategies and related deliverables for a variety case matters, including the Debtor's sales process, DIP credit facility and liquidity issues.
 - 31. BRG has expended 34.3 hours on this category for a fee of \$24,748.50.

Recovery/ SubCon/ Lien Analysis – Task Code 10

- 32. Time charged to this task code relates to BRG's analysis of liens, claims, and development of an analysis of creditor recoveries under various scenarios in order to advise and report to the Committee regarding these matters and develop appropriate case strategies.
 - 33. BRG has expended 44.5 hours on this category for a fee of \$21,338.00.

Claim Analysis/ Accounting - Task Code 11

- 34. Time charged to this task code relates to BRG's analysis of claims on the Debtor, including pre-petition secured notes and other securities, in order to advise the Committee regarding these matters and development of appropriate case strategies. Time was also spent reconciling claims objected to by the Debtor to claims filed and scheduled.
 - 35. BRG has expended 80.7 hours on this category for a fee of \$38,479.50.

Intercompany Transactions/ Balances - Task Code 13

- 36. Time charged to this task code relates to BRG's analysis of the Debtor's cash and accounting activity related to its relationship with non-Debtor subsidiary Orexigen Therapeutics Ireland, Ltd. ("OTIL") to understand valuation and recovery issues relating to OTIL. Time was also spent in reviewing valuation reports of advisers covering the transfer of certain intellectual property rights from the Debtor to OTIL and the payment terms thereof.
 - 37. BRG has expended 92.1 hours on this category for a fee of \$43,107.00.

Cash Flow/ Cash Management Liquidity - Task Code 19

- 38. This task code relates to time spent by BRG reviewing and analyzing matters impacting the Debtor's cash management processes and overall liquidity at the individual Debtor entities. Time was also spent on analyzing the implementation of first day orders relating to critical vendors, customers, Cardinal, McKesson, and other prepetition balance holders, analyzing post-sale cash flows and administrative solvency, and reviewing post-sale cash flow detail.
 - 39. BRG has expended 62.5 hours on this category for a fee of \$40,572.50.

Projections/ Business Plan/ Other - Task Code 20

- 40. Time charged to this task code relates to BRG's interactions with the Debtor's financial advisors regarding the Debtor's assumptions of an initial and then subsequent long term business plan including the Debtor's plan for OTIL. Time charged to this task code also included comparison of the Debtor's business plan to the monthly operating reports.
 - 41. BRG has expended 6.9 hours on this category for a fee of \$2,371.50.

Preference/ Avoidance Actions - Task Code 22

42. Time charged to this task code relates to BRG's interactions with the Debtor's financial advisors and UCC counsel regarding Nalproprion's intention to purchase certain

Article 5 claims. Time charged to this task code also includes analysis of potentially avoidable transfers, the likelihood of recovery and of potential defenses by transferees.

43. BRG has expended 16.8 hours on this category for a fee of \$10,208.00.

<u>Litigation - Task Code 25</u>

- 44. This task code relates to time spent by BRG reviewing draft documents related to potential litigation and providing feedback to UCC counsel thereupon.
 - 45. BRG has expended 10.4 hours on this category for a fee of \$6,735.00.

Plan of Reorganization/ Disclosure Statement - Task Code 27

- 46. Time charged to this task code primarily relates to time spent by BRG reviewing the Plan documents.
 - 47. BRG has expended 7.3 hours on this category for a fee of \$4,362.50.

Planning - Task Code 31

- 48. This task code relates to time spent by BRG preparing work plans to avoid duplication of efforts with other case professionals.
 - 49. BRG has expended 11.3 hours on this category for a fee of \$4,588.50.

Document Review - Task Code 32

- 50. Time charged to this task code primarily relates to time spent by BRG reviewing new docket filings to determine pertinence to the Committee and to monitor case issues.
 - 51. BRG has expended 8.3 hours on this category for a fee of \$2,448.50.

Overseas/Foreign Entity Proceedings - Task Code 39

- 52. Time charged to this task code relates to BRG's discussing matters with the Debtor's advisors solely relating to cash management and funding for OTIL.
 - 53. BRG has expended 7.0 hours on this category for a fee of \$2,765.00.

Expert Witness Testimony - Task Code 41

- 54. Time charged to this task code relates to BRG's preparation and giving of testimony on behalf of the Committee with respect to bid procedures and key employee incentive program.
 - 55. BRG has expended 42.1 hours on this category for a fee of \$34,487.00.

ACTUAL AND NECESSARY EXPENSES

- 56. BRG incurred no actual out-of-pocket expenses in connection with the rendition of the professional services to the Committee during the Interim Fee Period. BRG incurred actual out-of-pocket expenses in connection with the rendition of the professional services to the Committee as summarized above, in the amount of \$2,869.25 during the Final Fee Period, for which BRG respectfully requests reimbursement in full.
- 57. The disbursements and expenses have been incurred in accordance with BRG's normal practice of charging clients for expenses clearly related to and required by particular matters. Such expenses were often incurred to enable BRG to devote time beyond normal office hours to matters, which imposed extraordinary time demands. BRG has endeavored to minimize these expenses to the fullest extent possible.
- 58. BRG's billing rates do not include charges for photocopying, telephone and facsimile charges, computerized research, travel expenses, "working meals," secretarial overtime, postage and certain other office services, because the needs of each client for such services differ. BRG believes that it is fairest to charge each client only for the services actually used in performing services for such client. BRG has endeavored to minimize these expenses to the fullest extent possible.
- 59. In providing a reimbursable service such as copying or telephone, BRG does not make a profit on that service. In charging for a particular service, BRG does not include in the


