- 2. This supplements the Declaration of Evan Gershbein in Support of Debtors' Application for Entry of an Order (I) Authorizing and Approving the Appointment of Kurtzman Carson Consultants LLC as Claims and Noticing Agent, Effective Nunc Pro Tunc to the Petition Date, and (II) Granting Related Relief filed on May 15, 2022 (the "Original Declaration") (Dkt No. 4).

3. In addition to the prior list of entities reviewed for conflicting relationships as

disclosed in the Original Declaration, at the Court's request, KCC has conducted a search for any

relationship with Xclaim Inc. KCC does not have any connection to or relationship with Xclaim

Inc.

4. Further, in the Original Declaration, KCC disclosed that it is an indirect subsidiary

of Computershare Limited ("Computershare") and that Computershare performs certain

administrative services for iPass, Inc. Since the filing of the Original Declaration, KCC has been

made aware that iPass, Inc. no longer has a relationship with Computershare.

5. Based on the foregoing and those disclosures in the Original Declaration, I believe

that KCC is a "disinterested person" as that term is defined in section 101(14) of the Bankruptcy

Code. Moreover, to the best of my knowledge and belief, neither KCC nor any of its employees

hold or represent an interest adverse to the Debtors or their estates with respect to any matter upon

which KCC is to be engaged.

6. Should KCC discover any new relevant facts or relationships bearing on the matters

described herein or in the Original Declaration during the period of its retention, KCC will use

reasonable efforts to promptly file a supplemental declaration
