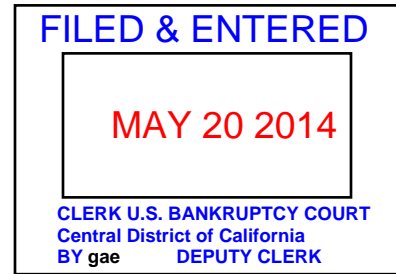

1                   The Court has considered the *Liquidating Trusts' Eighth Omnibus Motion for Order*  
2 *Seeking (1) Reclassification and/or Reduction of Certain Claims Misclassified as Priority Claims*  
3 *and (2) Disallowance or Reduction of Certain Claims Not Supported by the Debtors' Books and*  
4 *Records* (Docket No. 2831) (the "Objection"), filed on February 28, 2014 by the PC Trusts, by and  
5 through the Liquidating Trustee, seeking (among other things) entry of an order reclassifying  
6 PCHLI Claim No. 113 [Geraldine Dougherty Company], and the *Amended Notice of Objection to*  
7 *Claim* (Docket No. 2864) (the "Amended Notice") filed on April 9, 2014.<sup>2</sup>

8                   The Court considered the Objection, the Amended Notice and all related papers and  
9 documents. No timely written opposition was filed in response to the Objection.

10                   The Court has jurisdiction over this matter pursuant to sections 157 and 1334 of  
11 Title 28 of the United States Code, and the Court finds the form, scope and timing of notice of the  
12 Motion was adequate under the circumstances of these cases.

hereby:


**ORDERED THAT:**
