PLEASE TAKE FURTHER NOTICE that, in accordance with the Sale Orders, the Progression APA, the Lexington Law APA, and the approved contract designation process, the Debtors hereby file and provide notice of the assigned contracts prior to the Closing Date as reflected in **Exhibit A** attached hereto (the "Assigned Contracts").

PLEASE TAKE FURTHER NOTICE that, pursuant to the Sale Orders, the Progression APA, and the Lexington Law APA, the Purchaser has determined that the Assigned Contracts set forth on Exhibit A attached hereto shall be assumed by the Debtors and assigned and sold to Purchaser and shall be designated as "Assumed Contracts" within the meaning of the Sale Orders, the Progression APA, and the Lexington Law APA, in each case subject to, and effective as of, the Closing Date (unless such other date is mutually agreed upon by the Debtors, the Purchaser, and the counterparty or counterparties to any such Contract). For the avoidance of doubt, the Debtors intend to file a notice of the occurrence of the applicable Closing Date upon the closing of such sale transaction.
