deliberation and sufficient cause appearing therefor,

IT IS HEREBY ORDERED THAT:

1. The Application is GRANTED, as set forth in this Order.

2. Dundon is allowed, on a final basis, compensation for services rendered and

expenses incurred during the Final Fee Period in the sum of \$154,421.00.

3. The Debtors and the litigation trustee, as applicable, are hereby authorized and

directed to pay Dundon the difference between \$154,421.00 and any interim payments made to

Dundon with respect fees and expenses incurred during the Final Fee Period.

4. This Court shall retain jurisdiction to hear and determine all matters arising from

or related to the implementation, interpretation or enforcement of this Order.
