Pursuant to sections 330 and 331 of title 11 of the United States Code (the "Bankruptcy Code"), and Rule 2016 of the Federal Rules of Bankruptcy Procedure, and in accordance with that certain *Order Appointing Fee Examiner and Establishing Procedures for Consideration of Requested Fee Compensation and Reimbursement of Expenses* [Docket No. 751] (the "Fee Examiner Order") and that certain *Order (I) Authorizing and Establishing Procedures for Interim Compensation and Reimbursement of Professionals, and (II) Granting Related Relief* [Docket No. 188] (the "Interim Compensation Order"), the court-appointed fee examiner (the "Fee Examiner") in the above-captioned chapter 11 cases, Rucki Fee Review, LLC ("Rucki Fee Review"), hereby applies (the "Application") to the United States Bankruptcy Court for the District of Delaware (the "Court") for reasonable compensation for services rendered as Fee Examiner in the amount of \$44,632.00 for the monthly fee period from February

1, 2024 through March 13, 2024 (the "Monthly Application Period" and/or the "Interim Application Period"), in the amount of \$104,944.00 for the final fee period from December 15, 2023 through March 13, 2024 (the "Final Application Period"), and in the amount of \$72,992.00 for the post-Effective Date period (the "Post-Effective Date Period"), for total final compensation of \$177,936.00. In support of this Application, Rucki Fee Review respectfully represents as follows:

### **JURISDICTION AND VENUE**

- 1. The Court has jurisdiction to consider this Application pursuant to 28 U.S.C. §§ 157 and 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b) and the Court may enter a final order on this Application under the U.S. Constitution. Venue is proper in this District pursuant to 28 U.S.C. §§ 1408 and 1409.
- 2. The statutory and legal predicates for the relief sought herein are sections 330 and 331 of the Bankruptcy Code, Bankruptcy Rule 2016 and Local Rule 2016-2.

#### **BACKGROUND**

- 3. On August 7, 2023 (the "<u>Petition Date</u>"), the above-captioned debtor and an affiliate (collectively, the "<u>Debtors</u>") commenced a chapter 11 case by each filing a petition for relief under chapter 11 of the Bankruptcy Code (collectively, the "<u>Chapter 11 Cases</u>").
- 4. On August 24, 2023, the Office of the United States Trustee for the District of Delaware (the "<u>U.S. Trustee</u>") appointed an Official Committee of Unsecured Creditors in the Chapter 11 Cases pursuant to section 1102(a) of the Bankruptcy Code, which was subsequently modified on September 21, 2023 to include an additional member.
- 5. On September 5, 2023, the Court entered the Interim Compensation Order, which sets forth the procedures for monthly and interim compensation and reimbursement of

expenses in these cases, as subsequently modified by the Fee Examiner order as to quarterly and final fee applications.

- 6. Pursuant to the Fee Examiner Order, Rucki Fee Review was appointed as the Fee Examiner in the Chapter 11 Cases, effective as of December 15, 2023. The Fee Examiner Order authorizes Rucki Fee Review to be compensated on an hourly basis and to be reimbursed for actual and necessary out-of-pocket expenses.
- 7. On March 6, 2024, the Court entered that certain *Findings of Fact*, *Conclusions of Law, and Order Confirming the Fifth Amended Joint Chapter 11 Plan of Reorganization of Proterra Inc and its Debtor Affiliate* [Docket No. 1180] (the "Confirmation Order") confirming the plan of reorganization in the Chapter 11 Cases [Docket No. 1154] (the "Plan"). The effective date of the Plan occurred on March 13, 2024 (the "Effective Date").
- 8. Paragraph 130 of the Confirmation Order provides that the Fee Examiner shall be compensated from the Professional Compensation Escrow Account (as defined therein), and the Distribution Trust (as defined therein) to the extent that sufficient funds are not available in the Professional Compensation Escrow Account, in such amounts as are allowed by the Bankruptcy Court. For this reason, Rucki Fee Review has included its fees for the Post-Effective Date Period for Bankruptcy Court approval.
- 9. All services for which compensation is requested herein by Rucki Fee Review were performed by Rucki Fee Review, and Rucki Fee Review is not sharing its compensation with any person other than the member or employees of Rucki Fee Review.

#### **SUMMARY OF SERVICES RENDERED**

10. Attached hereto as <u>Exhibit A</u> is a detailed statement of fees incurred during the Monthly Application Period/Interim Application Period by Rucki Fee Review,

showing the amount of \$44,632.00 due for fees. In accordance with the Court's Local Rules, the statement of fees is presented in chronological order with the information required by Local Rule 2016-2. Additionally, the professional who rendered services relating to each category is identified, along with the number of hours for such individual and the total compensation sought for each category, in the summary attachments that precede this Application. The remaining fees incurred during the Final Application Period are set forth in detail in Rucki Fee Review's prior monthly fee applications, which are incorporated herein by reference and summarized in the preceding pages of this Application.

11. Rucki Fee Review performed work in the following categories during the Monthly Application Period/Interim Application Period:

Administrative Matters (Code 001) – 2.7 hours/\$756.00: Work in this category included e-mails with professionals regarding native format of fee and expense detail and other matters, and review of quarterly fee orders.

<u>Fee Review (Code 003) – 154.1 hours/\$43,148.00</u>: Work in this category included review of fee and expense detail and fee applications, preparation of initial and final reports on the same, and discussion with professionals regarding the same.

Rucki Fee Review Fee Applications (Code 007) – 2.6 hours/\$728.00: Work in this category included preparing Rucki Fee Review's first monthly fee application and review of the certificate of no objection related thereto.

12. Attached hereto as Exhibit B is a detailed statement of fees incurred

through and including April 26, 2024 during the Post-Effective Date Period by Rucki Fee Review, showing the amount of \$47,992.00 due for fees.

13. As contemplated by the Fee Examiner Order, Rucki Fee Review has continued, and will continue, to perform additional necessary services as Fee Examiner subsequent to the Final Application Period in connection with the review of second quarterly fee applications and final fee applications. Rucki Fee Review has performed work in the following categories through April 26, 2024 during the Post-Effective Date Period:

Administrative Matters (Code 001) – 2.3 hours/\$644.00: Work in this category included e-mails with professionals regarding native format of fee and expense detail and scheduling of the second quarterly fee hearing and the final fee hearing, as well as review of an omnibus second quarterly fee order for debtors' professionals.

Fee Review (Code 003) – 167.6 hours/\$46,928.00: Work in this category included review of fee and expense detail and fee applications, and preparation of initial and final reports on the same for the second quarterly fee period. The fee and expense review done during this period included portions of such work for both the second (November 2023-Janaury 2024) and third (February 1-March 13, 2024) quarterly fee periods, as both second quarterly fee applications and final fee applications were filed/due to be filed after the Effective Date.

Rucki Fee Review Fee Applications (Code 007) – 1.5 hours/\$420.00: Work in this category included preparing Rucki

Fee Review's first quarterly fee application.

14. The fees sought for the Post-Effective Date Period herein also include an estimated \$25,000.00 for work performed after April 26, 2024 in connection with preparation of this Application (which will be approximately 3.3 hours/\$924.00) and review of final fee applications being filed on the date of this Application and related work. Rucki Fee Review will subsequently file invoice detail underlying these estimated fees prior to the Bankruptcy Court's approval of this Application, and will reduce these estimated fees to the amount of actual fees if the actual incremental fees are lower than \$25,000.00. If the actual fees exceed the estimated fees, Rucki Fee Review will waive additional compensation in excess of the estimated \$25,000.00.

### **DISBURSEMENTS**

15. The Application does not seek reimbursement of any expenses or disbursements.

#### **VALUATION OF SERVICES**

- 16. The personnel of Rucki Fee Review have expended a total of 159.4 hours fulfilling the duties of the Fee Examiner in the Chapter 11 Cases during the Monthly Application Period/Interim Application Period, and 374.8 hours during the Final Application Period, as well as an additional 171.4 hours through April 26, 2024 during the Post-Effective Date Period.
- 17. As detailed in its prior fee applications incorporated herein by reference, the time incurred by Rucki Fee Review prior to the Monthly Application Period/Interim Application Period reflected the reasonable value of such services, and was billed at Rucki Fee Review's normal hourly rates of compensation for work of this character. Rucki Fee Review did not increase its billing rates at any time during the pendency of the Chapter 11 Cases.

- 18. The amount of time spent by the personnel of Rucki Fee Review as Fee Examiner in the Chapter 11 Cases during the Monthly Application Period/Interim Application Period, meanwhile, is fully set forth in the detail attached hereto as Exhibit A and the amount of time spent by the personnel of Rucki Fee Review through April 26, 2024 as Fee Examiner in the Chapter 11 Cases during the Post-Effective Date Period is fully set forth in the detail attached hereto as Exhibit B. These are Rucki Fee Review's normal hourly rates of compensation for work of this character. The reasonable value of the services rendered by Rucki Fee Review as Fee Examiner for the Monthly Application Period/Interim Application Period in the Chapter 11 Cases is at least \$44,632.00 and the reasonable value of the services rendered by Rucki Fee Review through April 26, 2024 as Fee Examiner for the Post-Effective Date Period in the Chapter 11 Cases is at least \$47,992.00. To ensure the additional estimated fees of \$25,000.00 for the remainder of the Post-Effective Date Period also reflect reasonable value, Rucki Fee Review will bill such work at the same billable rate and reduce the estimated fees if the actual fees are less than the estimated fees (in addition to not seeking compensation for fees in excess of the estimated fees).
- and <u>B</u> attached hereto are in compliance with the requirements of Local Rule 2016-2, and the undersigned member of Rucki Fee Review hereby certifies that he has reviewed such Local Rule and believes this Application is in compliance with such Local Rule. To the extent such requirements are not met, Rucki Fee Review requests a waiver of such requirements.
- 20. In accordance with the factors enumerated in section 330 of the Bankruptcy Code, the amount requested is fair and reasonable given (a) the complexity of these Chapter 11 Cases, (b) the time expended, (c) the nature and extent of the services rendered,

(d) the value of such services, and (e) the costs of comparable services other than in a case under chapter 11 of the Bankruptcy Code, to the extent applicable.
