25 **PLEASE TAKE NOTICE** that a Hearing will be held on December 13, 2023 at 10:30  
26 a.m., or as soon thereafter as the matter can be heard, at the United States Bankruptcy Court at 1300  
27 Clay Street, Oakland, California, Courtroom 220 before the Honorable William J. Lafferty, United  
States Bankruptcy Judge, to consider the *Motion to Allow Filing of Late Proofs of Claim* (the  
28 “Motion”), filed concurrently herewith, by eighteen (18) claimants who are sexual abuse claimants  
that hold claims against the Debtor and are represented by the firm of Winer, Burritt & Scott, (LLP)  
(hereinafter the “WBS Claimants”). The Motion seeks an order allowing the filing of late proofs



1 of claim on behalf of the WBS Claimants based upon excusable neglect under the provisions of  
2 Federal Rule of Bankruptcy Procedure 9006(b)(1).

3 The Motion is based upon this Notice, the Motion and the memorandum of points and  
4 authorities set forth therein, the Declaration of Erika J. Scott in Support of the Motion, and on such  
5 arguments or other evidence as may be presented at the Hearing.

17 at 1300 Clay Street, Suite 300, Oakland, California 94612 (mailing address: P.O. Box 2070,  
18 Oakland, California 94604) and must be served on counsel for the WBS Claimants at the address  
19 listed above. **Unless a timely objection is filed, the Court may grant the relief requested in the**  
20 **Motion without a hearing. Failure to file and serve a timely objection may result in waiver**  
21 **of any objection.**
