STATEMENT OF ISSUE AND DESIGNATION OF THE RECORD

Appellants Certain Underwriters at Lloyd's, London, subscribing, severally and not jointly, to Slip Nos. CU 1001 and K 66034 and Nos. I. Statement of Issue on Appeal

Whether LMI's loss reserve and insurance underwriting information is discoverable under FRBP 2004, where no party has alleged a bad faith insurance claim.¹
