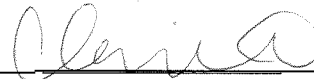
AFFIDAVIT OF SERVICE

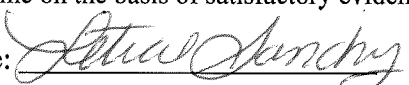
