estates, their creditors and all other parties in interest; and that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefor, it is hereby ORDERED that:

- 1. The Motion is GRANTED, as set forth herein.
- 2. The above-captioned cases are consolidated for procedural purposes only and shall not be a substantive consolidation of the respective estates. The cases shall be administered jointly under Case No. 13-10125 (KJC) in accordance with the provisions of Bankruptcy Rule 1015 and Local Rule 1015-1, and the joint caption of the cases shall read as follows:
