



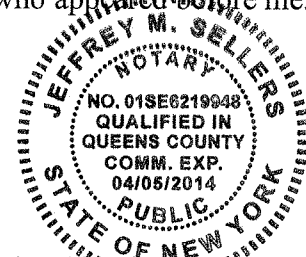

**NOTICE OF REJECTION OF EXECUTORY CONTRACTS AND
UNEXPIRED LEASES OF NON-RESIDENTIAL REAL PROPERTY**

PLEASE TAKE NOTICE that, on April 23, 2013, School Specialty, Inc. and its affiliated debtors and debtors-in-possession in the above-captioned cases (each a “Debtor,” and collectively, the “Debtors”) filed in the United States Bankruptcy Court for the District of Delaware (the “Court”) the *Debtors’ Amended Joint Plan of Reorganization Under Chapter 11 of the Bankruptcy Code* [Docket No. 862] (the “Plan”)² and the *Disclosure Statement for the Debtors’ Amended Joint Plan of Reorganization Under Chapter 11 of the Bankruptcy Code* [Docket No. 864] (the “Disclosure Statement”).

PLEASE TAKE FURTHER NOTICE that, on April 24, 2013, the Court approved the Disclosure Statement, on a conditional basis, as providing adequate information under section 1125 of title 11 of the United States Code (the “Bankruptcy Code”). Approval of the Disclosure Statement on a final basis is scheduled to be considered by the Court on May 20, 2013.

PLEASE TAKE FURTHER NOTICE that, pursuant to Article VII of the Plan, the executory contracts and unexpired leases that the Debtors intend to reject shall be set forth in the Plan Supplement. Entry of the Confirmation Order shall constitute a Court order approving the rejection of such executory contracts and unexpired leases pursuant to sections 365(a) and 1123 of the Bankruptcy Code, which rejections shall be effective as of the Effective Date.
