CERTIFICATION OF P. JOE MORROW IV WITH RESPECT TO THE TABULATION OF VOTES ON THE DEBTORS' AMENDED JOINT PLAN OF REORGANIZATION UNDER CHAPTER 11 OF THE BANKRUPTCY CODE

I, P. Joe Morrow IV, depose and say under penalty of perjury:

1. I am a Director of Corporate Restructuring Services, employed by Kurtzman Carson Consultants LLC ("<u>KCC</u>"), whose business address is 2335 Alaska Avenue, El Segundo, California 90245. I am over the age of 18 and not a party to this action.

2. Peter Walsh, Senior Managing Consultant for KCC, assisted in the service and tabulation described herein.

3. On February 25, 2013, the United States Bankruptcy Court for the District of Delaware (the "<u>Court</u>") entered the Order Authorizing and Approving the Employment and Retention of Kurtzman Carson Consultants LLC as Administrative Advisor for the Debtors and Debtors in Possession Nunc Pro Tunc to the Petition Date [Docket No. 279].

4. On April 24, 2013, the Court entered the Order: (A) Conditionally Approving Disclosure Statement; (B) Fixing Voting Record Date; (C) Approving Solicitation Materials and

Procedures for Distribution Thereof; (D) Approving Forms of Ballots and Establishing Procedures for Voting on Plan Tabulating Votes; (E) Scheduling Hearing and Approving Notice and Procedures for Filing Objections to (I) Confirmation of the Plan, and (II) Proposed cure Amounts Related to Contracts and Leases Assumed Under the Plan; and (F) Granting Related Relief [Docket No. 902] (the "Disclosure Statement Order") establishing, among other things, certain solicitation and voting tabulation procedures.

5. KCC worked with the Debtors and their counsel and other professionals to solicit votes to accept or reject the *Debtors' Amended Joint Plan of Reorganization Under Chapter 11 of the Bankruptcy Code* [Docket No. 862] (the "<u>Plan</u>") and to tabulate the ballots of creditors voting to accept or reject the Plan. Except as otherwise noted, I could and would testify to the following based upon my personal knowledge. I am authorized to submit this Certification on behalf of KCC.

6. KCC has considerable experience in soliciting and tabulating votes to accept or reject proposed chapter 11 plans.

A. Service and Transmittal of Solicitation Packages and Related Information

7. On or before April 27, 2013, KCC caused to be served Solicitation Packages (as defined in the Disclosure Statement Order²) on all known members of Classes 5, 6, 7 and 8 in accordance with the Disclosure Statement Order. Additionally, KCC caused to be served (i) the Non-Voting Creditor Notice to all known members of the remaining classes (Classes 1, 2, 3, 4 and 9), and (ii) the Confirmation Hearing Notice on the creditor matrix. An affidavit evidencing the service of the foregoing was filed with the Court on May 13, 2013 [Docket No. 1035].

8. In the days following the distribution of the Solicitation Packages and prior to the Voting Deadline (defined below), KCC received inquiries regarding service of Solicitation Packages and related classification of claims in Class 5 (General Unsecured Claims) and Class 6 (Trade Unsecured Claims). For each inquiry received, KCC, with specific guidance and approval from Debtors' counsel, responded by delivering additional Solicitation Packages to the inquiring recipients as requested. An affidavit evidencing the service of the foregoing was filed with the Court on May 16, 2013 [Docket No. 1078].

B. The Tabulation Process

9. The Disclosure Statement Order established April 24, 2013 as the record date (the "<u>Record Date</u>") for determining which creditors and holders of interests were entitled to receive Solicitation Packages and, where applicable, vote on the Plan. Pursuant to the Disclosure Statement Order, holders of claims in Class 5 (General Unsecured Claims), Class 6 (Trade Unsecured Claims), Class 7 (Noteholder Unsecured Claims) and Class 8 (Convenience Class Claims) (collectively, the "<u>Voting Classes</u>") were entitled to vote to accept or reject the Plan. No other classes were entitled to vote on the Plan.

10. Pursuant to the Disclosure Statement Order, KCC relied on the Debtors' Schedules of Assets and Liabilities and the claims information pertaining to the Debtors' Chapter 11 Cases as reflected in KCC's systems in order to identify the holders of claims entitled to vote to accept or reject the Plan.

11. KCC relied on a security position report provided by The Depository Trust Company ("<u>DTC</u>") as of the Record Date to identify the bank and brokerage firms (the "<u>Nominees</u>") that hold such Noteholder Unsecured Claims on behalf of underlying beneficial owners.

12. Using the information outlined above, and with specific guidance and approval from Debtors' counsel, KCC created a voting database reflecting the names of holders in the Voting Classes, addresses of such holders, voting amounts and classification of Claims in the Voting Classes.

13. Using its KCC CaseView voting database ("<u>KCC CaseView</u>"), KCC generated ballots for holders of Claims entitled to vote to accept or reject the Plan. The Disclosure Statement Order established May 16, 2013 at 4:00 p.m. (prevailing Eastern Time) as the deadline for receiving ballots to accept or reject the Plan (the "<u>Voting Deadline</u>").

14. For the Noteholder Unsecured Claims, KCC provided solicitation packages to the Nominees appearing on the security position report received from DTC, or the Nominees' agents, for subsequent forwarding to the underlying beneficial owners of Noteholder Unsecured Claims. KCC also provided a Master Ballot to each Nominee, or its agent, for their use in reporting the voting of the underlying beneficial owners.

15. Pursuant to the Disclosure Statement Order, KCC received and tabulated ballots as follows: (a) each returned ballot was opened and inspected at KCC's offices; (b) ballots were date-stamped and scanned into KCC CaseView; and (c) all ballots received on or before the Voting Deadline were then entered into KCC CaseView and tabulated in accordance with the tabulation rules outlined in the Disclosure Statement Order.

16. For the Noteholder Unsecured Claims, Master Ballots were tabulated against the Record Date security position amounts appearing for each Nominee as listed on the security position report received from DTC.

17. Set forth below is a summary of the voting results with respect to the Voting Classes tabulated on a consolidated basis:

b.	Not Signed	Any ballot that is not executed;
C.	Ambiguous	Any ballot that is illegible or contains insufficient or ambiguous information regarding the acceptance or rejection of the Plan; and/or
d.	Abstained	Any ballot that failed to indicate any acceptance or rejection of the Plan, or that indicated both acceptance and rejection of the Plan.

Conclusion

20. To the best of my knowledge, information and belief, the foregoing information concerning the distribution, submission and tabulation of ballots in connection with the Plan is true. The ballots received by KCC are stored at KCC's office and are available for inspection by or submission to this Court.
