On February 25, 2013, the United States Bankruptcy Court for the District of Delaware (the "Court") entered the *Order Authorizing and Approving the Employment and Retention of Kurtzman Carson Consultants LLC as Administrative Advisor for the Debtors and Debtors in Possession Nunc Pro Tunc to the Petition Date* [Docket No. 279].
- 4. On April 24, 2013, the Court entered the Order: (A) Conditionally Approving Disclosure Statement; (B) Fixing Voting Record Date; (C) Approving Solicitation Materials and

- 5. On May 17, 2013, the Certification of P. Joe Morrow IV with Respect to the Tabulation of Votes on the Debtors' Amended Joint Plan of Reorganization Under Chapter 11 of the Bankruptcy Code [Docket No. 1101] (the "Original Morrow Certification") was filed with the court.
- 6. The voting results for all classes were set forth in paragraph 17 of the Original Morrow Certification. A list of unacceptable ballots, including ballots that were late-filed, not signed, ambiguous, or ballots where the voting party abstained from voting to accept or reject the Plan was included as Exhibit B to the Original Morrow Certification.
- 7. Attached as Exhibit A to this amended and supplemental certification (the "Certification") is an amended and supplemental report of any ballots that were not included in the tabulation set forth in paragraph 17 of the Original Morrow Certification. Additional ballots were received after the filing of the Original Morrow Certification and are identified on the exhibit. The unacceptable reason for Ballot 398 was previously listed as ambiguous, however, upon further review, it was amended to abstain, as the creditor did not check either accept or reject box. Additionally, a column indicating the creditor's vote (accept, reject, or abstain) is included on the exhibit for purposes of the tabulation in paragraph 8.

8. Set forth below is a supplemental summary of the voting results for each class if all late-filed ballots and ballots not signed were counted:
