**NOTICE OF WITHDRAWAL OF OBJECTION OF THE  
CONNECTICUT LIGHT AND POWER COMPANY AND YANKEE GAS SERVICES  
COMPANY TO THE MOTION OF DEBTORS FOR ENTRY OF INTERIM AND FINAL  
ORDERS (I) PROHIBITING ANY UTILITY COMPANY FROM ALTERING,  
REFUSING, OR DISCONTINUING SERVICE, (II) APPROVING THE DEBTORS'  
PROPOSED ADEQUATE ASSURANCE, AND (III) ESTABLISHING PROCEDURES TO
