SUPPLEMENTAL AFFIDAVIT OF SERVICE

I, Jennifer Grageda, depose and say under the penalty of perjury:

- I am a Senior Clerk, employed by Kurtzman Carson Consultants LLC (“KCC”), the claims, noticing, and solicitation agent retained by Southern Air Holdings, Inc., et al., (collectively, the "Debtors") to assist with the solicitation and voting process in the above-captioned Chapter 11 cases, pursuant to the **Order Authorizing the Retention of and Appointing Kurtzman Carson Consultants LLC as Claims and Noticing Agent Under 28 U.S.C. § 156(c) and Local Rule 2002-1(f)** [Docket No. 67] entered by the United States Bankruptcy Court for the District of Delaware on October 1, 2012; and **Order Authorizing the Retention and Employment of Kurtzman Carson Consultants LLC as Administrative Agent Pursuant to Section 327(a) of the Bankruptcy Code, Bankruptcy Rule 2014, and Local Rule 2014-1** [Docket No. 197] entered by the United States Bankruptcy Court for the District of Delaware on October 24, 2012. I am over the age of 18 and not a party to this action. Except as otherwise noted, I could and would testify to the following based upon my personal knowledge. I submit this Affidavit of Service in connection with the service of Solicitation Packages (as defined herein) for the **Second Amended Joint Plan of Affiliated**




Debtors Pursuant to Chapter 11 of the United States Bankruptcy Code [Docket No. 470] (the “Second Amended Plan”).

2. On January 29, 2013, the Court entered the **Order (I) Approving the Proposed Disclosure Statement and the Form and Manner of the Notice of a Hearing Thereon, (II) Establishing Solicitation and Voting Procedures, (III) Scheduling a Confirmation Hearing, and (IV) Establishing Notice and Objection Procedures for Confirmation of the Debtors' Plan, Pursuant to Sections 105, 502, 1125, 1126, and 1128 of the Bankruptcy Code, Bankruptcy Rules 2002, 3003, 3017, 3018, and 3020, and Local Rules 2002-1, 3017-1, and 9006-1** [Docket No. 518] (the “Disclosure Statement Order”).
3. KCC is charged with the duty of printing and distributing Solicitation Packages (as defined herein) to creditors and other parties in interest in these chapter 11 cases pursuant to the instructions set forth in the Disclosure Statement Order.
4. The following documents and materials were approved by the Court for distribution to holders of claims entitled to vote on the Second Amended Plan (collectively, the “Solicitation Package”):
 - a. a CD-ROM (the “Solicitation CD-ROM”) containing:
 - i. **Disclosure Statement for the Second Amended Joint Plan of Affiliated Debtors Pursuant to Chapter 11 of the United States Bankruptcy Code** [Docket No. 520] (the “Disclosure Statement),
 - ii. Second Amended Plan (attached as an Exhibit to the Disclosure Statement),
and
 - iii. Disclosure Statement Order (without Exhibits).
 - b. Notice of (I) Approval of the Disclosure Statement, (II) Establishment of the Record Date, (III) Hearing on Confirmation of the Second Amended Plan and Procedures for Objecting to Confirmation Thereof, and (IV) Procedures and Deadline for Voting on the Second Amended Plan [attached as Exhibit 2 to the Disclosure Statement Order] (the “Confirmation Hearing Notice”);
 - c. A ballot for accepting or rejecting the Second Amended Plan, intended for the appropriate voting class as described below:
 - i. Class 2 – Prepetition Lender Claims (the “Class 2 Ballot”);


- ii. Class 4 – General Unsecured Claims (the “Class 4 Ballot”);
 - iii. Class 5 – Convenience Claims (the “Class 5 Ballot”)
 - iv. Class 6 – General Liability Insured and Litigation Claims (the “Class 6 Ballot”)
- d. a letter from the Debtors in Support of the Second Amended Plan [attached as Exhibit 5-1 to the Disclosure Statement Order] (the “Debtors’ Letter”);
 - e. a letter from the Creditors’ Committee in Support of the Second Amended Plan [attached as Exhibit 5-2 to the Disclosure Statement Order] (the “Creditors’ Committee Letter”); and
 - f. a pre-addressed, postage pre-paid return envelope, as applicable (the “Return Envelope”).
5. Additionally, the following notices were approved by the Court for distribution:
- a. Notice of Non-Voting Status to Unimpaired Classes [attached as Exhibit 4-1 to the Disclosure Statement Order] (the “Unimpaired Notice of Non-Voting Status”); and
 - b. Notice of Non-Voting Status to Impaired Classes [attached as Exhibit 4-2 to the Disclosure Statement Order] (the “Impaired Notice of Non-Voting Status”).
6. 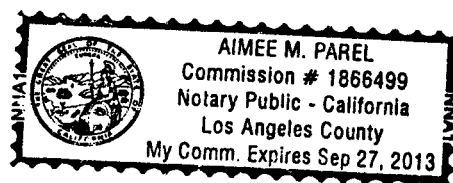
