

You must also mail a copy of your response to the undersigned at the address stated below.

If a hearing on the **Status Hearing Motion** cannot be held within thirty (30) days, Movant waives the requirement for holding a preliminary hearing within thirty (30) days of filing the motion and agrees to a hearing on the earliest possible date. If a final decision cannot be rendered by the Court within Sixty (60) days of the date of request Movant waives the requirement that a final decision be issued within that period. Movant consents to the automatic stay remaining in effect until the Court orders otherwise.
