STATEMENT OF ISSUES ON APPEAL

ISSUE 1: Whether the Bankruptcy Court erred as a matter of law in deciding that a Shortfall Amount under the Strategic Alliance Agreement was not a Permitted Claim under the Deed of Termination and Release.

ISSUE 2: Whether the Bankruptcy Court erroneously decided that Inmarsat delivered its services solely "under" the Master Service Agreement.

ISSUE 3: Whether the Bankruptcy Court erred in failing to consider that the Strategic Alliance Agreement established the essential price term for Fleet Xpress services that was applied to all 2020 Fleet Xpress invoices and that such services were delivered because the parties had agreed on the Take-or-Pay price and discount set by the Strategic Alliance Agreement.

ISSUE 4: Whether the Bankruptcy Court erred in failing to consider that, if the Strategic Alliance Agreement were not the agreement "under" which services were provided, then the Strategic Alliance Agreement's discount provisions cannot be applied to the price paid by Speedcast, and Inmarsat is thus owed at least the discounted amount that Speedcast received as if Speedcast had satisfied the Strategic Alliance Agreement's Take-or-Pay provision.
