
Plaintiff Catherine Youngman, as Class 3 Trustee, and Defendant Shaper have stipulated and jointly moved for the entry of a scheduling order setting deadlines for briefing related to Shaper's Motion to Dismiss Pursuant to Rule 12(b)(6) (Dkt. 6, 8) and the Plaintiff's forthcoming Motion to Remand. The Parties have further requested the resetting of the previously scheduled hearing on the Motion to Dismiss for March 21, 2022 and for a Status Conference on April 6, 2022 until after the proposed briefing schedule can be completed. The Court finds these requests have merit and should be GRANTED.



NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. Plaintiff's Motion to Remand is to be filed no later than Wednesday, March 9, 2022.
2. Defendant's Opposition to the Motion to Remand is to be filed no later than Monday, March 28, 2022.
3. Plaintiff's Reply in Support of the Motion to Remand, if any, is to be filed no later than Thursday, April 7, 2022.
4. Plaintiff's Opposition to the Motion to Dismiss is to be filed no later than Monday, April 18, 2022.
5. Defendant's Reply in Support of the Motion to Dismiss, if any, is to be filed no later than Monday, May 2, 2022.
6. The hearing on the Motion to Dismiss currently set for March 21, 2022 is re-set for May 9, 2022 at 1:30 p.m. Any timely filed motion to remand is set for hearing on May 9, 2022 at 1:30 p.m.
7. The Status Conference currently set for April 6, 2022 is re-set for May 9, 2022 at 1:30 p.m. The parties shall serve their Rule 26 disclosures no later than 14 days after this date; provided, the status conference and Rule 26 deadline may be further extended pending a ruling on the motions to dismiss and to remand.
