- 1. The Motion is GRANTED as set forth herein.
- 2. The period within which the Liquidating Trustee may seek removal of the Actions pursuant to 28 U.S.C. § 1452 and Bankruptcy Rule 9027 is enlarged through and including June 30, 2023, without prejudice to the rights of the Liquidating Trustee to seek further extensions.
- 3. All time periods set forth in this Order shall be calculated in accordance with Bankruptcy Rule 9006(a).
- 4. The Liquidating Trustee is authorized to take all actions necessary to effectuate the relief granted in this Order in accordance with the Motion.
- 5. This Court retains jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order.
