UTICA EQUIPMENT FINANCE LLC AND UTICA REALTY WELLINGTON, LLC'S RESPONSE TO OBJECTION BY THE BOEING COMPANY AND CENTRAL KANSAS AEROSPACE MANUFACTURING, LLC TO PROPOSED TESTIMONY REGARDING EMERGENCY MOTION OF UTICA EQUIPMENT FINANCE LLC AND UTICA REALTY WELLINGTON, LLC TO REMOVE EQUIPMENT FROM DEBTORS' LOCATION; MOTION TO STRIKE

Utica Equipment Finance, LLC ("<u>UEF</u>" or the "<u>Equipment Obligor</u>") and Utica Realty Wellington, LLC ("<u>Utica Realty Wellington</u>" or the "<u>Landlord</u>"), together the ("<u>Utica Movants</u>"), respond to Boeing Company ("<u>Boeing</u>") and Central Kansas Aerospace Manufacturing, LLC's ("**CKAM**") Objection to Utica Movant's proposed testimony as follows:

On October 14, 2021, Utica Movants filed an Errata to correct a typographical error in its Emergency Motion (D.I. 555). When originally filed, the Declaration of the Armin Walther ("Walther Declaration") and Declaration of Horace Jennings ("Jennings Declaration") were erroneously attached to the Errata. The Utica Movants discovered the error and independently filed the Walther Declaration (D.I. 557) and Jennings Declaration (D.I. 558), which were served on Boeing and CKAM at 10:14 p.m., less than two (2) hours after service of the Errata at 8:38 p.m. When the clerk's office opened on October 15, 2021, the Utica Movants advised the clerk's office of the error and the clerk's office restricted the Walther Declaration and the Jennings Declaration attachments to the Errata from public view to prevent any confusion in the docket.

Boeing and CKAM have made additional arguments and requests in their Objection to which the Utica Movants dispute and object. The Utica Movants intend on fully responding to these additional items at the hearing tomorrow, October 19, 2021, unless the Court otherwise requests the Utica Movants to file a written response addressing Boeing and CKAM's Objection.
