## MOTION BY TRUSTEE TO APPROVE STIPULATION OF SETTLEMENT BETWEEN CHAPTER 11 TRUSTEE AND JOELE FRANK, WILKINSON, BRIMMER, KATCHER

Stephen B. Darr, the duly appointed Chapter 11 Trustee (the "Trustee") of the bankruptcy estates ("Estates") of TelexFree, LLC, TelexFree, Inc., and TelexFree Financial, Inc. (collectively, the "Debtors"), respectfully requests that the Court approve the stipulation ("Stipulation") filed herewith by and between the Trustee and Joele Frank, Wilkinson, Brimmer, Katcher ("Joele Frank"), pursuant to Federal Rule of Bankruptcy Procedure 9019. The Stipulation provides for a payment into the Estates of \$20,000, a release by the Trustee in favor of Joele Frank, and the waiver by Joele Frank of approximately \$60,000 in claims.
