STATUS REPORT

Now comes Stephen Darr, the Chapter 11 trustee (the “Trustee”) of the bankruptcy estates of TelexFree, LLC, TelexFree, Inc., and TelexFree Financial, Inc. (the “Debtors”) and respectfully submits this report on the status of the adversary proceeding.

1. On or about April 5, 2016, the Trustee commenced this action to avoid and recover certain payments made by the Debtors to the Defendant.

2. On July 27, 2016, the Defendant filed its Answer.

3. On August 17, 2016, the Court issued a Scheduling Order.

4. The parties have since reached a consensual resolution to the dispute. The

Trustee expects to submit settlement documentation within the next two weeks.
