**MOTION BY CREDITOR UNITED STATES FOR AUTHORITY TO APPEAR BY
TELEPHONE FOR THE HEARING SCHEDULED FOR DECEMBER 27, 2017
(Request for Expedited Determination)**

THE CREDITOR UNITED STATES OF AMERICA respectfully requests that the Court authorize the undersigned counsel to appear telephonically at the hearing scheduled for December 27, 2017 on the (i) Fourth Interim Application for Compensation and Reimbursement of Expenses by Huron Consulting Services, LLC, Successor Accountant and Financial Advisor to the Trustee; and (ii) the First Interim Application for Compensation and Reimbursement of Expenses of StoneTurn Group, LLP as Expert Consultants for Both Domestic and International Defendant Classes (the “Applications”).

IN SUPPORT THEREOF, the United States submits:

1. The Applications are scheduled for hearing on December 27, 2017 at 10:00 a.m.
