This further to a notice dated 24 August 2018, sent by email from ClaimResponse@telexfreeclaims.com

Unfortunately the email address to which the aforesaid email was sent, had technical issues impeding us to read and answer messages, even though the messages appeared to be correctly sent and delivered.

We noticed that the claim above has been included in the list of the disallowed ones on the basis that the user accounts have been added without adequate explanation or documentation.

Indeed, please note that Mr. Grifoni had invested his money on Telexfree by giving money in cash to another investor, in particular to Mr. Michele Circelli who then used the money to open Mr. Grifoni's accounts. The dates of those payments are:

- 05 November 2013 for *romeo1954*
- 20 January 2014 for romeo1954alfa
- 21 February 2014 for romeo1954beta

Please note that Mr. Grifoni has never received money from Telexfree.

We hope this clarifies Mr. Grifoni's position and that you might reconsider to allow his claim no. 62687.
