1.º- That last February 25, 2019, I receive the communication sent by Mr. Stephen Darr attached to this letter as Doc. 1.

This communication is received by mail at my address, as evidenced by the postal envelope that I attach as Doc. 2.

2.º- That, prior to said communication, I made a claim or demand amounting to \$ **5,380.96**, and that it was registered in this court as number 34017, as evidenced by Doc. 3 attached.

3.º In the letter that I enclose from Mr. Darr, they inform me or warn me that my claim or claim is "inadmissible", by not having answered the emails that the Lord allegedly sent me in August and November of 2018.

In this regard, I respectfully and respectfully want to communicate to this Court, that for reasons or causes that I ignore and do not know, the prior communications that Mr. Darr sent me to my email, were not received by me, so I was not aware of these letters and, consequently, I could not answer what Mr. Darr asked me to do.

I can assure you that the first communication that I received from the lawsuit that I submitted is the one that I attached to you, received on February 25, 2019, and that, as I said, it was received in my mailbox of my private address, reason why I am writing this letter to this illustrious Court.

4.º- For the reasons stated above, until now I have not been able to present the evidence and documents that show that I made TELEXFREE a participation in the indicated amount.

In view of the foregoing, I show my disagreement and opposition to the declaration of inadmissibility of my claim made by Mr. Darr, because to date I have not had the opportunity to present the evidence that credits my credit against the company TELEXFREE.

5.º- As I say, I claim the amount of \$ 5,380.96, which is derived from the five contributions I made to TELEXFREE, on March 6, 2014, through five bank transfers for an amount of 1,076.68 euros (€) each to the TELEXFREE bank account that was indicated on your web page, located in Munich (Germany) in "DEUTSCHE POSTBANK", as accredited with the documents that are attached to the Doc. 4, to which I refer in their entirety.

For all the exposed,

I ASK THIS COURT: Have this response presented, and by virtue of what has been explained and said, agree to be justified in the absence of my response to the proposed resolution of Mr. Darr's claim, for cause not attributable to me, and for this reason, declare and recognize my right to collect the amount of \$ 5,380.96.
