#### **REPORT OF PLAN VOTING**

To the Honorable Melvin S. Hoffman, United States Bankruptcy Judge:

Stephen B. Darr, the duly appointed Chapter 11 trustee (the "<u>Trustee</u>") of the bankruptcy estates of TelexFree, LLC, TelexFree, Inc., and TelexFree Financial, Inc. (collectively, the "<u>Debtors</u>" or "<u>TelexFree</u>"), hereby submits this *Report of Plan Voting* with respect to ballots on the pending *First Amended Liquidating Plan of Reorganization of Stephen B. Darr, Chapter 11 Trustee of TelexFree, LLC, TelexFree, Inc., and TelexFree Financial, Inc.* (the "<u>Plan</u>"):

1. On or about May 28, 2020, the Court entered an Order (I) Approving First Amended Disclosure Statement With Respect To First Amended Liquidating Plan; (II) Establishing Record Holder Date; (III) Approving Solicitation Procedures, Form Of Participant Notice and Forms of Ballots, (IV) Establishing Deadlines For The Filing of Objections To Confirmation Of Chapter 11 Plan, and For the Submission of Ballots, and (V) Scheduling Hearing On Plan Confirmation (the "Balloting Order"). Among other things, the Balloting Order established June 30, 2020 (the "Balloting Deadline") as the deadline for the submission of ballots with respect to the Plan.

2. Pursuant to the ballots which were received in compliance with the Balloting

Order, each Class of Claims and Equity Interests under the Plan has voted as follows:

a. <u>Class 1</u>: Priority Claims

**Result:** Class 1 is unimpaired and is deemed to have accepted the Plan.

b. <u>Class 2</u>: Participant Convenience Claims

**Result:** Class 2 is impaired and has voted to accept the Plan. A tabulation of the ballots for Class 2 is included in the *Declaration of Tinamarie Feil Regarding Solicitation and Tabulation of Participant Votes in Connection with the First Amended Liquidating Plan of Reorganization*, attached as <u>Exhibit "A"</u>.

c. <u>Class 3</u>: General Participant Claims

**Result:** Class 3 is impaired and has voted to accept the Plan. A tabulation of the ballots for Class 3 is included in <u>Exhibit "A"</u>.

d. <u>Class 4</u>: Vendor Claims

**Result**: No vote was received from any holder of a Class 4 impaired claim, and Class 4 is deemed to have accepted the Plan. *See In re Ruti-Sweetwater, Inc.*, 836 F.2d 1263 (10th Cir. 1988).

e. <u>Class 5</u>: Equity Interests in Debtors

**Result:** Class 5 is impaired and is deemed to have rejected the Plan.
