Penalty for presenting fraudulent claim: Fine of up to \$500,000 or imprisonment for up to 5 years, or both.

As the attached documents show, I paid an average price of \$0.70658 for 6650 shares of THQIQ between 4/23/2012 and 5/03/2012. This amounted to \$4,667.50. Following THQ's 1-for-10 reverse stock split which happened after this purchase, the average price I paid (retroactively) became \$7.0658 for 665 shares. On December 19th, the day THQ filed for bankruptcy, the share price had dropped to \$1.40, a total loss of \$3,736.50.
