On April 15, 2024, the Committee filed the *Application of the Official Committee* of Unsecured Creditors of Thrasio Holdings, Inc., et al., for Entry of an Order Authorizing the Employment and Retention of Morrison & Foerster LLP as Counsel, Effective as of March 14, 2024 [Docket No. 370] (the "Application") pursuant to sections 328(a) and 1103(a) of the Bankruptcy Code, Rule 2014 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), and Rule 2014-1 of the Bankruptcy Local Rules for the United States Bankruptcy Court for the District of New Jersey.

- 5. In order to supplement and clarify certain statements made in the Application and the Original Declaration, I submit this First Supplemental Declaration in accordance with rule 2014(a) of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules").
- 6. Unless otherwise stated in this First Supplemental Declaration, I have personal knowledge of the facts hereinafter set forth. To the extent that any information disclosed herein requires amendment or modification upon Morrison & Foerster's completion of further analysis or as additional information becomes available to Morrison & Foerster, a supplemental declaration will be submitted to the Court. Subject to the approval of this Court and in compliance with the applicable provisions of the Bankruptcy Code, Bankruptcy Rules and the Local Rules, Morrison & Foerster intends to apply for compensation for professional services rendered in connection with these Chapter 11 Cases, plus reimbursement of actual, necessary expenses and other charges incurred by Morrison & Foerster during the Chapter 11 Cases.
- 7. I submit this First Supplemental Declaration in support of the Application and to supplement the disclosures set forth in the Original Declaration in accordance with Bankruptcy Rules 2014(a) and 2016(b). Except as otherwise indicated herein, all facts stated in this First Supplemental Declaration are based on my personal knowledge of the Firm's operations and finances, information learned from my review of relevant documents, and information supplied to me by the Firm's partners or employees. If called upon to testify, I could and would testify on that basis.

ADDITIONAL DISCLOSURES

- 8. As set forth in the Original Declaration, in connection with its retention by the Committee in these Chapter 11 Cases, Morrison & Foerster undertook to determine whether it had any conflicts or other relationships that might cause it not to be disinterested or to hold or represent an interest adverse to the Debtors.
- 9. As set forth in the Original Declaration, Morrison & Foerster currently represents, and has in the past represented, Amazon.com and certain of its affiliates (collectively "Amazon"), in a variety of its matters. Morrison & Foerster's representations of Amazon, in the aggregate, accounted for more than one percent of Morrison & Foerster's fee receipts for the 2022 calendar year. All of Morrison & Foerster's current and prior representations of Amazon have been unrelated to the Debtors and these Chapter 11 Cases. I do not believe that Morrison & Foerster's representation of Amazon precludes Morrison & Foerster from meeting the disinterestedness standard under the Bankruptcy Code.
- 10. Morrison & Foerster's representations related to each individual representation listed in <u>Schedule 2</u> to the Original Declaration accounted for less than 3.5% of Morrison & Foerster's fee receipts for the each of the 2022 and 2023 calendar years. All of Morrison & Foerster's current and prior representations listed in <u>Schedule 2</u> of the Original Declaration have been unrelated to the Debtors and these Chapter 11 Cases, unless otherwise stated herein or in the Original Declaration.
- 11. As set forth in the Original Declaration Morrison & Foerster's hourly rates are set at a level designed to fairly compensate the Firm for the work of its attorneys and paraprofessionals and to cover fixed and routine overhead expenses. These hourly rates are based on a variety of factors, including seniority, distinction, and expertise in one's field and are subject to periodic

adjustments to reflect economic and other conditions.³ Attached hereto as **Exhibit A** are specific hourly billing rates for the attorneys and paraprofessionals who have closed time under this engagement as of April 24, 2024. I anticipate that this list will vary as workstreams arise or conclude in these Chapter 11 Cases.

AFFIRMATIVE STATEMENT OF DISINTERESTEDNESS

12. Based on the conflicts search conducted to date and described herein, to the best of my knowledge and insofar as I have been able to ascertain, (a) I believe that Morrison & Foerster is a "disinterested person" within the meaning of section 101(14) of the Bankruptcy Code, as required by section 328 of the Bankruptcy Code, and does not hold or represent an interest adverse to the Debtors, their estates, their creditors, or the Committee and the members thereof; (b) Morrison & Foerster does not represent any entity having an adverse interest in connection with the Chapter 11 Cases as required by section 1103 of the Bankruptcy Code; and (c) Morrison & Foerster has no connection to the Debtors, their estates, their creditors, the Committee, and the members thereof, or other parties in interest except as disclosed in this First Supplemental Declaration or in the Original Declaration.

As set forth in the proposed order, Morrison & Foerster will provide ten (10) business days' notice to the Committee, the Debtors, and the U.S. Trustee before implementing any periodic increases, and will file such notice with the Court.
