NOTICE OF SUPPLEMENTAL BAR DATE FOR FILING CUSTOMER PROOFS OF CLAIM ON MAY 14, 2010

TO: ALL PERSONS OR ENTITIES WHO MAY HAVE PREPETITION AND/OR POSTPETITION CUSTOMER CLAIMS AGAINST TOUSA, INC. OR ITS **AFFILIATED DEBTORS**

PLEASE TAKE NOTICE that, on January 29, 2008, TOUSA, Inc. ("TOUSA") and its affiliated debtors and debtors in possession in the above-captioned, jointly administered chapter 11 cases (collectively, the "Debtors") each filed a voluntary petition for relief under chapter 11 of title 11 of the United States Code (the "Bankruptcy Code") in the United States Bankruptcy Court for the Southern District of Florida (the "Court").

PLEASE TAKE FURTHER NOTICE that, on March 1, 2010, the Court entered an order establishing May 14, 2010 as the deadline (the "Customer Claims Bar Date") by which any person or entity (including individuals, corporations, partnerships, trusts, and governmental units) that holds a claim arising from or related to (i) a signed agreement to purchase a home from, or a home sale closed with, the Debtors before January 29, 2008, or a claim arising from or related to a (ii) signed agreement to purchase a home from, or a home closed with, the Debtors after January 29, 2008, only to the extent the Debtors have not paid or honored such claim during the Debtors' chapter 11 cases (each, a "Customer Claim") must file written proof of such Customer Claim (a "Customer Proof of Claim") with the Bankruptcy Court.

YOU ARE RECEIVING THIS NOTICE because you may have a Customer Claim against one or more of the Debtors. However, the fact that you are receiving this notice does not mean that you do have a Customer Claim against a Debtor or that the Debtors believe that you do.

PURSUANT TO THE CUSTOMER CLAIMS BAR DATE ORDER ENTERED BY THE **COURT:**

- THE DEADLINE TO FILE A CUSTOMER PROOF OF CLAIM IS MAY 14, 2010 AT 5:00 P.M. (PREVAILING PACIFIC TIME).
- IF YOU ARE REQUIRED TO FILE A CUSTOMER PROOF OF CLAIM BY THE CUSTOMER CLAIMS BAR DATE BUT FAIL TO DO SO, YOUR

(1) WHO MUST FILE A CUSTOMER PROOF OF CLAIM

You **MUST** file a Customer Proof of Claim if you have a Customer Claim against any of the Debtors by **May 14, 2010 at 5:00 p.m.** (**prevailing Pacific Time**).

Acts or omissions that occurred before January 29, 2008 may give rise to Customer Claims that are subject to the Customer Claims Bar Date, even if the Customer Claim may not have become known or fixed until after January 29, 2008.

In the event that you assert a claim based upon the purchase of a home from the Debtors, but you believe your claim is an administrative claim because you provided a benefit to the Debtors on or after January 29, 2008, you should still file a claim by May 14, 2010, but you should use an administrative proof of claim form, which may be obtained by contacting the Debtors' noticing and claims agent, Kurtzman Carson Consultants LLC, at 2335 Alaska Ave., El Segundo, California 90245, Telephone: (866) 381-9100.

You should **not file** a duplicate proof of claim at this time if you have already filed a proof of claim in the Debtors' chapter 11 case for the same claim.

Enclosed with this notice is a form Customer Proof of Claim for you to use.

For your filed Customer Proof of Claim to be valid, it must (i) be written in English; (ii) include a claim amount denominated in United States dollars; (iii) state a claim against only one Debtor; (iv) clearly indicate the Debtor against which the creditor is asserting a claim; and (v) be signed by the Customer Claimant or if the Customer Claimant is not an individual, by an authorized agent of the Customer Claimant. In addition, you must attach to your Customer Proof of Claim any documents on which your Customer Claim is based (if voluminous, you may instead attach a summary) or an explanation as to why such documentation is not available. You also must specifically identify the Debtor against which you assert a Customer Claim by name and case number (listed on page 3, 4 and 5 of this notice). You should include all Customer Claims against a particular Debtor in a single Customer Proof of Claim. If you have Customer Claims against multiple Debtors, you must file a separate Customer Proof of Claim against each Debtor.

(3) WHEN AND WHERE TO FILE

All Customer Proofs of Claim must be received by Kurtzman Carson Consultants LLC ("KCC") or filed with the Clerk of the Bankruptcy Court of the Southern District of Florida, Fort Lauderdale Division, on or before the Customer Claims Bar Date.
