**SUPPLEMENTAL CERTIFICATE OF SERVICE**

I, Stephanie Delgado, depose and say:

1. I am employed by Kurtzman Carson Consultants LLC (“KCC”), the claims, noticing, and balloting agent for the Debtors in the above-captioned cases. I submit this Supplemental Affidavit in connection with the service of the solicitation materials for *The Debtor's and Official Committee of Unsecured Creditors' Second Amended Joint Plan of Liquidation for TPP Acquisition, Inc. d/b/a The Picture People Under Chapter 11 of the United States Bankruptcy Code (Solicitation Version)* [Docket No. 468] (the “Second Amended Plan”). I am over the age of 18 and not a party to this action. Except as otherwise noted, I could and would testify to the following based upon my personal knowledge.

2. On September 9, 2016, the Court entered the *Order Pursuant to 28 U.S.C. § 156(c) Authorizing the Retention and Appointment of Kurtzman Carson Consultants LLC as Claims, Noticing, and Balloting Agent Nunc Pro Tunc to the Petition Date* [Docket No. 84] designating KCC as the claims, noticing agent, and balloting agent.

3. Consistent with its retention as claims, noticing, and balloting agent, KCC is charged with, among other things, the duty of printing and distributing Solicitation Packages to creditors and other interested parties pursuant to the instructions set forth in the *Order Approving Debtor's Expedited Motion for Entry of an Order (I) Scheduling Combined Hearing on Approval of Disclosure Statement and Confirmation of Plan of Liquidation, (II) Conditionally Approving Disclosure Statement, (III) Establishing Procedures for Solicitation and Tabulation of Votes on Plan, and (IV) Approving Related Matters* [Docket No. 474] (“Solicitation Procedures Order”), as entered by the Court on February 15, 2017.

4. The Solicitation Packages consist of one or more of the following documents:

- a. Flash Drive (the “USB Flash Drive”) containing the following documents:
  - i. the Second Amended Plan;
  - ii. the *Second Amended Disclosure Statement Under 11 U.S.C. § 1125 in Support of the Debtor's and Official Committee of Unsecured Creditors' Second Amended Joint Plan of Liquidation for TPP Acquisition, Inc. d/b/a The Picture People Under Chapter 11 of the*



*United States Bankruptcy Code (Solicitation Version)* [Docket No. 469] (the “Second Amended Disclosure Statement”); and

- iii. the Solicitation Procedures Order.
- b. the Notice of Hearing to Consider Final Approval of Second Amended Disclosure Statement and Confirmation of Second Amended Joint Chapter 11 Plan of Liquidation of the Debtor and the Committee Under Chapter 11 of the Bankruptcy Code (the “Confirmation Hearing Notice”);
- c. Ballot for Class 2, Allowed Other Secured Claims (the “Class 2 Ballot”) (substantively in the form attached as Exhibit 2 to the Solicitation Procedures Order);

- f. Ballot for Class 5, Allowed General Unsecured Claims (the “Class 5 Ballot”) (substantively in the form attached as Exhibit 2 to the Solicitation Procedures Order);
- g. Notice of Unimpaired Non-Voting Status Under Second Amended Joint Chapter 11 Plan of Liquidation of the Debtors and the Committee (the “Unimpaired Non-Voting Status Notice”) (substantively in the form attached as Exhibit 3 to the Solicitation Procedures Order); and
- h. Notice of Impaired Non-Voting Status Under Second Amended Joint Chapter 11 Plan of Liquidation of the Debtors and the Committee (the “Impaired Non-Voting Status Notice”) (substantively in the form attached as Exhibit 4 to the Solicitation Procedures Order).
