PLEASE TAKE NOTICE that on May 15, 2019, the Liquidation Trustee for the Liquidation Trust for TPP Acquisition, Inc. (the “Liquidation Trustee”) filed the *Liquidation Trustee’s Fourth Omnibus Objection to Claims Asserted* [D.I. 739] (the “Fourth Omnibus Claim Objection”). On August 13, 2019, the Court entered the *Order Granting Liquidation Trustee’s Fourth Omnibus Objection to Claims Asserted* [D.I. 765] (the “Fourth Omnibus Order”). Pursuant to the Fourth Omnibus Order, the Court sustained the Fourth Omnibus Claim Objection, except with respect to the proofs of claim filed by claimants (i) the State Board of



Equalization (Proof of Claim No. 468), and (ii) the Ventura County Tax Collector (Proof of Claim No. 469) (collectively, the “Surviving Claims”). The hearing on the Fourth Omnibus Claim Objection solely as it relates to the Surviving Claims is continued to **September 10, 2019 at 1:30 p.m. (CT)** at the Earle Cabell Federal Building, 1100 Commerce Street, 14th Floor, Courtroom No. 3, Dallas, Texas 75242. The Trustee shall file a reply in further support of the Fourth Omnibus Claim Objection as it applies to the Surviving Claims on or before **September 3, 2019**.
