**FINAL ORDER: (I) AUTHORIZING PAYMENT OF CERTAIN PREPETITION TAXES AND FEES AND (II) AUTHORIZING FINANCIAL INSTITUTIONS TO HONOR ALL RELATED CHECKS AND ELECTRONIC PAYMENT REQUESTS**

Debtor filed a Motion<sup>1</sup> for entry of an Order: (i) authorizing it to pay all Taxes and Fees, and (ii) authorizing banks and financial institutions to honor all related checks and electronic payment requests. Debtor served the motion and notice of hearing. No interested party filed an objection. At the final hearing on March 23, 2017, Anfield Apparel Group, Inc. requested that the Court add language preserving its rights to assert reclamation claims. For the reasons stated on the record, Anfield Apparel Group, Inc.'s untimely objections are overruled and its request for additional language is denied.

This Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334(b) and venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409. This is a core proceeding under 28 U.S.C. § 157(b) and the Court finds that it has authority to enter a final order consistent with Article III of the United States Constitution.

After considering the Declaration of Jill Motschenbacher [Doc. 26], her Supplemental Declaration [Doc. 156] and other evidence offered at the hearings, reviewing other pleadings filed in this case and hearing arguments from counsel, the Court finds cause for granting the relief provided in this Order.<sup>2</sup>

**IT IS ORDERED:**

1. The Motion is GRANTED as provided below.
2. Debtors is authorized to pay the Taxes and Fees due and owing to federal, state and local taxing authorities and other governmental authorities listed on Exhibit C to the Motion [Doc. 86], including, without limitation, through the issuance of postpetition checks or wire transfer requests, as Debtor deems necessary in an amount not to exceed \$775,000.
3. The Banks are authorized, when requested by Debtor, in Debtor's discretion, to honor and process checks or electronic fund transfers drawn on Debtor's bank accounts to pay prepetition obligations authorized to be paid under this Order, whether such checks or other requests were submitted prior to, or after, the Petition Date, provided that sufficient funds are available in the applicable bank accounts to make such payments. The Banks may rely on the representations of Debtor with respect to whether any check or other transfer drawn or issued by Debtor prior to the Petition Date should be honored pursuant to this Order, and any such Bank shall not have any liability to any party for relying on such representations by Debtor, as provided for in this Order.

To the extent any of the following findings of fact constitute conclusions of law, they are adopted as such. To the extent any of the following conclusions of law constitute findings of fact, they are adopted as such.

4. Nothing in this Order shall impair any right of Debtor to dispute or object to any taxes asserted as owing to the Taxing Authorities or those parties who ordinarily collect the Taxes and Fees as to amount, liability, classification, or otherwise.

5. Debtor is authorized to issue postpetition checks, or to effectuate postpetition fund transfer requests, in replacement of any checks or fund transfer requests that are dishonored as a consequence of this Chapter 11 Case with respect to prepetition amounts owed in connection with the Taxes and Fees.

6. Debtor is authorized and empowered to take all actions necessary to implement the relief granted in this Order.

7. The requirements set forth in Bankruptcy Rule 6004(a) are waived, and pursuant to Bankruptcy Rule 6004(h), the terms and provisions of this Order shall be immediately effective and enforceable upon its entry.

8. Notwithstanding any provision in the Bankruptcy Rules to the contrary: (i) this Order shall be effective immediately and enforceable upon its entry; (ii) Debtor is not subject to any stay in the implementation, enforcement, or realization of the relief granted in this Order; and (iii) Debtor is authorized and empowered, and may in its discretion and without further delay, take any action necessary or appropriate to implement this Order.

9. This Court shall retain jurisdiction with respect to all matters arising from or related to the implementation or interpretation of this Order.
