**JOINT MOTION OF DEBTOR AND THE UNSECURED CREDITOR COMMITTEE
FOR CONTINUANCE OF HEARING ON APPROVAL OF DISCLOSURE
STATEMENT**

Debtor Vanity Shop of Grand Forks, Inc. (“Debtor”) filed its Disclosure Statement [Doc. 510] and Plan of Reorganization [Doc. 511] on November 22, 2017. The Court set the hearing on approval of Debtor’s Disclosure Statement for January 10, 2018 at 10:00 a.m. [Doc. 512] Objections to the Disclosure Statement are to be filed by January 3, 2018. On December 18, 2017, the Unsecured Creditors’ Committee (the “Committee”) filed a Motion for Derivative Standing to Pursue Claims on Behalf of the Estate (the “Standing Motion”). [Doc. 543] Objections to the Standing Motion are to be filed by January 2, 2018.

Debtor and the Committee jointly stipulate and request the Court continue the hearing on the Disclosure Statement and extend deadlines for objecting to the Disclosure Statement and the Standing Motion for a period of forty-five (45) days. The purpose for the continuance is to allow the parties to conduct discovery and attempt to resolve any disputes concerning certain language in the Disclosure Statement and Plan of Reorganization and possible claims against statutory insiders. The Committee has agreed it will not object to further extension of the Debtor’s exclusive periods to file a plan through February 9, 2018 and solicit votes through April 10, 2018.



The Debtor's counsel has contacted Attorney Brad Sinclair (counsel to TGC, LP and certain other statutory insider entities) and the United States Trustee Sarah Wencil concerning the continuance and was advised there is no objection to the continuance.

WHEREFORE, Debtor and the Committee jointly request the Court enter an order continuing the hearing on the Disclosure Statement for a minimum period of forty-five (45) days and set corresponding deadlines for the filing of objections to the Disclosure Statement and the Standing Motion.
