**DECLARATION OF ANGELA NGUYEN ON BEHALF OF KURTZMAN CARSON CONSULTANTS LLC REGARDING VOTING AND TABULATION OF BALLOTS CAST ON THE DEBTOR’S SECOND PLAN OF LIQUIDATION DATED APRIL 9, 2018**

I, Angela Nguyen, hereby declare that the following is true to the best of my knowledge, information, and belief:

1. I am over the age of 18 and competent to testify and make this declaration (this “Declaration”). I am an employee of Kurtzman Carson Consultants LLC (“KCC”), the court-approved claims, noticing, and balloting agent in the above-captioned chapter 11 cases.

2. KCC has considerable experience in soliciting and tabulating votes to accept or reject proposed chapter 11 plans and elections thereunder, and I am duly authorized to make and submit this Declaration on behalf of KCC regarding the solicitation process and the tabulation of votes on and elections under the Debtor’s Second Plan of Liquidation Dated April 9, 2018 [Docket No. 646] (the “Plan”).

3. Pursuant to the Order Approving Disclosure Statement and Setting Deadline for Return of Ballots and Objections to Confirmation and Scheduling Confirmation Hearing [Docket No. 655] (the “Disclosure Statement Order”), KCC did solicit and tabulate votes from Holders of Class 2, Class 3 and Class 4 Claims (collectively, the “Voting Classes”) entitled to vote on the Plan in accordance with specified voting procedures.



4. Except as otherwise indicated, all facts set forth in this Declaration are based upon my knowledge, my review of relevant documents, or my opinion based upon experience, knowledge, and information concerning the Debtor's chapter 11 case. If called upon to testify, I can and will testify competently to the facts and opinions set forth herein.

5. The Debtor established April 13, 2018 as the Record Date for determining which Creditors were entitled to vote on the Plan. Holders of Claims in the Voting Classes as of the Record Date were entitled to vote to accept or reject the Plan in accordance with the Disclosure Statement Order. KCC consulted with counsel to the Debtor, to identify which Holders of such Claims were entitled to vote to accept or reject the Plan. Using its CaseView voting database, KCC generated ballots (the "Ballots") for the Holders of Claims in the Voting Classes.

6. On April 16, 2018, in accordance with the solicitation procedures as set forth in the Disclosure Statement Order, KCC served Solicitation Packages on Holders of Claims in the Voting Classes entitled to accept or reject the Plan via First Class mail. See Certificate of Service re: Solicitation [Docket No. 659].

7. Pursuant to the Disclosure Statement Order, KCC received and tabulated Ballots as follows: (a) each returned Ballot was opened and inspected at KCC's office; (b) Ballots were date and time stamped upon receipt and scanned into KCC CaseView; and (c) all Ballots received were then entered into KCC CaseView and tabulated in accordance with the tabulation procedures outlined in the Disclosure Statement With Respect to Chapter 11 Plan of Liquidation of Vanity Shop of Grand Forks, Inc. Dated April 9, 2018 [Docket No. 645] (the "Disclosure Statement").

8. In order for a Ballot to be counted as valid, the Ballot must have been properly completed in accordance with the Disclosure Statement and executed by the relevant Holder or such Holder's authorized representative and must not have been subject to a pending

objection. All completed Ballots were required to be mailed to the Vanity Shop Ballot Processing Center, c/o Kurtzman Carson Consultants LLC, 2335 Alaska Avenue, El Segundo, California 90245, which address was listed on the Ballots, so as to be received by KCC before the deadline of May 15, 2018, at 4:00 p.m. (Central Time) (the “Voting Deadline”), unless otherwise extended in writing by the Debtor. The following Chart summarizes the tabulation results for the voting classes:

10. Attached as Exhibit B to this Declaration is a detailed listing of any Ballots not included in the Tabulation Report because they did not satisfy the requirements for a valid Ballot set forth in the Disclosure Statement for the reasons described below:

- (a) Abstained: Any Ballot that failed to indicate any acceptance or rejection of the Plan, or that indicated both acceptance and rejection of the Plan;
- (b) Late-Filed: Pursuant to the Disclosure Statement, Ballots that were received after the Voting Deadline were not tabulated, unless otherwise indicated by the Debtor;
- (c) Not Signed: Any Ballot that is not executed;

**CONCLUSION**

11. I declare under penalty of perjury that the foregoing information concerning the distribution, submission, and tabulation of Ballots in connection with the Plan is true and correct. The Ballots received by KCC are stored at KCC's offices and are available for inspection by or submission to this Court.
