**MOTION TO APPEAR AND PARTICIPATE BY VIDEO  
CONFERENCE IN HEARINGS SCHEDULED FOR AUGUST 29, 2018**

The Official Committee of Unsecured Creditors (the “Committee”) of Vanity Shop of Grand Forks, Inc., the debtor and debtor-in-possession in this case (“Vanity” or the “Debtor”), by and through its undersigned counsel Fox Rothschild LLP (“Fox”), respectfully moves this Court (the “Motion”) for authority to attend and participate by **video conference** in the hearings scheduled for August 29, 2018 in this case to consider: (i) Confirmation Hearing of Debtor’s Third Chapter 11 Plan of Liquidation [Doc. 799]; and (ii) Motion to Approve Settlement With Statutory Insiders and Related Parties [Doc.
