**MOTION TO APPEAR AND PARTICIPATE BY TELEPHONE
IN HEARINGS SCHEDULED FOR AUGUST 29, 2018**

Landlords affiliated with GGP Limited Partnership, representing former lessors of multiple shopping center locations of Debtor and general unsecured creditors herein ("GGP Landlords"), by their undersigned counsel, Allen Matkins Leck Gamble Mallory & Natsis LLP, respectfully move this Court (this "Motion") to attend and participate by telephone in the hearing on confirmation of Debtor's Third Chapter 11 Plan of Liquidation, dated July 18, 2018 [Docket No. 799], now set for August 29, 2018 in this case (the "Confirmation Hearing"). In support of this Motion, the GGP Landlords respectfully state:

1. Ivan M. Gold is of counsel to the law firm of Allen Matkins Leck Gamble Mallory & Natsis LLP, and is resident in its San Francisco, California office. Mr. Gold has been granted permission to appear *pro hac vice* in the above-captioned case by this Court's order entered March 3, 2017 (Docket No. 64).



2. While the GGP Landlords do not have a pending objection to Debtor's Third Chapter 11 Plan of Liquidation, in his representation as counsel for GGP Landlords (in the aggregate one of the largest unsecured creditor groups in this case), Mr. Gold requests authorization from this Court to listen to and monitor the Confirmation Hearing and the Court's ruling by telephone in order to minimize the cost associated with appearing in person for this limited scope of appearance.

3. Mr. Gold's request to appear at the Confirmation Hearing telephonically will not cause any undue hardship to the parties herein.

WHEREFORE, GGP Landlords respectfully request that this Court enter an order under Local Rule 5001-1 granting Mr. Gold permission to appear telephonically at the Confirmation Hearing and granting GGP Landlords such and further relief as the Court may deem just and proper.
