This Stipulation is entered between Verity Health System Of California, Inc. ("VHS") and the above-referenced affiliated debtors, the debtors and debtors in possession in the above-captioned chapter 11 bankruptcy cases (collectively, the "Debtors"), in the above-referenced jointly administered Chapter 11 bankruptcy cases, on the one hand, and Swinerton Builders ("Swinerton"), on the other, with respect to the following:

Desc

- 1. On August 31, 2018, the Debtors each filed a voluntary petition for relief under chapter 11 of title 11 of the United States Code.
- 2. Among other "First-Day Motions," the Debtors filed their Emergency Motion of Debtors for Interim and Final Orders (A) Authorizing the Debtors to Obtain Post Petition Financing (B) Authorizing the Debtors to Use Cash Collateral and (C) Granting Adequate Protection to Prepetition Secured Creditors Pursuant to 11 U.S.C. §§ 105, 363, 364, 1107 and 1108; Memorandum of Points and Authorities in Support Thereof [Docket No. 31] (the "Motion Authorizing Debtors to Obtain Post Petition Financing and Use Cash Collateral").
- 3. On September 6, 2018, the Court entered an interim order (the "Order") [Docket No. 86] granting the foregoing Motion Authorizing Debtors to Obtain Post Petition Financing and Use Cash Collateral.
- 4. Pursuant to the Order, the Court set the following deadlines: (i) any party in interest is required to file oppositions by no later than September 19, 2018, at 4:00 p.m. (Pacific Daylight Time) (the "Opposition Deadline"); and (ii) any reply by the Debtors is due by September 26, 2018 (the "Reply Deadline").
- 5. Swinerton has requested an extension of the Opposition Deadline and the Debtors have agreed.
- **NOW, THEREFORE**, all of the parties to this Stipulation hereby stipulate and agree as follows:
- A. The Opposition Deadline shall be extended from September 19, 2018, at 4:00 p.m. (Pacific Daylight Time), to September 24, 2018, at 2:00 p.m. (Pacific Daylight Time).
