1 The Court, having reviewed the Stipulation filed as Adv. Proc. Docket No. 20 (the
2 “Stipulation”) entered into between Verity Health System of California (“VHS”) and the above-
3 referenced affiliated debtors, the debtors and debtors-in-possession (collectively, the “Debtors”) in
4 the above captioned Chapter 11 bankruptcy cases (the “Chapter 11 Cases”) and Old Republic
5 Insurance Company (“Old Republic” and collectively with the Debtors, the “Parties” and each a
6 “Party”), by and through their respective attorneys, and good cause appearing,

7 IT IS HEREBY ORDERED AS FOLLOWS:

8 1. The Stipulation is approved.

9 2. Pursuant to the Stipulation, the restrictions contained in this Order and the
10 restrictions contained in the related *Order Approving Stipulation Between the Debtors and Old*
11 *Republic Insurance Company Regarding Injunction Related to Letter of Credit* [Doc. No. 17] shall
12 be effective through **October 12, 2018**, unless before October 12, 2018, ~~The restrictions contained~~
13 ~~in this Order shall be effective through September 30, 2018, unless before September 30, 2018,~~ the
14 Court extends this deadline for good cause or the Parties agree to an extension in writing. The
15 Parties may extend the **October 12, 2018** ~~September 30, 2018~~ deadline by written agreement and
16 without further Order of this Court.

17 3. The deadline for the Defendants in the instant adversary proceeding to answer or
18 otherwise plead shall be on or before October 21, 2018.

19 4. The Parties’ rights with respect to any factual or legal issue raised in the Adversary
20 Complaint or Motion for TRO are unaffected by this Order.

21 5. Notwithstanding Rule 6004(h) of the Federal Rules of Bankruptcy Procedure, the
22 terms and conditions of this Order are immediately effective and enforceable upon its entry.


