8 Seton Medical Center, St. Vincent Dialysis Center, Inc., Verity Medical Foundation, De Paul
9 Ventures—San Jose Dialysis LLC (collectively, the “Debtors”) are health care businesses as
10 defined under § 101(27)(A).


