1 **PLEASE TAKE NOTICE** that a hearing will be held on November 7, 2018 at 11:00 a.m.,
2 before the Honorable Ernest M. Robles, United States Bankruptcy Judge, in his Courtroom 1568 located
3 at 255 E. Temple St., Los Angeles, CA, to consider the applications (“Applications”) filed by Jacob
4 Nathan Rubin, MD, FAAC, the Patient Care Ombudsman (“PCO”) appointed under Section 333 of the
5 Bankruptcy Code in the above-referenced bankruptcy cases of the affected debtors and debtors in
6 possession (collectively, “Debtors”), for Court approval of his employment of (A) Levene, Neale,
7 Bender, Yoo & Brill L.L.P. (“LNBYB”) as bankruptcy counsel effective as of October 1, 2018, and (B)
8 Dr. Tim Stacy DNP, ACNP-BC (“Dr. Stacy”) as consultant effective as of October 3, 2018, at the
9 expense of the Debtors’ estates, with compensation determined and paid pursuant to 11 U.S.C. § 330
10 and orders of this Court. The Applications are based on this Notice, the Applications and all pleadings
11 filed in support of the Applications, the entire records of the Debtors’ cases, the statements, arguments
12 and representations of counsel to be made at the hearing on the Applications, and any other evidence
13 properly presented to the Court.

14 Briefly, the PCO requires the assistance of LNBYB as bankruptcy counsel to adequately and
15 efficiently discharge his duties, understanding the scope of his duties as well as the activities and events
16 of the cases which are relevant to performing such duties, analyzing, drafting and filing his reports and
17 other documents in the Debtors’ cases, and with regard to discussions, negotiations, meetings or Court
18 hearings that relate to his duties as the PCO. The PCO is a licensed medical professional. In order for
19 the PCO to timely and competently comply with his duties within the relatively small amount of time
20 allotted for him to do so under the applicable Bankruptcy Code and Bankruptcy Rule provisions, he
21 must be given an opportunity to focus primarily on patient care issues without having to spend any
22 significant time on the legal and procedural aspects of these cases. Having bankruptcy counsel will
23 streamline the PCO’s ability to focus primarily on patient care issues, while facilitating his need to
24 understand the relevant facts and circumstances of these cases and timely reporting to the Court as to
25 patient care matters.

26 With less than sixty (60) days to submit his initial report to the Court as to the quality of patient
27 care provided to the thousands of patients at the Debtors’ six (6) active acute care hospitals with
28 emergency rooms, a trauma center, and a host of medical specialty clinics, centers and facilities, the

1 PCO also immediately requires the assistance of Dr. Stacy to adequately, efficiently and timely
2 discharge his duties and submit his reports to the Court. The PCO is an individual, and not a business
3 with employees; thus, the PCO needs assistance in carrying out his planned tasks which, in addition to
4 reviewing a variety of hospital and patient records, reports and related information, includes, among
5 other things, touring all of the facilities and review the ER, OR, ICU, medical and surgical floors, lab,
6 pharmacy, radiology, and dietary services, and speaking to Chief of Staff, key members of senior
7 management, Board of Directors and/or executive committees and certain patients and employees. In
8 short, there is a lot of tasks for the PCO to perform in a short span of time and immediate assistance is
9 needed from Dr. Stacy to fulfill such tasks.

10 LNBYB and Dr. Stacy will bill their time on an hourly billing basis as specified in the
11 Applications and will seek Court authority to be paid from the Debtors' estates, including, without
12 limitation, interim payments under any monthly fee payment procedures approved by the Court (*i.e.*,
13 "Knudsen Order") for any and all fees incurred and expenses advanced by LNBYB from and after
14 October 1, 2018 and by Dr. Stacy from and after October 3, 2018. LNBYB and Dr. Stacy will also seek
15 reimbursement of expenses in accordance with the rates set forth in the guidelines previously
16 promulgated by the UST.

17 **PLEASE TAKE FURTHER NOTICE** that any request for a copy of the Applications must be
