This stipulation is entered as of January 11, 2019, between U.S. Bank National Association, as note trustee and collateral agent under each of the 2015/2017 Indentures and related collateral documents hereinafter defined (collectively, the "<u>Trustee</u>"), on the one hand, and the Official Committee of Unsecured Creditors in the above-captioned jointly administered cases (the "Committee"), on the other, with respect to the following:

- 1. On September 14, 2018, the Committee was formed.
- 2. On October 4, 2018, the Court entered its Final Order (I) Authorizing Postpetition Financing, (II) Authorizing Use of Cash Collateral, (III) Granting Liens and Providing Superpriority Administrative Expense Status, (IV) Granting Adequate Protection, (V) Modifying Automatic Stay, and (VI) Granting Related Relief (the "Final DIP Order") [Docket No. 409].
- 3. Pursuant to paragraph 5(e) of the Final DIP Order, the Committee has 90 days from the date of its formation to challenge Prepetition Liens (as defined in the Final DIP Order) asserted by the Trustee (the "Original Challenge Deadline").
- 4. By mutual agreement of the Trustee and Committee pursuant to that certain Stipulation between U.S. Bank National Association and the Official Committee of Unsecured Creditors Extending Challenge Deadline executed on or about December 13, 2018 (the "Stipulation") the Original Challenge Deadline for certain limited purposes was extended 30 days (the "Challenge Deadline") all pursuant to the terms set forth therein.
- 5. The Challenge Deadline is currently January 14, 2019 and the parties desire to extend such date to February 13, 2019.

NOW, THEREFORE, all of the parties to this stipulation hereby stipulate as follows:

A. Section B of the Stipulation is hereby amended to delete the date "January 14, 2019" and replace the same with the date "February 13, 2019." Except for the foregoing, the Stipulation continues in full force and effect in accordance with its original terms.
