MEMORANDUM OF POINTS AND AUTHORITIES

A. **Background Facts**

On or about December 23, 2016, Aetna Life Insurance Company ("Aetna") entered into the Conditional Settlement Agreement, Including Defendants' Agreement To Pay Settlement Amount Or Have Judgment Entered Against Them, a true and correct copy which is attached to the Stipulation as Exhibit "A" and incorporated herein by this reference (the "Conditional Settlement"), with the parties identified as the "Defendants" in the Conditional Settlement (the "Defendants").

Effective on January 17, 2017, Verity Holdings and Aetna entered into the Guarantee Agreement (the "Guarantee"), a true and correct copy of which is attached to the Stipulation as **Exhibit "B"** and incorporated herein by this reference. Pursuant to the Guarantee, Verity Holdings guaranteed the "Obligations" of the Defendants under the Conditional Settlement, as that term is defined in the Guarantee.

Pursuant to the Conditional Settlement, the Defendants were obligated to pay to Aetna \$6,666,667 no later than December 31, 2018. The Defendants did not make the foregoing payment. On January 2, 2019, Aetna sent to the Defendants the demand letter, a true and correct copy of which is attached to the Stipulation as **Exhibit "C"** and incorporated herein by this reference.

The Defendants have informed Aetna that they contend that Aetna is required to also deliver a written notice of the default or nonpayment by Defendants to Verity Holdings in order to trigger an "Event of Default" by Defendants under the Conditional Settlement, as that term is defined in Paragraph 6 of the Conditional Settlement. Aetna contends that the Defendants' arguments regarding the appropriate construction of Paragraph 6 of the Conditional Settlement are unfounded and that Aetna is not required to also deliver a notice to Verity Holdings to trigger an "Event of Default" by Defendants under the Conditional Settlement. The Defendants are the primary obligors and Verity Holdings is a guarantor. Aetna is seeking to collect the balance owed from the primary obligors who are insisting that Aetna also send a notice to Verity Holdings, in its capacity as guarantor.

Aetna seeks to avoid the unnecessary delay and expense of litigation regarding the appropriate construction of paragraph 6 of the Conditional Settlement by sending a written notice of the Defendants' default or nonpayment to Verity Holdings.

Verity Holdings is willing to accommodate Aetna's request to modify the automatic stay strictly for the purpose of enabling Aetna to pursue the Defendants as the primary obligors and thereby reduce the secondary liability of Verity Holdings under the Guarantee. Aetna and Verity Holdings have therefore entered into the Stipulation, subject to approval of this Court.

В. The Stipulation Should be Approved

Section 362(d)(1) of the Bankruptcy Code provides that "[o]n request of a party in interest and after notice and a hearing, the court shall grant relief from the stay provided under subsection (a) of this section, such as by terminating, annulling, modifying, or conditioning such stay (1) for cause, including the lack of adequate protection of an interest in property of such party in interest." 11 U.S.C. § 362(d)(1). Congress enumerated that under Section 362 of the Bankruptcy Code, relief from the automatic stay may be granted "for cause." 11 U.S.C. § 362(d)(1). Cause is not defined in the Bankruptcy Code, but rather must be determined on a case-by-case basis.

Here, there is no prejudice to the Debtor or its estate that will result from approval of the Stipulation and allowing Aetna to send a notice of default to Verity Holdings, which the Defendants contend is a condition to Aetna enforcing its rights against the non-debtor Defendants. If the Defendants pay the amount they owe under the Conditional Settlement, Verity Holdings will be relieved of any liability it may have under the Guarantee. Even if the Defendants do not pay, the automatic stay is not being modified to allow Aetna to enforce its rights directly against Verity Holdings outside of the bankruptcy claim process. The Stipulation will minimize the litigation expenses of Verity Holdings and Aetna and eliminate the need for litigation over Defendants' contention that Aetna must make a demand under the Guarantee before it can enforce remedies against the primary obligors.

For all of the above reasons, the Debtor submits that approval of the Stipulation and modification of the automatic stay is appropriate under the circumstances.
