PLEASE TAKE NOTICE that Verity Health System of California, Inc. and the abovereferenced affiliated debtors, the debtors and debtors in possession in the above-captioned chapter 11 bankruptcy cases (collectively, the "Debtors"), hereby supplement their Notice to Counterparties to Executory Contracts and Unexpired Leases of the Debtors That May Be Assigned [Dkt. No. 1704] (the "Initial Cure Notice") filed in accordance with their (i) Motion For The Entry Of (I) An Order (1) Approving Form Of Asset Purchase Agreement For Stalking Horse Bidder And For Prospective Overbidders, (2) Approving Auction Sale Format, Bidding Procedures And Stalking Horse Bid Protections, (3) Approving Form Of Notice To Be Provided To Interested Parties, (4) Scheduling A Court Hearing To Consider Approval Of The Sale To The Highest Bidder, And (5) Approving Procedures Related To The Assumption Of Certain Executory Contracts And Unexpired Leases; And (II) An Order (A) Authorizing The Sale Of Property Free And Clear Of All Claims, Liens And Encumbrances [Docket No. 1279] (the "Motion"), and (ii) the order granting the Motion (the "Bidding Procedures Order") approving, among other things, the Bidding Procedures requested in the Motion, which Bidding Procedures Order governs (a) the bidding process for the sale of certain assets (the "Assets") of the Debtors, and (b) procedures for the assumption and assignment of certain of the Debtors' executory contracts and unexpired leases. See Docket No. 1572.

PLEASE TAKE FURTHER NOTICE that the Initial Cure Notice attached a list of executory contracts and unexpired leases subject to assumption (the "Executory Contracts Subject to Assumption") and set forth the amount, if any, which the Debtors asserted is owed to cure any defaults existing under the Executory Contract Subject to Assumption (the "Cure Amount"). Thereafter, the Debtors filed a supplemental notice that provided that the cure amount related to "Saint Vincent IPA/Data Trust" ("SVIPA") in the Initial Cure Notice related to an ancillary services agreement and a risk sharing agreement was inadvertently listed as "\$0.00" instead of "TBD." Docket No. 1793. For the avoidance of doubt and at the request of SVIPA, "TBD" was used as an acronym for "To Be Determined."

PLEASE TAKE FURTHER NOTICE that the Debtors hereby file this Notice to supplement the Initial Cure Notice by identifying additional executory contracts that were not originally included in the Initial Cure Notice, as set forth in the attached Exhibit "A" (the "Additional Executory Contracts Subject to Assumption"). The Additional Executory Contracts Subject to Assumption listed on Exhibit "A" are principally (i) downstream capitation vendor contracts managed by a third party administrator (a management services organization) (the "MSO Contracts"), and (ii) supply chain contracts (the "Supply Chain Contracts"). The foregoing Additional Executory Contracts Subject to Assumption should have been listed on the Initial Cure Notice, but were inadvertently excluded because (i) the MSO Contracts are not maintained in the Debtors' internal contract system, (ii) the Supply Chain Contracts were loaded into the contract system of the Debtors' GPO partner instead of the Debtors' internal contract system named "Meditract."

PLEASE TAKE FURTHER NOTICE that the Debtors also hereby file this Notice (i) to remove certain contracts from the Initial Cure Notice that were incorrectly included therein, as set forth in the attached **Exhibit "B**," and (ii) to revise certain information related to Executory

Contracts Subject to Assumption listed on the Initial Cure Notice, including Cure Amounts as set forth in attached Exhibit "C."

PLEASE TAKE FURTHER NOTICE that, if you disagree with the Cure Amount(s) shown on the attached **Exhibit "A,"** you must file in writing your objection with the United States Bankruptcy Court for the Central District of California, 255 E. Temple St., Los Angeles, California 90012. The Court previously set March 22, 2019, at 4:00 p.m. (prevailing Pacific Time), as the deadline to object to Cure Amounts, but the Debtors will enter into stipulations with counterparties to executory contracts or unexpired leases to extend the aforementioned deadline, if needed, and to resolve any issues given that this Notice is being served and filed after the Initial Cure Notice, as it relates to the Additional Executory Contracts Subject to Assumption. Any counterparty to a executory contract or unexpired lease that fails to timely file and serve an objection shall be forever barred from asserting that a Cure Amount is owed in an amount in excess of the amount, if any, set forth in the attached Exhibit "A" or Exhibit "C."

PLEASE TAKE FURTHER NOTICE that, as previously noticed, within forty eight (48) hours following the conclusion of the auction as set forth in the Bidding Procedures Order, the Debtors shall file a notice identifying the Successful Bidder(s) with the Bankruptcy Court and serve such notice by fax, email or overnight mail to all counterparties whose contracts are to be assumed and assigned. An evidentiary hearing (the "Sale Hearing") to approve the Sale and authorize the assumption and assignment of the Executory Contracts Subject to Assumption will be held on April 17, 2019, at 10:00 a.m. (prevailing Pacific Time), before the United States Bankruptcy Court for the Central District of California, 255 E. Temple St., Los Angeles, California 90012, Courtroom 1568. The Sale Hearing may be adjourned from time to time without further notice to creditors or parties in interest other than by announcement of the adjournment in open court on the date scheduled for the Sale Hearing.
