**DECLARATION OF ADAM THOMAS**

I, Adam Thomas, declare as follows:

1. I am not a party to this action. I make this declaration based upon my personal  
knowledge, and, if called as a witness, I could competently testify as to the facts stated herein.

2. I have assisted my clients, in preparation for and filing of a motion with the United  
States Bankruptcy Court, Central District of California, for authorization to file class proof of  
claim.

3. My preparations included reaching out to the attorneys for Verity Health System  
("Debtor"), who are Samuel R. Maizel and Tonya Moyron from the offices of Dentons U.S. LLP.

4. I sent an email to the attorneys Debtor's attorneys on March 28, 2019 asking them  
if their client would stipulate to our client's motion to approve class claim.

5. On March 28, 2019, I received an email from Debtor's counsel, Tania Moyron,  
which informed me that the Debtors do not consent to a class proof of claim.

6. The law offices of Weinberg, Roger & Rosenfeld have been representing multi-  
employer benefit funds since approximately 1968, and have continuously represented these funds  
after they became subject to the Employee Retirement Income Security Act ("ERISA") in 1974.

7. William A. Sokol is a shareholder with the firm. For over 44 years, his practice has  
included legal representation of pension, health and welfare, apprenticeship and training funds  
both before, and after the enactment of ERISA. Mr. Sokol serves as both sole counsel and as

21                  December 21, 2017.


23                  10. I, Adam Thomas, am an associate at Weinberg, Roger & Rosenfeld since April
